Burglaries are down this week, fortunately 7<sup>th</sup> Division detectives have a couple suspects named in almost half of them. As with most burglaries, either the side or rear door or a garage door is the primary point of forced entry. Re-enforcing these doors can go a long way. Please contact me if you have any questions.

We are at 100% on all thefts from automobiles. The "unknown method of entry" is almost always "unlocked". Thieves do not typically use "slim-jims" or other devices to gain entry when they see a high-valued target in a locked vehicle, the simply smash and grab. Whereas most of the burglaries occurred on beat 3, most of the thefts from UNLOCKED automobiles occurred on Beat 4.

If you are unsure which beat you are on, we are going to clarify that very soon and you are going to get more one-on-one communications with our office! We are in the process of mapping your specific area; this is part of our new initiative which we will cover at the annual meeting next month.
