# Learn More About Nature's Methane and the planned Anaerobic Digester in West Louisville at the Food Port!

#### Fact VS. Myth

Myth: There was a long-range plan by the mayor and others to use West Louisville for dumping.

Nature's Methane was originally invited to Louisville by the Food Port team as a solution to what to do with their organic materials. After meeting with community members, a second facility was independently negotiated in associated with the organic stillage of Heaven Hill. Long-term Nature's Methane hopes to build several similar facilities in both rural and urban communities

throughout the region.

**FACT:** 

Myth: They're building a landfill or waste treatment plant in our community?

FACT: Nature's Methane is building an anaerobic digester. There is a huge difference between the old school wastewater treatment plants and landfills, and an anaerobic digester. First, anaerobic digester processes are all completed in enclosed tanks that eliminate most odors. Also, because the materials are not stockpiled for long periods there are no residues to smell or cause rodent

infestation like landfills and treatment plants.

Myth: These facilities are unsafe and they are prone to explosions.

**FACT:** Anaerobic digesters are extremely safe. There are over 1,500 digesters currently in use in the US and over 11,000 in Europe. Nature's Methane is using a system from GE Power and Water, used

in over 250 locations, none of which have had a major safety issue.

Myth: The plants will cause a lot of traffic, stink up the city and attract rats.

FACT: Anaerobic digesters are relatively quiet and kept clean. They are a great source of energy, and they enhance the environment because they utilize materials that otherwise may find itself in the sewer system. Also, because some of the materials are piped in, and other material is already being

trucked through the neighborhood, the net affect of trucks to the facility should be minimal. Also,

each truck that comes in is cleaned before they go back out into the community.

Myth: There is no benefit to West Louisville to have these facilities

FACT: There are many benefits that will be realized by the neighborhoods and West Louisville due to the new facilities being developed by Nature's Methane. Some of the benefits are construction opportunities in the build out, opportunities for professional services long-term, there will be 10 employees hired per site (a total of 20) of which a minimum of half are expected to be from the local community. Nature's Methane has already reached out several local non-profit entities about its potential involvement and investment in the mission of those organizations. The development of those properties will provide tax revenue that can go back in to the neighborhoods. There are

also multiple environmental benefits.

### Nature's Methane Holdings Frequently Asked Questions

#### 1. Who is Nature's Methane?

Nature's Methane or NM is the renewable natural gas division of Star Energy Holdings, a Fort Wayne, Indiana-based renewable energy company.

#### 2. What are Nature's Methane's plans for Louisville, KY?

NM is currently developing two anaerobic digester facilities in Jefferson County – one in affiliation with Seed Capital Kentucky at the West Louisville Food Port at 30th and Muhammad Ali Blvd and a second one on 17th and Maple Street.

#### 3. How many digester facilities has Nature's Methane developed?

None. However, executives and owners of the company have developed digesters such as the Fair Oaks Dairy digester in Northwest Indiana that curious callers come to every day to visit. Additionally, NM is partnering with GE Power and Water to provide its Monsal AD technology that is operational in over 250 sites in the United Kingdom. GE Power and Water intends to operate the facilities in Louisville.

#### 4. What is an anaerobic digester?

The anaerobic digester itself is a large, <u>airtight</u> container or tank that contains no oxygen. The tank is filled with organic material and maintained at an optimum temperature for anaerobic bacteria to naturally break down the material. The entire system that prepares the material going into the digester, and processes the material after digestion is often referred to as an anaerobic digester process. The American Biogas Council has additional resources about digesters and the anaerobic digestion process at https://www.americanbiogascouncil.org/biogas\_what.asp.

#### 5. How big are the digester tanks and what materials will be processed in them?

The insulated, specially lined stainless steel tanks are approximately 42 feet tall and 70 feet in diameter and have a storage capacity of approximately 1.5 million gallons. The facilities will process multiple types of organic materials (food waste from restaurants, damaged produce from wholesalers and food port operations, grocery stores, bakeries, and other commercial activities; tillage from distillery operations; and fats, oils and grease generated in the community).

#### 6. Where will the materials come from?

NM expects the materials will be generated in the Louisville area and will reduce materials being sent to the local landfill. It is cost prohibitive to transport organic materials from longer distances. Also, NM will accept all organic materials generated at the Food Port not otherwise used there. With respect to the 17th Street facility, NM expects that approximately 60-70% of the material processed there will be stillage from the Heaven Hill Distillery. That stillage will be delivered to the NM facility via a newly constructed pipeline, eliminating about 30 trucks/day that currently haul the stillage away from the distillery.

#### 7. What are the emissions of the facility?

The biogas generated and contained in the digesters is generally 60% methane and 40% carbon dioxide, and the biogas will contain small amounts of nitrogen and hydrogen sulfide. The biogas is removed from the digester tanks and the process first separates the carbon dioxide and returns it into the atmosphere. This is the same carbon dioxide that the organic material captured to grow so there is not a net addition of the carbon dioxide to the atmosphere. The hydrogen sulfide is removed in a liquid scrubbing process and sent to the sewer system. The nitrogen is also released into the atmosphere. This is not the same nitrogen compound that can create particle pollution. This nitrogen is also released into the atmosphere but the amounts are extremely small and the gas is inert when released. **More Questions Will Be Announced Next Week.**
