Jefferson County Soil and Water Conservation District offering FREE soil testing for Louisville Metro homeowners *limit 2 tests per household!*

Although fertilizer, lime, and other amendments can be very helpful in establishing happy, healthy plants and lawns, they pose a risk if not used properly. Excess fertilizer and chemicals wash away with rainwater and pollute our local streams and waterways. The first guideline of responsible fertilizer application is to take a soil sample and have it analyzed to determine fertilizer needs. The Jefferson County Soil and Water Conservation District (SWCD) is offering a soils test incentive program to offset the cost for Louisville Metro residents.

The SWCD will provide up to 2 vouchers per household to cover the processing fee for a standard soils test. People wishing to participate in this incentive program must request the soils test voucher(s) from the Conservation District office. Email your voucher request to: joy.edwards@ky.nacdnet.net. The email should include your name, physical address, phone number and if you want one or two vouchers.
