# **Forensic Mapping**



In 1999, she was assigned as a detective in the Crime Scene Search Unit before joining the Homicide Unit in 2001. Cheryl promoted to Sergeant in 2006 and returned to supervise the Sexual Assault Unit in 2007. In 2011, Cheryl was selected to supervise the Homicide and Cold Case Units.

Cheryl has worked on numerous violent crime investigations over the past 16 years to include several high profile murder cases, death penalty cases and serial cases, both in Homicide and Sexual Assault. She retired from FWPD in March, 2014.
