Things that can be done to combat auto theft and larcenies from autos include:

- Installing a car alarm.
- Using steering-wheel locking applications like the club etc.
- Applications of a hidden kill switch to the ignition system.
- > Park in a well lit well traveled area if possible.
- Always maintain security of vehicle keys.
- Do not leave anything of value in your vehicle in plain view.
- > Always lock your vehicle doors.
- Never leave a vehicle unattended while running.
- There is a trend of things being stolen from vehicles in the parking lots of fitness centers and fun centers. While going to these places, be extra careful to remove all items of value and secure your vehicle.

- If you receive a phone call or email telling you that you have won something that you did not apply for, it is more than likely a fraud.
- No legitimate organization will ask for any money or a Credit Card number in order to claim a prize

If your wallet/purse etc. gets stolen, cancel all stolen credit and ATM cards immediately.

Checking your credit history regularly is a great way to keep appraised on the status of your credit.

The Troy City Council Approved the transfer of the Troy Police Department "Animal Control Service" to the Oakland County Animal Control Services at the City Council meeting on Monday March 28, 2011.

City of Troy Residents will need to call Oakland County Animal Control for all of their animal control needs @ 248.391.4102.

Oakland County Animal Control Services will responsible for the following:

- Respond to and investigate animal bites on any animal that may carry rabies.
- Respond 24/7 to calls involving animals that put the public at risk.
- Sell, process, and record the licensing of dogs.
- Impoundment, care for, and attempt to reunite stray

dogs.

- Annual dog census.
- Investigations of reported animal cruelty.
- Support and administration for shelter operations and enforcement.
- Enforce the Dangerous Dog Act, including any vicious animals.
- Investigate and enforce multiple animal control law violations to include: wolf/dog breeding, ban on large carnivores, dog fighting, and suspected rabies cases.
- Sick and injured animals with the potential of rabies causing hazard to the public.
- Any wild animal in a residence living area, and a public hazard to the community.
- Animals running at large, other than cats.
- Found animals, other than cats which must be dropped off at the county facility.
- Welfare checks on animals left in vehicles. (Cruelty)
- Respond to assist police where animals are involved. (Arrest's, drug raids, etc.)
- Investigate and prosecute Dog Fighting Charges.
- Investigate suspected rabies in domestic and wild animals.
- Inspection and issuance of licenses to Kennels within Oakland County.

Oakland County Animal Control Services will not respond to the following (and neither will the Troy Police Department):

- Pick up stray and or nuisance cats, provide cat impoundment, or return cat's to owners.
- Noise/barking dog complaints.
- Number of dogs allowed in residence.
- Disturbance of birds and bird nest.
- Permits for domestic livestock or dangerous animals.
- Coyote complaints (DNR matter)
- Geese problems (DNR matter)
- Pick up injured wildlife and transport to wildlife or sanctuary.
- Annually inspect kennel facilities, unless claim of cruelty.
- Pet shop inspections, unless cruelty.
- Tethering, unless claim of cruelty.
- Feeding waterfowl.
- Hunting and trapping of animal violations, unless cruelty.
- Delivery of rabies specimens to Lansing for testing.
- Provide shelter quarantine of attack animals.
- Euthanasia of sick or ill-tempered animals for

residents.

- All animal give-ups must be taken to the county facility. (costs incurred by resident)
- Picking up of dead animal carcasses on roadway.

Troy DPW will pick up dead animals on the roadways. Dead animals on Private Property will be the private property owner's responsibility.

The Troy Police Department will respond to emergency calls concerning dangerous animals, such as a dog attacking a person.

City of Troy Ranked as the Safest City in Michigan

On November 22, 2010, CQ Press released City Crime Rankings 2010-2011: Crime in Metropolitan America. CQ Press uses six crime categories to establish crime rate rankings for all cities with a population of at least 75,000 that report crime data to the FBI. The crime categories include: murder, rape, robbery, aggravated

assault, burglary and motor vehicle theft. The rankings in the CQ report are based upon data reported to the FBI for 2009.

According to the CQ report, Troy has the lowest crime rate ranking in Michigan for cities with a population between 75,000 and 99,999. Nationwide, for cities with a population between 75,000 and 99,999, Troy is ranked 10th safest overall. For cities in the United States with a population of 75,000 and above, Troy is ranked 13th. Troy was ranked as the safest city in Michigan for cities with its population in 9 of the last 13 ranking periods, including the current one. Troy achieved "Safest City" rankings as high as 5th and 6th in the United States for cities with populations between 75,000 and 99,999 in 2006 and 2005, respectively. Troy has consistently ranked among the top 25 safest cities in the United States with populations over 75,000 since 1998.

The crime categories used by the CQ Press include all FBI Part 1 crimes, except larceny and arson. The City of Troy has experienced a general downward trend in the incidents of Part 1 crimes over the last 10 years, and crime in all categories for Troy reflects a similar downward trend over the same period. The number of Part 1 crimes reported to the Troy Police Department for 1999 – 2009 are as follows:

1999: 2,411 incidents 2004: 1,979 incidents2000:

2,387 incidents 2005: 2,044 incidents

 2006: 2,090 incidents

2009: 1,957 incidents

In 2009, there were only 74 violent crimes reported to the Troy Police Department, which represents less than 3.8% of the total Part 1 crime in Troy.

Murder: 0
Rapes: 17
Robberies: 14
Aggravated Assault: 43

Incidents of violent crime, which include murder, rape, robbery and aggravated assault, are extremely low. It should be noted that although 17 acts of criminal sexual conduct that occurred in Troy are classified as "rapes" in the FBI statistics, these types of assaults in Troy do not usually involve a victim being attacked by a stranger. They generally relate to incidents of criminal sexual conduct where one of the actors is a minor, complaints where incest or molestation by family members are alleged, or non-consensual acts between

individuals who are acquainted with one another. In 2009, there was only one sexual assault involving a rape where the victim was forcibly assaulted by a suspect that she did not know.

This ranking represents a significant achievement not only for the men and women who work for the Troy Police Department, but for the community in general. It is a tribute to the residents; an excellent school system; strong prevention programs such as provided by the Troy Community Coalition, Boys and Girls Club, Troy Youth Assistance, and many others; an effective District Court; and an active business community. The current ranking for the lowest crime rate in Michigan, as well as the city's long term record in this regard reflects the high priority this community places on public safety. It reinforces the high quality of life that is offered in Troy. The Troy Police Department is dedicated to continuing to work with the community we serve, as well as City Management and City Government to assure this city remains a safe and attractive place to live, raise families, work, and recreate.

The current challenges this community faces in terms of budgets and shrinking resources are significant.

However, results such as those reflected here not only reinforce Troy's strengths, but also place this city in a position to remain attractive to both residents and businesses as we attempt to face these challenges and move ahead into the future.

In commenting on the latest ranking, Troy Police Chief Gary Mayer not only reinforced the overall accomplishment this represents for the community, but the dedication and quality of the employees of the Troy Police Department. The Chief stated, "The Troy Police Department is made up of professional men and women who work hard to solve problems and provide this community with a level of enforcement service that is second to none. value the resources we have been provided to both prevent and solve crime. As we move forward in the face of current challenges, this organization will remain dedicated to utilizing these resources both efficiently and effectively to maintain Troy's exceptional record for public safety."

City Manager John Szerlag also reinforced these latest rankings as a significant accomplishment. Mr. Szerlag stated, "Both City Management and City Government have worked closely with the community

to ensure public safety remains a priority, even in the face of these difficult times. In addition to the excellence of the Police Department that is reflected in these rankings, this achievement also underscores the contributions that the Fire Department and other city departments involved in public safety contribute to the overall quality of life in this community. Troy City Council Approves Distracted Driving Ordinance

On Monday, July 12, the Troy City Council voted to approve a proposed Distracted Driving Ordinance. The Ordinance is scheduled to become effective on Thursday, July 29.

The Ordinance defines and prohibits three distinctive

types of distracted driving behavior.

The first type is similar to the behavior prohibited by the State of Michigan Texting Law that went into effect on July 1. It prohibits, with exceptions, any activity necessary to or associated with the use of a two way wireless electronic communication device for the purpose of sending or receiving text messages while driving a motor vehicle.

The second type prohibits, with exceptions, any activity necessary to or associated with the use of a hand held wireless electronic device for the purpose of sending or receiving voice messages while driving a motor vehicle. The use of a hands free device is allowed.

The third type prohibits any other activity that distracts a driver, such that it results in the failure of the driver to use due care and caution in the safe operation of a motor vehicle. Examples include, but are not limited to, eating, grooming, reading, writing, or other activities that prevent the driver from having control of the motor vehicle, with at least one hand on the steering wheel or other steering mechanism.

The Troy Police Department is in the process of

educating the public about the new ordinance. The Police Department appreciates your assistance with these educational efforts. Police Officers are prepared to enforce the ordinance as soon as it becomes effective.

Sections of Chapter 106, <u>Traffic</u>, of the Troy City Code relating to distracted driving read as follows:

1.20.05 "Distracted Driving" means the following:

- 1. The physical manipulation of any 2-way wireless electronic communication device used for dialing numbers; or scrolling; or typing or entering multiple letters, numbers, symbols, or other text; or the sending, receiving, and reading of any non-voice data in the device while the motor vehicle is in motion on any highway or street or place open to the general public within the City of Troy. As used in this subsection, a wireless 2-way communication device does not include a global positioning or navigation system that is affixed to the motor vehicle.
- 2. The physical manipulation or handling of any wireless entertainment or electronic communication device for the purpose of speaking into, or listening to

voice data, while the motor vehicle is in motion on any highway or street or place open to the general public within the City of Troy; or

3. Any action by the driver of a motor vehicle that diverts his or her attention resulting in the failure to use due care and caution in the safe operation of a motor vehicle while the vehicle is in motion on any highway or street or place open to the general public within the City of Troy. Such action can include but is not limited to: eating, reading, writing, performing personal hygiene/grooming, physical interaction with pets, passengers, or unsecured cargo, any of which is done in a manner that prohibits the driver from maintaining direct physical control of the motor vehicle steering mechanism with at least one hand that is free of all other objects and used entirely to form a controlled grip on the steering mechanism.

14c. Distracted Driving; Violation as Civil Infraction.

- 1. A person shall not engage in distracted driving within the City of Troy.
- 2. A person who violates this section is responsible

for a civil infraction.

- 3. Exceptions. This section does not apply to a person who is using a electronic communication device to do one or more of the following:
 - a) Report a traffic accident, medical emergency or serious road hazard.
 - b) Report a situation in which the person believes his or her personal safety is in jeopardy.
 - c) Report or avert the perpetration or potential perpetration of a criminal act against the individual or another person.
 - d) Carry out official duties as a police officer, law enforcement official, member of a paid or volunteer fire department, or operator of an emergency vehicle.

Distracted Driving Ordinance Fines
At a recent City Council meeting a citizen voiced concerns that a possible reason behind this ordinance

was to generate revenue for the City. A formula was asserted based on a report that the Police Department had issued 100 warnings in a month. The implication was that when officers would begin issuing citations rather than warnings, this translated to 1,200 tickets annually and at a fine of \$200 each represented \$240,000 in revenue for the City.

The above concern suggests some clarification may be indicated as to how traffic fines are dispersed. The fines attached to any traffic citation do not go directly back to the issuing agency. Traffic ticket fines are dispersed according to formulas set by the State of Michigan and the courts. The distribution for distracted driving related citations is as follows:

Texting While Driving and Distracted Driving:

- o Fine: \$200.00
- ■20% or \$40 goes to the State
- ■56% or \$112 goes to the Court
- ■24% or \$48 comes back to the City

Driving While Talking on a Cell Phone:

- o Fine: \$75.00
- ■53% or \$40 goes to the State

- ■33% or \$24.50 goes to the Court
- ■14% or \$10.50 comes back to the City

Another aspect of the comments that were made that deserves clarification is the implication that every stop for a violation of this ordinance will result in a formal citation; that is not accurate, as officers have and use discretion in determining the appropriate enforcement action to pursue in regard to any stop for a traffic offense. A traffic stop does not necessarily translate into a traffic ticket in every event.

An advantage of enforcement under this ordinance is that it contains no points. This is similar to approaches taken when seatbelts were initially made mandatory. A no point violation provides officers with the ability to issue a citation that represents a lesser overall penalty to a violator when circumstances indicate such an approach is reasonable.

The Troy Police Department utilizes problem solving in its approach to traffic safety. Traffic enforcement for the mere sake of issuing tickets for the so-called generation of revenue is not practiced by this department. Our approach combines education, engineering considerations, and enforcement; all aimed at preventing traffic crashes. The overall goal is for the driving public to voluntarily comply with traffic

| regulations. Enforcement is meant to reinforce hazardous driving behavior that causes crashes, and hopefully stop it from being repeated in the future. | |
