Inactive Hazardous Waste Disposal Site Classification Notice

The Inactive Hazardous Waste Disposal Site Program (the State Superfund Program) is the State's program for identifying, investigating, and cleaning up sites where the disposal of hazardous waste may present a threat to public health and/or the environment. The New York State Department of Environmental Conservation (DEC) maintains a list of these sites in the Registry of Inactive Hazardous Waste Disposal Sites (Registry). The boundaries of the site identified above were recently modified and the site was reclassified on the Registry as a Class 4 as it no longer presents a significant threat to public health and/or the environment for the following reason(s):

Environmental investigations have been completed and remedies are in place for groundwater and soil. Restrictions on use of the property have been filed with Monroe County. These restrictions include requirements that must be followed when handling potentially contaminated soil and groundwater during changes in use of the site, such as during redevelopment. Groundwater testing and site inspections continue to be performed and a soil vapor intrusion management plan is in place.

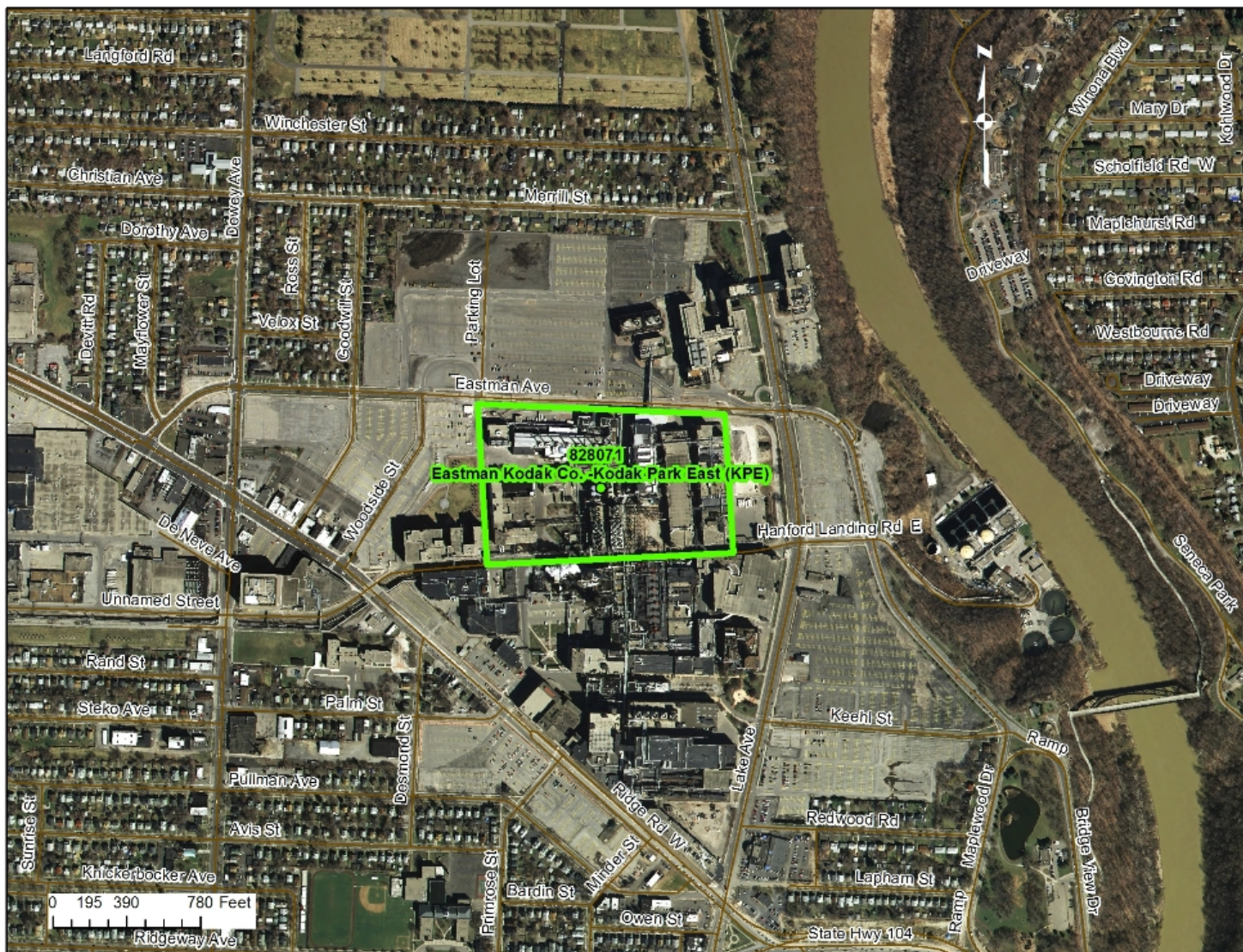
