

Region 1 Area Commission on Transportation (R1ACT) At-Large Active Transportation Membership Application

The Region 1 Area Commission on Transportation is chartered by the Oregon Transportation Commission (OTC)¹. The R1ACT serves as an advisory board to the OTC and provides valuable input and recommendations as the OTC is considering policy and funding decisions.

R1ACT membership consists of 31 voting members. The Active Transportation member is appointed through a recruitment process administered by ODOT and then nominated to the R1ACT. This at-large member will serve a four-year term and is eligible for reappointment. Sixteen of the 31 members are nominated by county commissions and/or county coordinating committees per the R1ACT Formation Proposal and R1ACT bylaws.

At-large members represent specific modes of travel and/or areas of interest. At-large memberships may be extended to any person, business owner or advocacy representative. R1ACT members serve as active liaisons to the communities they represent.

The R1ACT meets every other month for two hours in the evenings. Most locations are near transit routes. Meetings are accessible and open to everyone. Accommodation needs and interpretation will be provided as requested.

R1ACT Members must be willing to attend meetings and actively participate in the development of the ACT work plan and evaluation of transportation projects for selection in the Statewide Transportation Improvement Plan (STIP). For more information on ACTs and STIP, go to:
