New Features in Release 5

The following features were added from Information Technology Service Requests (ITSRs):

- New option for a Voluntary contribution to Special Olympics during vehicle registration
- Change the option of a fixed \$1 Donor Fee to field where the customer can enter a larger amount to donate during vehicle registration
- Replacing the Hot Check (Credit, Redeemed and Deduct) functions in the Accounting event to Insufficient Funds Credit, Insufficient Funds Redeemed, and Deduct Insufficient Funds to be able to handle disputed payments made by checks and credit/debit cards as well as hot checks
- Making the license plate replacement fees consistent for all vehicle types
- Enabling the Carrying Capacity of a private bus to be entered

Making a Voluntary Contribution Option to Special Olympics During Registration

A new option to make a voluntary contribution to the Special Olympics is now displayed on the Fees Due PMT104 page for people who are registering or renewing registration on their vehicle. This option will be similar to the existing Miscellaneous Fee, State Parks, and Veterans Fund options where the customer specifies an amount they wish to donate.

The contribution is collected and remitted monthly (to the comptroller) in the same manner as the other voluntary contribution options sited above and will deposited to the Special Olympics Texas Fund.

Changing the Organ Donor Option

The checkbox for the Organ Donor Fee displayed on the Fees Due PMT104 page (which automatically added \$1 to the Fees Due) is now a button to display the pop-up to fill in an amount a customer wishes to donate (like the State Parks or Veterans' Fund buttons). There is no change to the remittance process.

Handling Insufficient Funds Payments

In the Accounting event, 3 Insufficient Funds functions replace the Hot Check functions to handle disputed credit and debit card payments in the same manner as hot checks.

You can now search for the type of credit and fee – either CCard for credit/debit card or HOT CHECK – or the Amount paid by typing it in the Search field at the top of the list.

You can also page through the results using the page number or the forward/backward errors and the last page/first page arrows (located directly below the displayed results).

Changing \$5 License Plate Replacement Fees to \$6

This change makes the following license plate replacement fee of \$5 for certain vehicles to be consistent with the majority of license plate replacement fees that are \$6:

- Antique Motorcycle
- Antique Classic Auto
- Classic Motorcycle
- Classic Truck
- Classic Travel Trailer
- Machinery
- Military Vehicle
- Military Motorcycle
- Old Plate
- Permit

Adding the Carrying Capacity for Private Buses

The Carrying Capacity field is now enabled in applicable events for vehicles registered in the Private Bus More Than 6000 and Private Bus Less/EQL 6000 registration class.

Issues in the Release Not Yet Fixed

The following are new issues reported since the last release but not fixed in this release. Please note that these issues may have been reported by county, region, or headquarters users and may not apply to all POS users.

Issue	Description and Mitigation
DMVRTS- 11331	The RTS Core link disappears from the Search By Owner page if action is not taken within 10 minutes of displaying the page.
	Users must close the browser and start their transaction again.
DMVRTS- 11332	In the RTS Core, the number of the View Detail Title page is not displayed in the upper right corner.
	This is a cosmetic error that does not affect processing.
DMVRTS- 11342	After viewing a selected record and then closing the View Record SB002 page to return to the Search Criteria SB001 page, the options to View Record or Select Record are not active.
	Users must select a different record and then select the record again to make the Select Record button available for that record.
RRTS - 2580	On the Enter registration expiration month and year, you cannot press the Cancel button until an incorrect date is corrected.
	This is being investigated.
RRTS - 2606	The IVTRS page contains a typographical error where the Address field contains 2 colons.
	This is a cosmetic error that will be addressed in a later release.
RRTS - 2619	After a system error on the PMT001 page during an exchange transaction, the license plate requested displays on the vehicle record but also displays in the available inventory balance.
	This is being investigated.

Summary of POS Issues Not Yet Fixed

The following is a summary of issues reported since the initial product release that have not yet been resolved.

Issue	Description and Mitigation
DMVRTS- 3812	For RSPS Status Update, the error displayed is not helpful if the flash drive is not inserted when the Enter key is pressed.
	Users must insert the flash drive and then press the Enter key.
DMVRTS-	On the Reprint Reports page, the reports are not listed alphabetically.
4252	This cosmetic error will not be fixed at this time.
DMVRTS-	On a duplicate receipt printed from the Hot Checked Redeemed page, the
5822	data does not print in the correct format.
	This cosmetic issue will not be fixed at this time.
DMVRTS-	On the Payment Confirmation page, the space bar is not available when
5867	selecting the Payment Type.
	Users should not be able to change the Payment Type on this page at this point in the transaction.
DMVRTS-	Selecting the Cancel button to return to the KEY021 page, changing the
6675	Funds Types option, and then pressing the Tab key may cause the cursor to
	jump up to the address bar (URL) of the Internet browser.
	Users must use the mouse to manually position the cursor in a field on the POS
	page.
RRTS-	On the Session Expired page that displays when the system detects no
00	the computer screen
	Users should select Leave Page or exit POS when a Session Expired message
	displays.
RRTS-	On the Primary Evidence Surrendered Table of the TTL0011 page, the cursor
227	displays in the Texas Title area instead of in the search area.
	Users must use the mouse to manually position the cursor in the search area.
RRTS-	On the REG008 page, selecting a new value for Vehicle Class (instead of
284	PASS) and then pressing the Tab key causes the cursor to move to the
	Registration Class field, but the existing value in the field is not highlighted
	instead of replacing it.
	Users must manually highlight the value with the mouse before typing new text in
	the field.
RRTS-	Working in another related application (like WebDealer) but not directly in the
341	POS may cause users to be logged out of the POS if they are not actually pressing keys in the POS application pages.

	Users must log into RTS POS again if they have not actively used the RTS POS application for 30 minutes or more.						
RRTS- 349	During a registration involving Special Plates, pressing the ESC key to go back to the previous page and then cancelling the transaction causes a system error to display. Users must exit the RTS application, and then log back in and perform the transaction again.						
RRTS- 355	When processing a transaction, an error message may display that states "Take note of any unsaved data and click here or press ESC to continue Code 502." Users must exit the RTS application, and then log back in and perform the						
	transaction again.						
RRTS-	A certificate error may display the first time users open the RTS POS.

	Users must:						
	1. On the RTS POS, click Exit from the access bar and choose a sign-off option.						
	2. On the browser window, click the X in the corner of the window to close it.						
	3. On the desktop, click the RTS POS icon to open the RTS POS again.						
RRTS- 369	Comments field and pressing the Enter key does not display the next page.						
	Users should not enter a comment when declining an IVTRS transaction.						
RRTS- 467	After typing in the payment for a transaction, pressing Enter causes a system error to display.						
	Users must begin the transaction again.						
RRTS- 473	When running a report in RTS, typing the Start Time and/or End Time as a string without colons (for example, 83045) causes a system error to display.						
	Users must manually type in colons between the hour, minutes, and seconds specified (for example, 8:30:45) when entering a specific Start Time and/or End Time while configuring a report in the RTS POS.						
RRTS- 491	When printing several renewal receipts in a row, the receipts do not print in the order they are sent to the printer.						
	Users must carefully match the receipt to the correct transaction for the customer.						
RRTS- 619	When processing an Internet renewal where the customer changed their address, pressing the Enter key on the Vehicle Information and Processing REG103 page displays the REG105 page and then pressing the Enter key on that page causes the REG103 page to display again, which appears to keep the user from continuing to process the transaction.						
	Users can press the Tab key to reach the Enter button or use the mouse to click

RRTS-	Processing a title correction where an invalid document number was entered
