Interested Individuals, Organizations, and Agencies

The USDA Forest Service, San Bernardino National Forest (SBNF) is planning a project to designate OHV routes and restore unauthorized routes on the Mountaintop District. This letter begins a 30-day scoping period for an environmental analysis, during which we are actively seeking comments. A project description, a map of the project area, and additional information can be found online at the link below.

The project, called Rattlesnake Mountain OHV Trails, consists of designating approximately 8.7 miles of OHV routes, and restoration of approximately 25 miles of unauthorized routes. The project area covers approximately 8,000 acres ranging from near Rattlesnake Mountain to Big Pine Flat; this is the area within which proposed trails, mixed use of roads, and restoration of unauthorized routes will be evaluated, and environmental effects will be analyzed for this project. This project area is on the northern edge of the Mountaintop District of the SBNF, south of the Town of Apple Valley and north of Fawnskin. Coxeey Road (Forest Road 3N14), Grapevine Canyon Road (Forest Road 4N16), and White Mountain Road (Forest Road 3N17) pass through or adjacent to the project area. The project area is adjacent and to and southeast of Juniper Flats, managed by the Bureau of Land Management (BLM), and would connect to OHV routes managed by BLM in that area.

The SBNF is requesting written comments on the scope of this Proposed Action. Comments are being requested to help identify key issues, potential alternatives, mitigation measures, and to analyze the effects of the proposed action. If you have pertinent information, points of dispute, debate or disagreement regarding potential effects of the proposed action, please send those to the project leader. Please be as specific as possible expressing your comments so they can be effectively addressed.
