State Director's Message

As I sat down to write this letter, it immediately struck me what a challenging, yet rewarding year, 2015 has been at Rural Development

(RD). Most years we experience some change and with that comes uncertainty. This past year RD experienced both.

We said goodbye to retiring longtime employees, and others who moved on. We have seven new faces in Casper and Riverton. We are downsizing space at the Casper state office and relocating across the hall into shared space with NRCS in the Torrington field office. Both measures conserve resources and

reflect RD's current size and staffing. Phone numbers and addresses remain the same.

We closed on some exciting projects and are seeing others under construction that have been in the works for two or three years. We have played a role and funded a portion of many important projects across the state:

- A new surgical center under construction in Rock Springs
- Over 1,300 new homeowners across the state
 - 48 affordable apartments in Jackson re-

financed and renovated to maintain afford-ability

- A business expansion grant to a small business in Buffalo
- The acquisition of a new fire truck for a small community
- Loans for an expansion and canning operation for a Sheridan business

The list of projects that we have funded is impressive. In FY15, RD invested \$265,848,346 in Wyoming. We are closing in on the \$2 billion mark for housing loans made in Wyoming. Wow!

Some areas of the state are still recovering from severe springtime flooding. RD has been heavily involved with the FEMA Disaster Assessment Team strategizing with the State and the Town of Lusk on a long-term plan for recovery. Buffalo and other communities were impacted this spring as well, however only Niobrara County was granted a federal disaster declaration.

We have undergone numerous changes designed to make some of our applications as streamlined and efficient as possible. We continue to strive to improve communications with our borrowers and clients, and to further

Secretary visits Wyoming

U.S. Department of Agriculture Secretary Tom Vilsack visited Wyoming in June to promote the Rural Energy for America Program (REAP). During his trip, he stopped at Snake River Brewing Company in Jackson where he made an announcement for 544 grants that combined for \$6.7 million for REAP.

"Energy costs can consume a large part of a business's budget," Vilsack said. "I am pleased that USDA's Rural Energy for America Program is helping farmers, ranchers and rural small business owners here in Wyoming save thousands of dollars in energy costs each year. This assistance from USDA helps businesses develop renewable energy systems and make energy efficiency improvements."

Snake River Brewing Company, which was established in 2007, received a \$13,810 REAP grant to install a solar panel. Once the panel is operational, the renewable energy project will generate more than 21,000 kilowatt-hours of electricity annually. It will also reduce the use of traditional fossil-based fuels and is expected to reduce greenhouse emissions by 21.6 metric tons in carbon dioxide equivalence.

The brewery is located in the heart of the Teton Mountain Range and employs more than 100 people.

Wyoming rancher Byron F. Oedekoven received two REAP grants. He will use one – a \$5,825 grant – to make energy efficiency improvements to offset the costs of lighting upgrades for shops and barns used in his ranch-

ing business. Oedekoven is also receiving a \$17,681 grant to transition from propane to geothermal energy. The switch from fossil fuels will help reduce greenhouse gas emissions and reduce his energy costs.

REAP was created by the 2002 Farm Bill and was reauthorized by the 2014 Farm Bill. REAP funding has helped farmers expand renewable energy use in recent years. According to the 2012 Census of Agriculture, 57,299

farms reported using a renewable energy producing system in 2012. That's more than double the 23,451 operations that reported the same in 2007. Solar panels accounted for 63 percent of renewable energy producing systems on farms, with 36,331 farms reporting their use. Farmers and ranchers continue to lead the charge toward a more sustainable energy future.

RD Apply


USDA Rural Development Wyoming is streamlining the application process for Rural Utility Service (RUS) Programs that provide much-needed infrastructure and infrastructure improvements to rural communities. Programs such as Water and Environmental Program (WEP), Telecom Infrastructure and Telecom Farm Bill can now use the newly designed online application system.

This process was designed specifically to provide consistent program delivery, timeliness, convenience and identity security while reducing paper consumption and streamlined customer service.

With RD Apply, applications are taken electronically on line. Once the application is complete, all parties are able to access the project and input their respective information. This includes the applicant, engineers, architects and attorneys.

In Wyoming, the Town of Greybull is on target to be the first to apply for RD funding in this manner. We hope that more communities and entities seeking water, sewer and solid waste funding will take advantage of this new system.

Top Lenders in Guaranteed Rural Housing Program

USDA Rural Development has announced its Top 10 approved lenders for loan activity for its Guaranteed Rural Housing (GRH) loan program in Wyoming for fiscal year 2015.

In FY 2015, lenders participated in the GRH program and provided more than \$231,415,141 to assist 1,230 rural Wyoming households in achieving home ownership.

These lenders have been recognized by Rural Development and received certificates honoring their dedication and accomplishment.

FY 2016 should be a strong year as well and Rural Development is planning a celebration to honor lenders that will help us reach \$2 billion in GRH obligations.

Through the GRH program, loan funds are provided by private lending institutions and guaranteed by the federal government. The program features no down payment to eligible income households and no maximum mortgage limits. Homes must be located in rural areas. In Wyoming, this include every-

Multi-Family Housing

Cedar Creek II Apartments

USDA Rural Development's Multi-Family Housing (MFH) Programs offer affordable rental housing for very-low-, low- and moderate-income residents, the elderly and persons with disabilities.

This year we financed and subsidized a MFH property in Jackson, Wyoming – the Cedar Creek II apartments. Not only did that property receive new owners, but it also was given a new name, face-lift and an extended life span.

In 2014, the new owners applied for and received over \$5 million in funding. This funding was provided by USDA Rural Development, Bonneville Mortgage Company, Wyoming Community Development Authority, Mountain Plains Equity Group and First Interstate Bank.

This funding allowed Cedar Creek II Housing Limited Partnership to purchase the Jackson Apartments and to complete a comprehensive rehabilitation of the property.

This project included new cabinets, countertops, plumbing fixtures, light fixtures, floor coverings, windows and new paint. Major improvements to handicap accessibility and energy efficiency were made both inside and out. New energy efficient windows were installed in all buildings. Sidewalks, ramps, curbs, and parking lots were replaced to allow better handicap accessibility.

Loans for rental housing in rural areas are available under Section 515 of the Rural Housing Act of 1949, as amended, to provide living units for persons with low and moderate incomes including those ages 62 and older. Loans may be made for housing in open country and communities up to 20,000 people.


