Significant Activity: Dec 23-24



Significant Events: Severe Weather – Eastern U.S.

Significant Weather:

- Severe Thunderstorms/ Flash Flooding – Central Gulf Coast to Mid-Atlantic
- Heavy snow – Upper elevations of Pacific Northwest, California, Central Great Basin, Southwest & Rockies
- Red Flag Warnings: None; Elevated/Critical Fire Weather: None
- Space Weather:
 - Past 24 hours: minor, reaching R1 radio blackouts occurred
 - Next 24 hours: no space weather predicted

Declaration Activity:

- Major Disaster Declaration – Idaho (FEMA-4246-DR-ID)

Severe Weather – Eastern U.S.

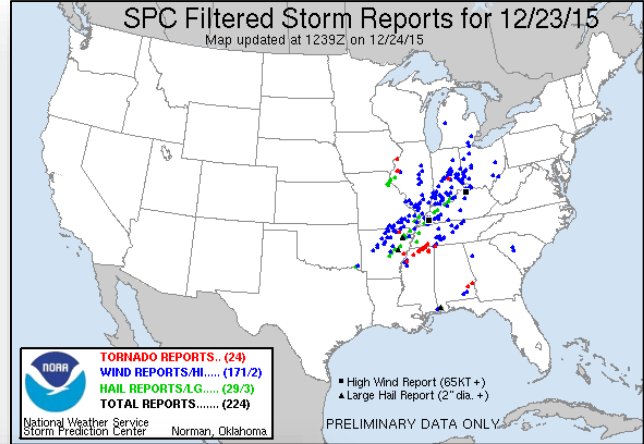


Situation:

- Widespread tornado outbreak impacted Lower Mississippi, Tennessee & Ohio Valleys
- Preliminary reports of 29 possible tornados, 211 wind & 35 hail events

Impacts:

- Region IV: Approximately 14k customers w/o power (DOE Eagle-I as of 7:00 a.m. EST)
 - 3 confirmed & 2 unconfirmed fatalities; over 40 injured
 - 3 shelters open in MS with 1 occupant
 - Downed trees & power lines, road closures & damage to numerous homes & businesses
- Region V: Approximately 153k (137k MI) customers w/o power (DOE Eagle-I as of 7:00 a.m. EST)
 - No fatalities or injuries reported
 - Downed trees & power lines, damage to several homes & businesses
- Region VI: Approximately 1k w/o power (DOE Eagle-I as of 7:00 a.m. EST)
 - 1 unconfirmed fatality reported in AR
 - Downed trees & power lines, damage to homes & businesses



State Response:

- MS and TN EOCs at Partial Activation
- KY EOC activated to Level IV (Monitoring)
- TN declared a State of Emergency for Severe Storms

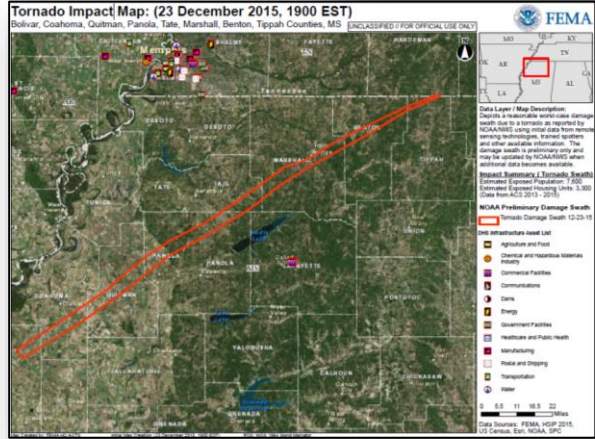

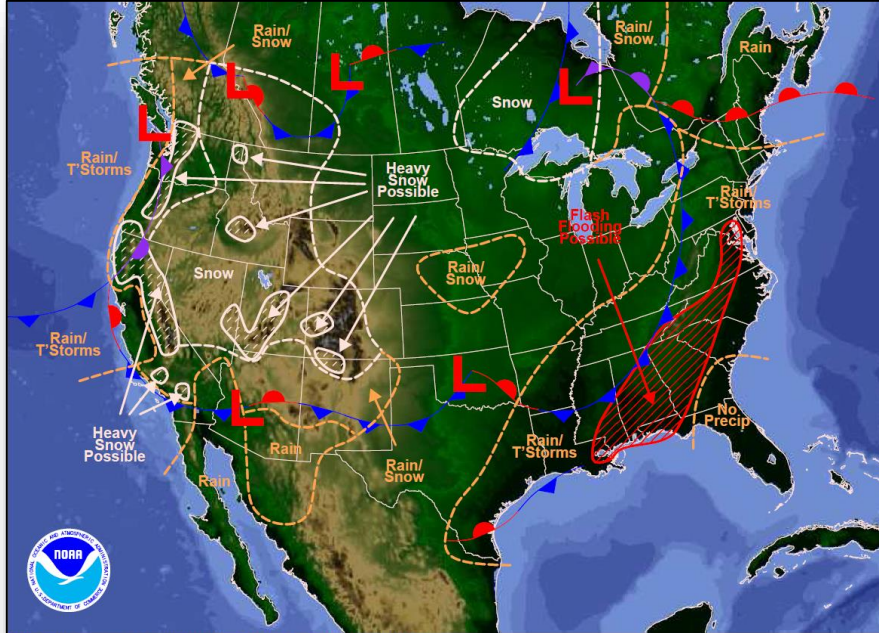
- RRCC not activated; RWC/MOC at Normal Ops

- NRCC is not activated; NWC at Watch/Steady State (24/7)

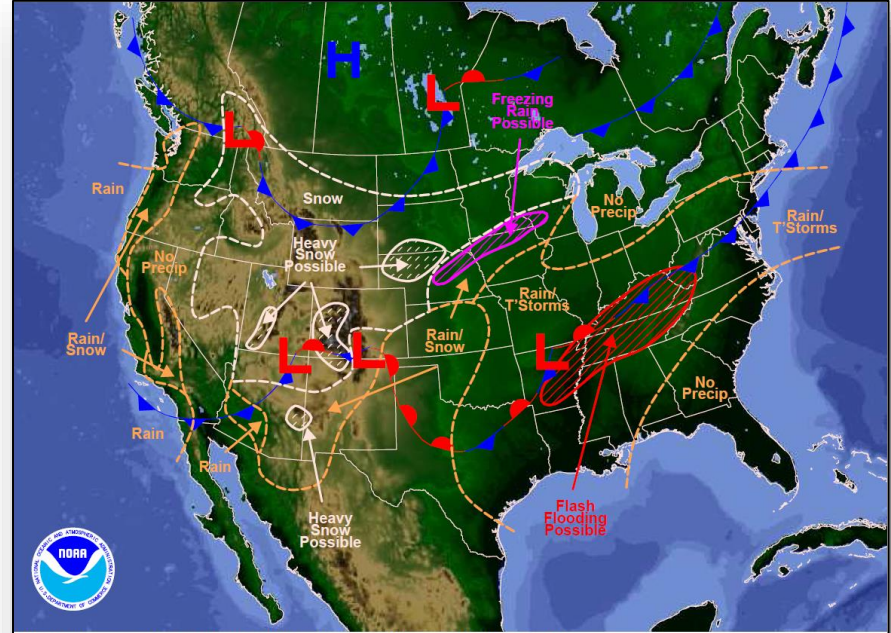


National Weather Forecast

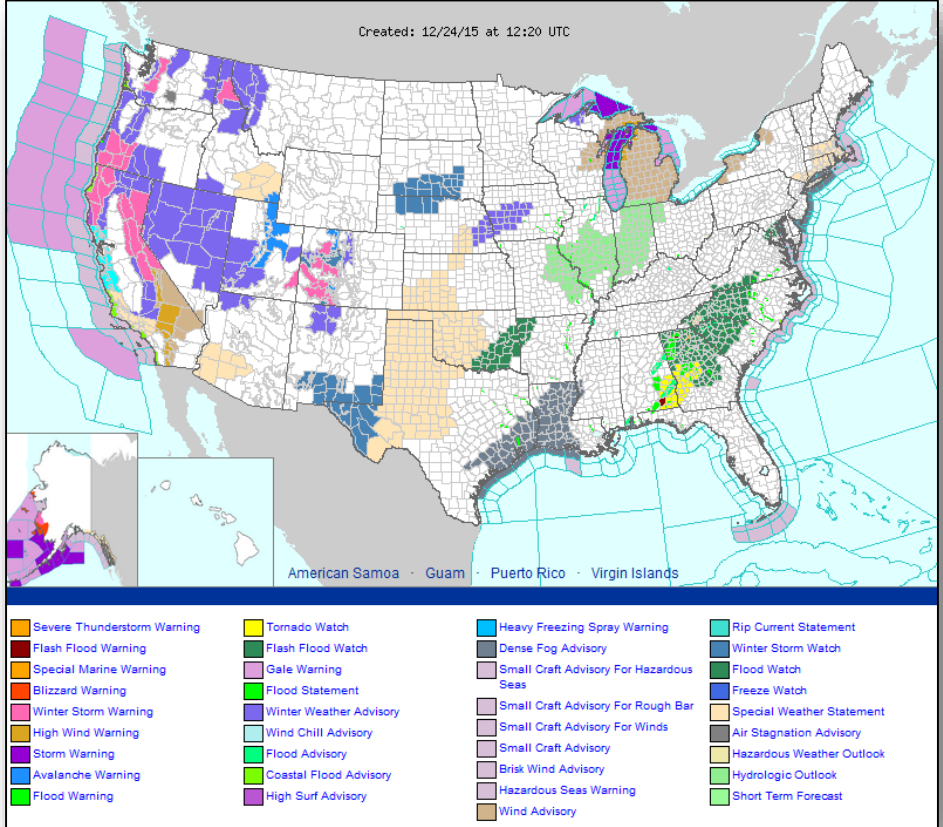

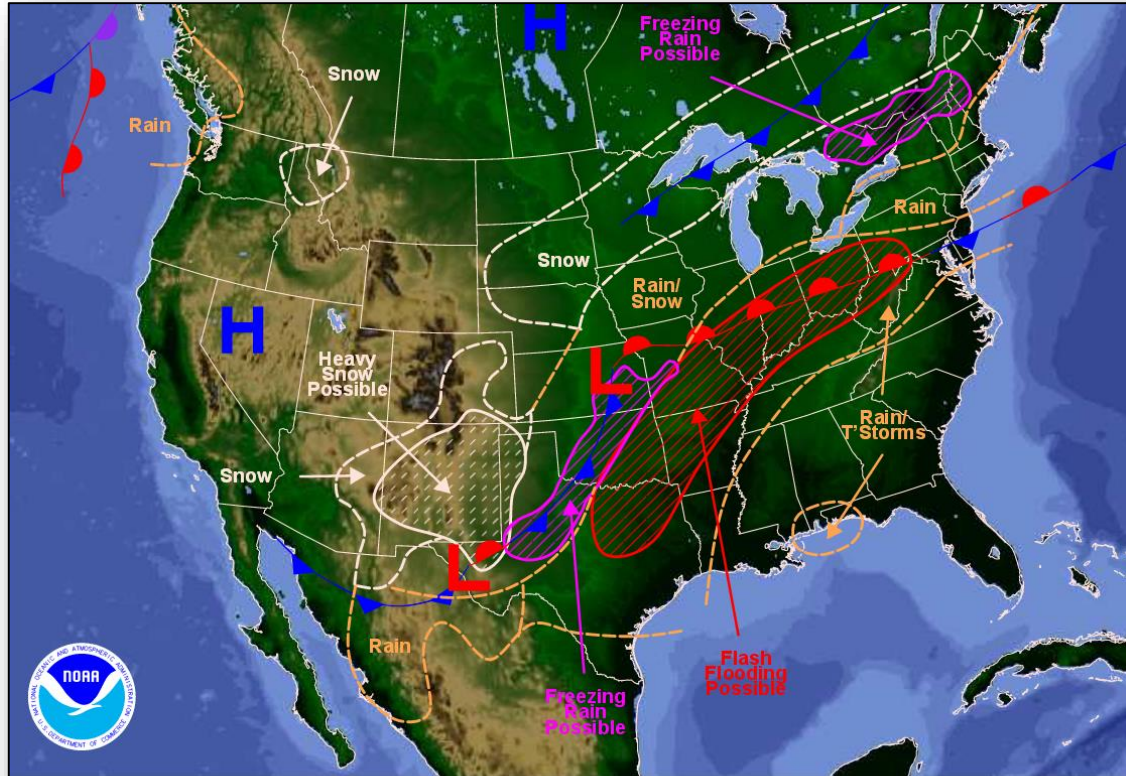

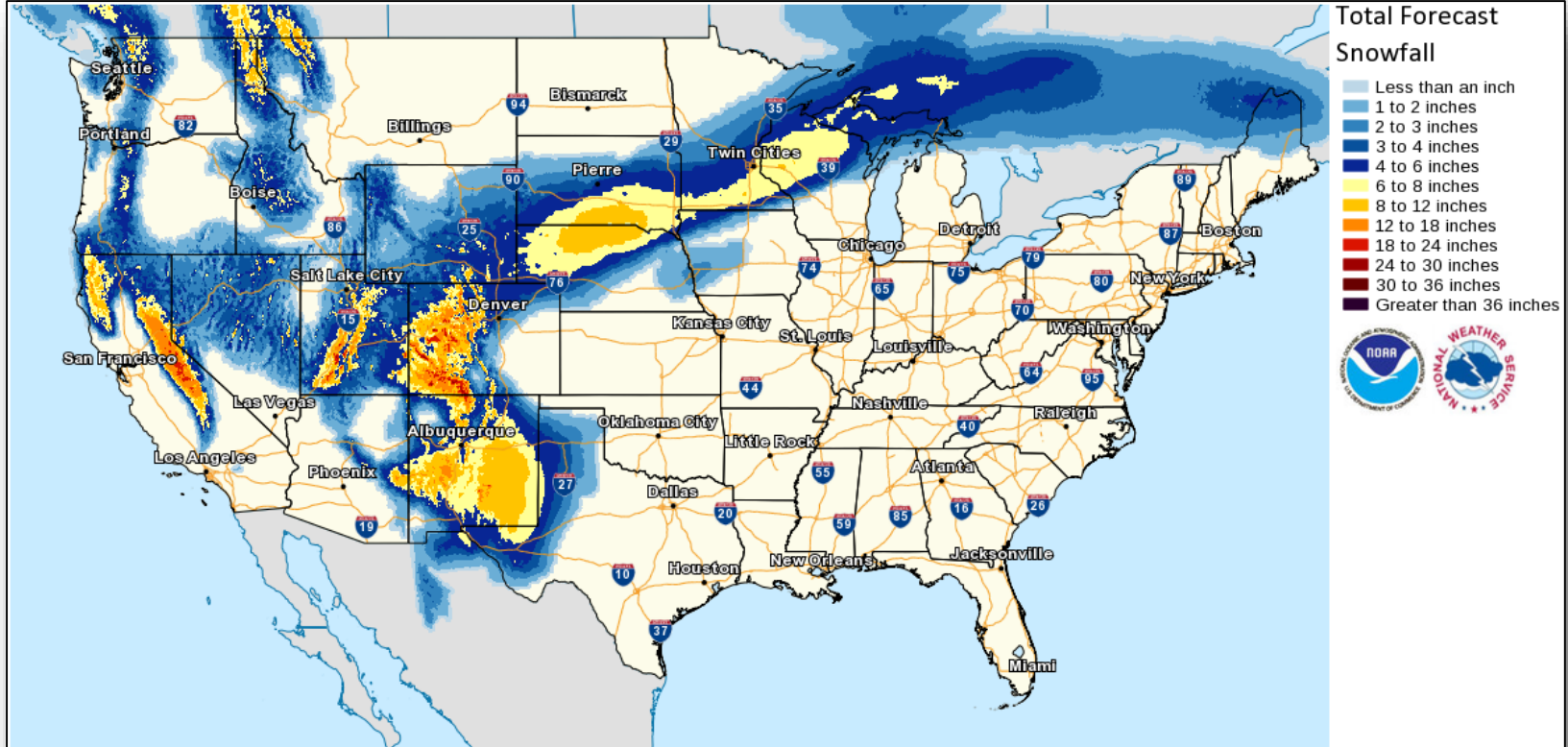


National Forecast - Day 3 (Saturday)

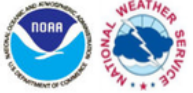

Snowfall Forecast



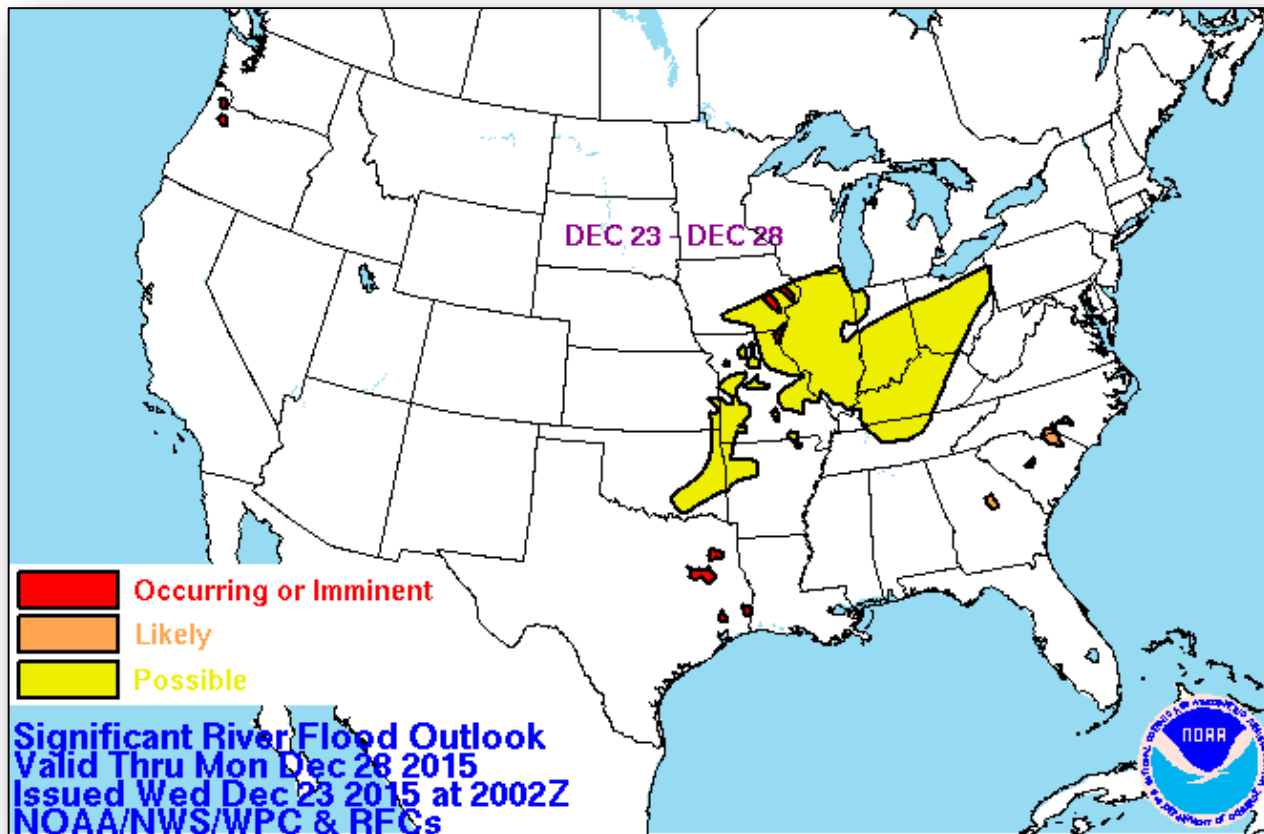

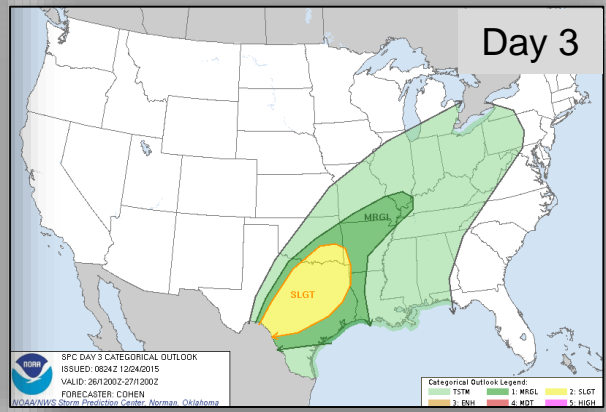
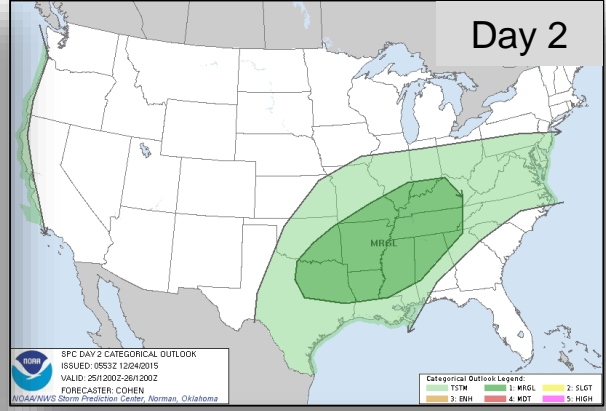
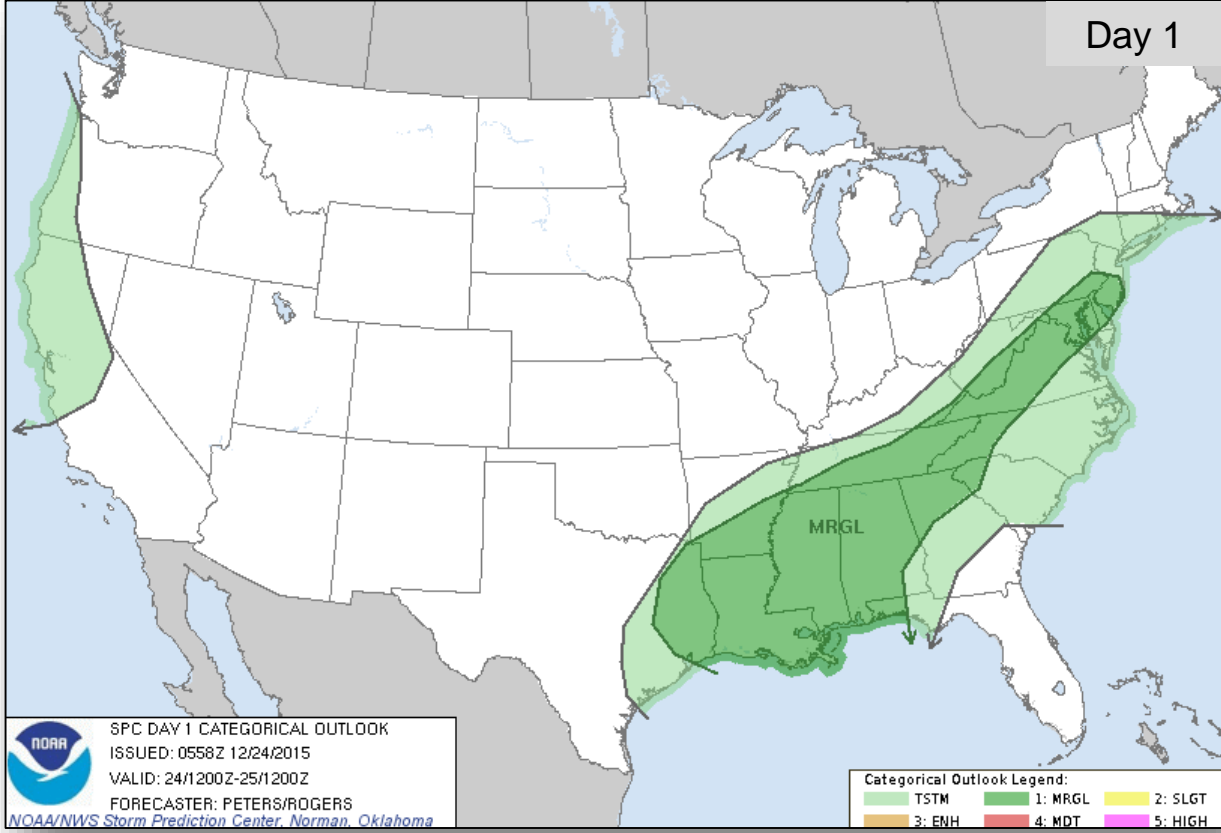
Significant River Flood Outlook

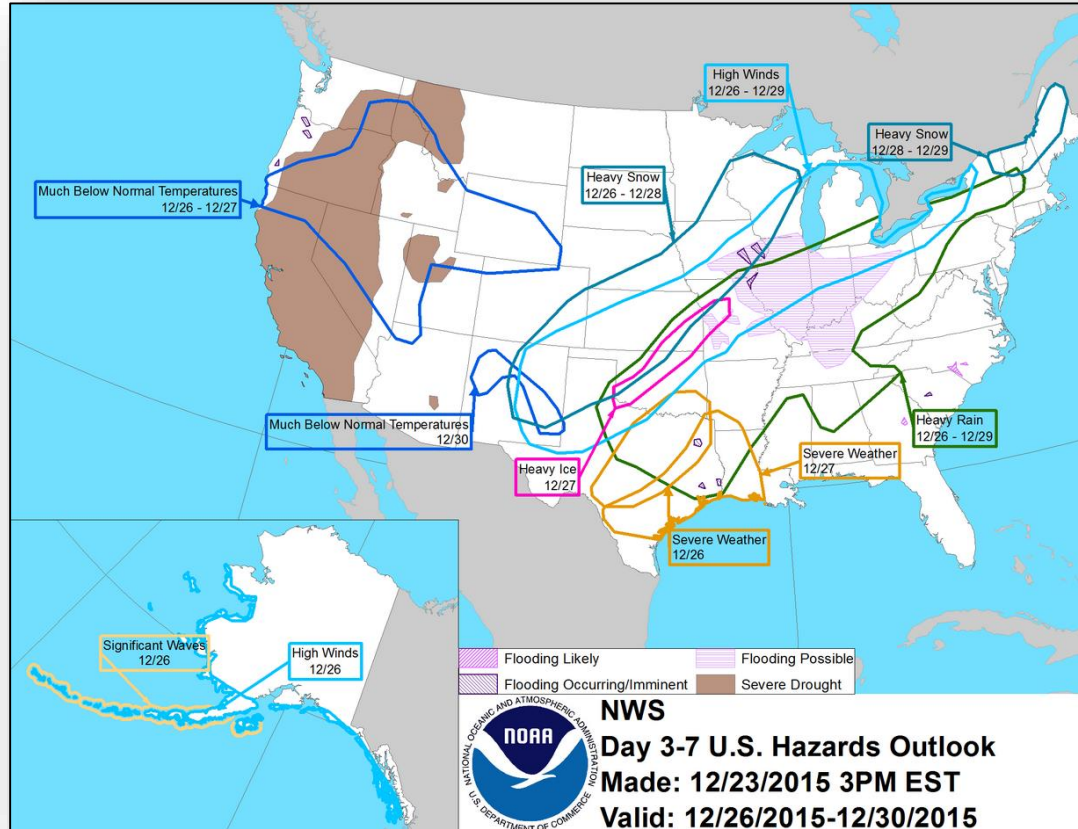
Severe Weather Outlook, Days 1-3

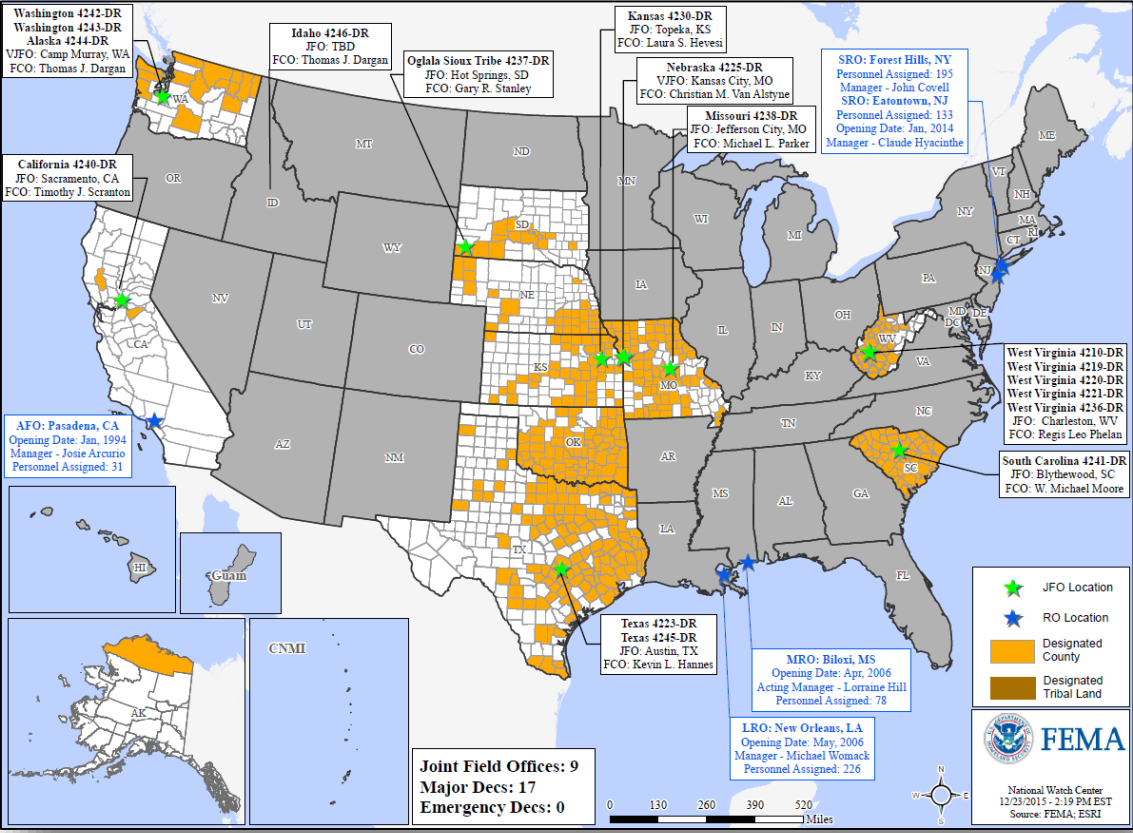


FEMA-4246-DR-Idaho
