BLANKET VARIANCE - 1115 Adult Residential Facilities

The Commissioner recognizes that 1115 Adult Residential Facilities are not traditional assisted living homes; therefore, certain accommodations should be made to meet the needs of the state, the provider, and the residents we are all serving. Commissioner Crum has approved the below blanket variances for all 1115 Adult Residential Facilities.

7 AAC 260 (a)(7)(c)	Modification	For an Adult Mental Health Residential program bedroom that is for triple occupancy, it must contain at least 200 square feet of open floor space measured before furniture is placed in the room
7 AAC 75.260 (b)	Modification	A Facility can be used as an Adult Mental Health Residential program licensed as an Assisted Living Facility with specified variances and may be licensed in a building that has more than one occupancy if:
