**CEQA:** Pursuant to the California Environmental Quality Act (CEQA) guidelines, an initial Study

was prepared and Mitigated Negative Declaration (MND) finding was adopted by the Planning Commission on March 15, 2011 for the Tilden Terrace Site Plan Review, Administrative Modification, and Density and Other Bonus Incentives applications. This Tentative Parcel Map application does not propose any changes to the previously approved applications; no new information has become available and no changes in the approved project have been made since the Planning Commission's adoption of the MND. Therefore, pursuant to Section 21166 of the Public Resources Code and Section 15162 of CEQA, no new environmental analysis is required for this subdivision

application.
