4/22	C3	Vandalism ARREST	At 4:12 AM, deputies responded to a vandalism call at Voyager Craft Coffee on Stevens Creek Boulevard. An investigation revealed the suspect threw a glass mug at the front door of the business, breaking the door. The total amount of damage was estimated at approximately \$1,000.
