7/7	C3	Commercial Burglary ARREST	Between 2:09 PM and 3:14 PM on 6/18, two suspects entered a storage unit at Public Storage on Valley Green Drive by prying the door open and stole paperwork and tools valued at approximately \$250. The follow-up investigation led to the identification of both suspects. One suspect was arrested and booked into the Main Jail, while the other remains at large pending the issuance of a warrant.
