NOTICE: Full Intersection Closure

ELWOOD AVE. / FOOTHILL BLVD. (CITY OF GLENDORA) JUNE 10 - JUNE 17, 2024

CONSTRUCTION ACTIVITY

As part of the Foothill Gold Line light rail project, crews will be completing the intersection improvements at Elwood Ave. and Foothill Blvd. in the City of Glendora. Construction crews will finalize the intersection by installing the new traffic signals, which requires a full closure of the intersection. No vehicular traffic will be permitted through the intersection during this work. Access to residences and the Christian Science Church will be maintained at all times.

WHEN

Beginning Monday, June 10th and continuing thru Monday, June 17th, the Elwood Ave./Foothill Blvd. intersection will be fully closed to all vehicular traffic 24 hours a day. Loriane Ave. (east of the intersection) and Bennett Ave. (north of the intersection) will remain open and accessible by way of detour routes, see map below.

• Work Hours: 7:00 AM - 9:00 PM, Monday thru Saturday. NOTE: Occasional longer work hours and construction on Sunday may be performed during the period.

TRAFFIC ADVISORIES

- Elwood Ave. will be fully closed to thru vehicular traffic between Bennett Ave. & Woodland Ave.
- Foothill Blvd. will be fully closed to thru vehicular traffic between Live Oak Ave. & Loraine Ave
- Pedestrian access will be maintained via eastbound/westbound Foothill Blvd.
- Access to residences and the Christian Science Church will be maintained at all times.

PLAN YOUR ROUTE AND BE PREPARED

- A detour route (see map below) will be in place during the closure and signage will be posted to direct motorists. Please follow detour signs.
 - ✓ Live Oak Ave. & Loraine Ave. (northbound and southbound) will serve as the main detour routes.
 - √ Woodland Ln. & Bennett Ave. (eastbound and westbound) will serve as the main detour routes
 - ✓ Glenwood Ave. (NB/SB), Carroll Ave., Dalton Ave., Mountain View, & Meda Ave. (EB/WB) within the closure area will remain open and accessible for thru local traffic.


NOTE TO RESIDENTS / BUSINESS OWNERS
