# UPDATED NOTICE: Intermittent Lane Closures Lone Hill Ave.

## LIGHT RAIL BRIDGE AND RAILROAD CROSSING CONSTRUCTION (CITY OF GLENDORA) EXTENDED THRU DECEMBER 2024

### CONSTRUCTION ACTIVITY

As part of the Foothill Gold Line light rail project, crews will continue to work on final bridge, street paving and striping and railroad crossing operations on Lone Hill Ave. Construction activities will alternate between the center median and adjacent to the outermost lanes at the railroad crossing. Lanes in each direction will continue to be closed intermittently thru December 2024, as well as full directional closures with detour signage in place to direct traffic. **Two lanes in each direction will be maintained at all times during daytime work hours.**

### WHEN

Ongoing and continuing thru December 2024, lane closures on Lone Hill Ave. will be in affect intermittently in both directions up to 24 hours per day. Allowable work hours are:

- **Daytime Work Hours:** 7:00 AM - 9:00 PM
- **Nighttime Work Hours:** Monday - Friday, 7:00 PM - 6:00 AM & Saturday - Sunday, 7:00 PM - 7:00 AM
- NOTE: Occasional longer working hours and Sunday working hours may be needed.

### WHERE

Construction activities will take place in both northbound and southbound lanes of Lone Hill Ave. between Gladstone St. and Auto Centre Dr., at the railroad crossing. Thru traffic will be maintained during the day, and access will be maintained at all times to local businesses and the Glendora Marketplace.

### TRAFFIC ADVISORIES

- **Daily:** Traffic lanes on Lone Hill Ave. from Gladstone St. to Auto Centre Dr. will be closed intermittently. **Thru access for vehicular traffic will be maintained.**
- **Intermittent Nightly:** Reduced northbound & southbound access will occur intermittently with traffic maintained. Full northbound & southbound directional closures may occur as needed. Signage will be in place to direct traffic to alternate detour routes during directional closures. Access to businesses will be maintained at all times.

### NOTE TO RESIDENTS / BUSINESS OWNERS

- Typical noise from construction equipment will be produced near the active work zones such as construction vehicles and light plants (during nighttime hours).
- The red area in the map shows the work zones.

### STAY SAFE
