COVID-19 TESTING	<p style="text-align: center;">Testing is Prioritized and Strongly Encouraged for:</p> <p>Symptomatic persons with:</p> <ul style="list-style-type: none"> • Fever or chills, Cough, Shortness of breath or difficulty breathing, Fatigue, Muscle or body aches, Headache, New loss of taste or smell, Sore throat, Congestion or runny nose, Nausea or vomiting, and Diarrhea. <p>Symptomatic persons who are:</p> <ul style="list-style-type: none"> • Hospitalized • Healthcare workers and other first responders • Employees and residents in group living settings, and • Over 65 years old or with <u>underlying health conditions</u> that place them at higher risk of serious complications <p>Asymptomatic persons:</p> <ul style="list-style-type: none"> • If they are part of a public health investigation • If they live or work in high risk settings, such as skilled nursing facilities or homeless shelters • If they are a close contact of someone with a confirmed positive diagnosis of COVID-19, or • If they are an essential worker. <p>Prioritization of routine testing among other asymptomatic people is not recommended at this time. People over the age of 65 or with underlying conditions do not necessarily need to be tested unless they have symptoms, have had an exposure or have been told by public health to be tested. - The Los Angeles Regional Food is taking necessary precautions to make sure that food and product remain safe, and that distributions and volunteer activities can continue. For more information [Click Here.](#)
- As of 10/28/2020, Access Services has completed over 264,936 deliveries of means, grocery boxes, and paper goods to people with disabilities and seniors across all current projects.
- This week, #LetsFeedLACounty is hosting 1 drive-thru food distribution event on 11/06 at Cerritos College.
- Total distributed to date at 48 events is 2,791 tons of food which is the equivalent 4.6 million meals provided to 81,466 households.
- Drive-thru food distribution event held last week in Hollywood and Bell where: 1,308 and 1,435 households, respectively, were provided 80 pounds of food, including shelf-stable items, dairy product frozen meat, and fresh produce.
- We have now exceeded 5 million pounds of food distributed..
- #LetsFeedLACounty has secured 400 20-pound boxes of groceries from the LA Regional Food Bank for weekly delivery through the end of December to clients of the DHS Housing for Health program.
- Issuing additional CalFresh benefits up to the maximum allowed per family and allowing CalFresh recipients to purchase groceries online for delivery from Walmart and Amazon.
- Great Plates Delivered has a current service population: 7,457 seniors. Total meals served through this program since May 12: 1,893,636.
- The Great Plates Delivered Program has contracted with 75 meal providers that are employing 1,755 people. 68% of meal providers are minority-owned businesses.
- Great Plates Program has been extended until November 8, 2020.
- Elder Nutrition Program has a current service current population of 26,919 seniors (37% increase since June 20).
