## Training Overview

As required by state law of California Evidence Code Section §1037.1(a)(1), all employees and volunteers who will be providing direct client services at any domestic violence service agency are required to receive 40 hours of training on domestic violence. At the end of the training, you will receive a Certificate of Completion. *This certificate does not act as a license to provide domestic violence services.* Please see below for the topics covered in the training:

- Overview of domestic violence and societal attitudes
- Adult and youth services, peer counseling, crisis intervention, and cultural competency
- Legal issues, police response, and criminal prosecution
- Housing, public assistance, financial, health and referral services
