## Supervisory District 2

With drop-off service, you will be able to drop off your tax documents and any pre-filled forms at a secure location. Then, an IRS-certified VITA volunteer will work on your tax return. You will be contacted to return to the VITA site to review and sign your tax return after it has been prepared. It will then be sent to the IRS.

### Required Tax Documents (If Applicable)

- Taxpayer must be present with photo identification.
- Social Security cards for all the people listed on the tax return.
- Copies of last year's federal and state tax returns.
- Birthdates of all the people listed on the return.
- All income statements, such as Forms W-2 and 1099, Social Security and unemployment compensation. Other statements also included are pensions, stocks, interest and any documents showing taxes withheld.
- If you are self-employed or make cash, collect records of all your income and expenses.
- Forms 1098 for college tuition, student loan interest, mortgage interest, or real estate taxes.
- Form 1095-A Health Insurance Marketplace Statement if you purchased insurance coverage through Covered California.
- Identity theft PIN issued by the IRS.
- Bank routing numbers and account numbers to direct deposit any refund.
