4th District Highlights from 2017

As your Supervisor, it is my goal be engaged in our community as much as I can . Community events are great resource for me, both to share County projects with you and to hear from you on how we can improve . Below are some events that I would like to highlight:

- This past fall, I spoke at the Clean Marin Trash Summit organized by the Marin County Coalition of Storm Water Pollution Prevention Program. It is important to highlight this effort to clear the storm water runoff of trash, especially as we enter the winter season. - I spoke at the Marin County Commission on Aging at their December policy meeting and gave an overall update of the County's work on age-friendly policy. Included in my remarks was an update on our [Junior Second Unit/Accessory Dwelling Unit Program](#) and the Year of the Older Adult.
- I was the keynote speaker at the Mission San Rafael Bicentennial Celebration. While it is outside the 4th District's boundaries, the Mission's services are well attended by many of my constituents, and it was a great opportunity to get to know them.

- I participated in the Marin County Free Library's, "Reading for the Record," at Papermill Creek Children's Corner. A group of 30 preschoolers and I read "Quackers," by Liz Wong. My aide Lorenzo helped me by stepping in to read the Spanish version of the book. We gave a copy of the book to each student to hopefully remind them of the experience and to encourage further reading efforts at home.
- I was invited by the Consulate General of Guatemala to speak at the Guatemalan Independence Day Celebration in East San Rafael. It was a wonderful event celebrating our Guatemalan residents as part of the rich cultural fabric that makes the 4th District so unique.
- I participated in a town hall discussion with Congressman Jared Huffman on health care. The meeting discussed preserving the Affordable Care Act as well as debating the benefits of national versus state single-payer health care systems.

- Continue participation in the Clean Marin Trash Summit meetings and follow-up actions
- Find ways to reduce the negative side of tourism in West Marin, with possible funding solutions to support needed County resources
- Provide updates to the Accessory Dwelling Unit/Junior Dwelling Unit Program as well as an increased outreach efforts to promote this program to all our communities
- Simplify the building permit process
- Support the Marin Strong Start ballot measure to provide continued support to our preschool-age children
- Host a roundtable with ranchers and farmers from Sonoma and Marin
- Support increased rental protections for all our Marin residents.
- Continue my open door policy: spring community office hours will commence in March 2018

The 2018 Year of the Older Adult will include a year-long calendar of events and programs focusing on the vitality, contributions, and challenges facing Marin's senior residents. The program will initiate new policies, programs, and resources to promote an age-friendly Marin County.

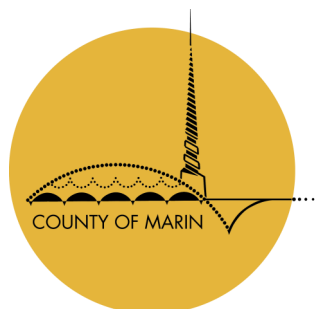
The purpose of this initiative:

- Bring all ages together to understand and celebrate the social, cultural, and economic contributions of Marin's older adults

A Message on Emergency Preparedness

The North Bay fires were a difficult experience for many of us. During this time, I was proud of 4th District's initiative to mobilize, organize, and house nearly 530 evacuees. The North Bay fire evacuees not only sought shelter in our Marin Center location, but also at the San Geronimo Valley Community Center, the Point Reyes Dance Palace, the Marconi Conference Center, Lawson's Landing, and many private homes. I thank those of you who donated your time, energy, and resources to help those in need. Every bit counts, and our community members did what they could during a very difficult and sad time.

As your Supervisor, these catastrophic events are a reminder that we need a more robust emergency preparedness program. Below is a sample of what my office has already done to ensure that our community is prepared:

- Moved the process forward to get the Muir Beach emergency siren installed in cooperation with the National Park Service, the Muir Beach Community, Green Gulch Farm, PG&E, and the Marin County Fire Department
- Arranged for two emergency preparedness trailers to be relocated to Tomales and Muir Beach
- Supported an Emergency Preparedness Grant to Tomales for the procurement of emergency radios
- Supported an Emergency Preparedness Grant to KWMR for new modern broadcasting equipment
- Supported an Emergency Preparedness Grant to Nicasio Volunteer Fire Department for the planning and permitting costs to install a back-up emergency generator.
- Reviewed lessons learned from the North Bay fires and how Marin can better prepare for the future.

On Friday, February 9, 2018, FIREsafe Marin will host a community workshop to help Marin neighborhoods achieve a Firewise USA safety recognition by the National Fire Protection Association. We'll have representatives from the Marin County Fire Department, Marin Municipal Water District, Marin County Open Space, PG&E, and others, to help you understand Marin's wildfire risk and to develop a plan to address that risk.
