SUBJECT: Eastern Placer County Fire Services – Truckee Fire Protection District Zone 7
Fire Control Fund Fiscal Analysis

ACTION REQUESTED

1. Receive a presentation from County Executive Office staff on the Fire Control Fund Fiscal Analysis for Zone 7 within the Truckee Fire Protection District

BACKGROUND

On August 29, 2023, the Placer County Board of Supervisors formed a limited duration Eastern Placer Fire Services Ad Hoc Committee to advance discussions related to ongoing funding communication from the Truckee Fire Protection District regarding Annexation #7 (aka: Zone 7) within the Martis Valley area of Placer County and to perform an analysis of options and alternatives for further discussion.

On February 27, 2024, your Board heard an update of the Ad Hoc Committee discussions and were presented options for further direction to County staff. Based on direction provided at that meeting, staff has prepared the following fiscal analysis reflecting the allocation of the Fire Control Fund associated with parcels within the Zone 7 area of the Truckee Fire Protection District based on the Board approved 2019 Voluntary Tax Exchange Agreement. A combined funding amount of the agreed upon 60/40 split is reflected below for each year of the existing agreement.
