All **regular** status employees (Temporary, Per Diem, Intern, and Contractors are exempt from completing the survey) are required to complete the County of Riverside the **MANDATED** 2022 Annual Commuter Services Transportation Survey. The annual survey collects data on how you commuted to work during the week of **JUNE 20 – 24, 2022 (MONDAY – FRIDAY)**

Below are a few good reasons why you must complete and submit the survey...

- 1. It's MANDATORY for all Regular status employees to complete the survey.** The County must conduct this survey annually to meet clean-air mandates. Whether you are reporting to your worksite or are currently working from home, your input is vital and required.
- 2. Filling out the survey takes less than 3 minutes.** The survey primarily collects information on how you arrived to work (drove alone, carpool, rode transit, biked, walked, or telecommuted) on some or all workdays. The results of the annual survey are used to compare commuter trends from year-to-year and to assist the County in providing useful resources and information on commuting options and potential carpool groups from various areas within the County of Riverside.
- 3. It helps the County better meet commuters needs.** The survey compiles useful data that helps the County develop programs to make your commute easier and less stressful. Plus, the survey results are also used to evaluate how the County is doing in providing commute services to employees and identify areas where we can improve.
- 4. You may elect to receive a free RideGuide!** If you select yes at the bottom of the survey, you will receive a RideGuide after the surveys are processed with personalized information on your transportation options, such as carpooling or transit routes.
