### SUBJECT: AUTHORIZATION TO ISSUE A REQUEST FOR PROPOSALS AND AWARD A PHASED CONTRACT FOR THE UPGRADE OF THE REGIONAL COMMUNICATIONS SYSTEM (DISTRICTS: ALL)

#### **OVERVIEW:**

1.

The Regional Communications System (RCS) provides public safety and public service radio communications service to San Diego and Imperial Counties, 24 incorporated cities, and numerous other local, state, federal, and tribal government agencies in the San Diego County/Imperial County Region.

The RCS technology is approaching its end of life and can no longer be supported. The County has been working with RCS partner agencies to plan for upgrading the system with next generation public safety interoperable communications technology that complies with the International Association of Public Safety Communications Officials Project 25 standards.

This is a request to authorize the Director, Department of Purchasing and Contracting to issue a request for proposals and award a contract or contracts for the procurement, implementation, support and optional financing of a next generation regional public safety communications system. The project would be divided into three phases: Phase I would provide for services for planning and system design; Phase II would implement contractor recommendations for the equipment, software, and services to upgrade the technology at existing RCS facilities; and Phase III would consist of any necessary development or construction of new RCS facilities or expansion of existing facilities. The contract would provide that Phase III is optional, and the County, in its sole discretion, may exercise the options.

If new required sites are identified, and once these sites have undergone environmental review, staff will return to the Board to request approval to proceed with Phase III of the project.

This is also a request to establish a separate trust fund to hold vendor deposits related to the procurement of a next generation regional public safety communications system.

#### FISCAL IMPACT:

There is no current year fiscal impact as a result of this request. Funds in the amount of \$50,555,000 have been included in the Fiscal Year 2015-16 CAO Recommended Operational Plan in the Justice Facility Construction Fund. The funding sources are available prior year Public Safety Group fund balance (\$34,255,000) and fund balance component decrease (\$16,300,000). The estimated cost of the Next Generation Regional Communications System (NextGen RCS) infrastructure is \$105,000,000. The actual cost of the system, as determined following the competitive procurement, will be shared by all the parties to the Agreement Between and Among the County of San Diego and

Participating Cities and Jurisdictions Regarding the Next Generation Regional Communications System (NextGen RCS Agreement), including the County of San Diego, based on the cost apportionment model established by the NextGen RCS Agreement. The NextGen RCS Agreement provides that a financing mechanism will be determined and made available by the County. Following the procurement process, any required financial agreements and recommendations for funding will be brought to the Board of Supervisors. The cost to operate the new system is not yet known; however, the cost will be allocated across all system users by charging a per-radio operating fee similar to the current Regional Communications System business model. This request will result in no change in net General Fund cost and no additional staff years.

# **BUSINESS IMPACT STATEMENT:** N/A

### **RECOMMENDATION:** SHERIFF

- 1. Find that the technology upgrade of the existing Regional Communications System is exempt from the California Environmental Quality Act (CEQA) as specified under Section 15301 of the CEQA Guidelines because the design, planning and technology improvements would occur within the existing infrastructure with negligible or no expansion of existing use.
- 2. In accordance with Section 401, Article XXIII of the County Administrative Code, authorize the Director, Department of Purchasing and Contracting, to issue competitive solicitations (Requests for Proposals) to replace the County's existing Regional Communications System (RCS) and, upon successful negotiations and determination of a fair and reasonable price, award a contract or contracts for the project, with an optional Phase III and optional vendor financing.
- 3. Authorize the Director, Department of Purchasing and Contracting to amend the contract as required to reflect changes to services and funding allocations, subject to the approval of the Sheriff.
- 4. Direct the Auditor and Controller to establish a separate trust fund to hold the vendor deposits related to the procurement of the next generation regional public safety communications system.

# 2. SUBJECT: PROBATION DEPARTMENT – PRISON RAPE ELIMINATION ACT GRANT APPLICATION (DISTRICTS: ALL)

# **OVERVIEW:**

The U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance (BJA) is accepting applications for the Prison Rape Elimination Act (PREA) Program. Today's request is to authorize the Chief Probation Officer to apply for and, if awarded, accept up to \$500,000 in grant funds from the BJA for

the PREA Program for the period of October 1, 2015, through September 30, 2017, and to authorize the Chief Probation Officer to execute all required grant documents. The funds, if awarded, will be used to support the continued implementation of the County plan and project developed to prevent sexual abuse in facilities.

This is also a request to authorize the Chief Probation Officer to apply for and accept grant funding and review and execute all required grant and grant-related documents from the BJA for the PREA Program in subsequent years provided there are no material changes to the grant terms and funding levels.

### FISCAL IMPACT:

Funds for this request are included in the Fiscal Year 2015-17 CAO Recommended Operational Plan in the Probation Department. If approved, this request will result in Fiscal Year 2015-16 costs of \$823,318 and revenue of \$357,731 and Fiscal Year 2016-17 costs of \$176,682 and revenue of \$142,269. The funding sources are the U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance (\$500,000) and General Purpose Revenue (\$500,000). There is a 50% match required for the Prison Rape Elimination Act Program grant which will be satisfied by in-kind Salaries and Benefits and Services and Supplies. There will be no change in net General Fund costs and no additional staff

# **RECOMMENDATION: CHIEF ADMINISTRATIVE OFFICER**

- 5. Authorize the Chief Probation Officer to review and execute all required grant and grant-related documents for the Prison Rape Elimination Act Program in subsequent years, including any agreements with other agencies for the distribution of grant funds where necessary to carry out the purposes of the grant, any extensions, amendments and/or revisions thereof that do not materially impact or alter the services or funding level.

### **OVERVIEW:**

Administrative Code Section 66 and Board of Supervisors Policy A-112, Acceptance of Gifts and Donations, permit the acceptance of gifts by the administrative heads of each department in the County, subject to approval by the Board of Supervisors. This request is to ratify the acceptance of safety clothing and office, field and laboratory equipment valued at \$23,526 from Lifesharing and the San Diego Eye Bank to the Medical Examiner's Department.

### FISCAL IMPACT:

Funds for this request are not included in the Fiscal Year 2014-15 Operational Plan for the Medical Examiner's Office. If approved, this request will accept safety clothing, and office, field and laboratory equipment donations valued at \$23,526 from Lifesharing and the San Diego Eye Bank to the Medical Examiner's Department. There will be no change in net General Fund costs and no additional staff years.

### **OVERVIEW:**

County of San Diego Administrative Code Section 66 and Board of Supervisors Policy A-112, Acceptance of Gifts and Donations, permit the acceptance of gifts and donations upon approval by the Board of Supervisors. This is a request to approve the acceptance of a donation in the amount of \$276,000 from the San Diego Regional Fire Foundation for the purchase of Automated Vehicle Locator (AVL) equipment. AVL equipment allows backcountry fire vehicles to transmit their location to the California Department of Forestry and Fire Protection (CAL FIRE) Dispatch Center, which can then dispatch the closest unit to an emergency for the fastest response to 9-1-1 calls.

### FISCAL IMPACT:

Funds for this request are included in the Fiscal Year 2014-16 Operational Plan in the San Diego County Fire Authority. If approved, this request will result in current year costs and over-realized revenue of \$276,000. The funding source is a donation from the San Diego Regional Fire Foundation. There will be no change in net General Fund cost and no additional staff years.

### SUBJECT: GENERAL SERVICES - AUTHORIZATION TO ADVERTISE AND AWARD A CONSTRUCTION CONTRACT FOR THE JUVENILE COURT OFFICE RENOVATION PROJECT (DISTRICT: 4)

#### **OVERVIEW:**

District Attorney staff offices are located at the Juvenile Court facility at 2851 Meadow Lark Drive in San Diego. Improvements are necessary at this site in order to renovate outdated offices and restrooms, and address code and accessibility issues. Design of these improvements is underway, with a construction contract expected to be awarded using the low bid delivery method.

The Board of Supervisors is requested to authorize the Director, Department of Purchasing and Contracting to advertise and award a construction contract for the Juvenile Court Office Renovation project. If approved, advertisement is expected in June 2015 with construction starting by September 2015. All work is expected to be completed by summer 2016.

### FISCAL IMPACT:

Funds for this request in the amount of \$2,200,000 are included in the Fiscal Year 2014-15 Operational Plan for the District Attorney's Office. If approved, this request will result in costs of approximately \$2,200,000 for all work associated with the construction of tenant improvements and temporary staff relocation at the Juvenile Court. The funding source is available prior year Public Safety Group fund balance. There will be no change in net General Fund cost and no additional staff years.

### **RECOMMENDATION:** CHIEF ADMINISTRATIVE OFFICER

- 1. Find that the proposed District Attorney Juvenile Court Office Renovation project is exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15301 (Existing Facilities).

### SUBJECT: COUNTY LIBRARY - ACCEPTANCE OF GRANTS, GIFTS AND DONATIONS, ESTABLISH APPROPRIATIONS OF GRANT FUNDS FOR THE SAN DIEGO COUNTY LIBRARY – AUTHORITY TO SUBMIT FUTURE GRANT APPLICATIONS (DISTRICTS: ALL)

#### **OVERVIEW:**

San Diego County Library (SDCL) has received numerous gifts and donations from individuals and groups that are interested in promoting library services to their communities. County of San Diego Administrative Code, Section 66, Acceptance of Gifts, permits the acceptance of gifts and donations by the administrative head of each department of the County, subject to ratification by the Board of Supervisors. The Board of Supervisors' approval to accept individual gifts over \$5,000 is required. The Board is requested to approve the acceptance of \$153,129 in cash and non-cash gifts and donations exceeding \$5,000 in value received by SDCL between the period of July 1, 2014 through December 31, 2014.

A portion of the cash donations received was matched by the Library Fund.

The California State Library has awarded a total of \$48,790 for a California Library Literacy Services grant for Fiscal Year 2014-15. The California State Library is dedicated to supporting SDCL's literacy program. This grant supports adult and family literacy. In order to provide the consistent need for adult literacy tutoring, SDCL serves its communities by providing relevant and up-to-date library materials to adult learners.

The Consulate General of Mexico in San Diego has awarded a total of \$10,000 through the Institute for Mexicans Abroad Fellowship Program for Fiscal Year 2014-15. The Institute's mission is to improve the development of persons of Mexican origin in the country where they live. The Mexican Consulate and San Diego County Library are partnering to provide educational opportunities to persons of Mexican origin residing in the U.S. with low literacy skills in their native language to better prepare them to succeed in English as a Second Language (ESL) and English Literacy programs offered by San Diego County Library, thereby eliminating an important obstacle towards greater community integration and involvement.

Cal Humanities has awarded a total of \$15,000 for a California Reads public library grant. Cal Humanities supports efforts to bring Californians together to explore important topics through books that invite thoughtful community conversation.

The County Library's mission is to inform, educate, inspire, and entertain. The County Library applies for grants and awards to fund programs that support the strategic goals of the County of San Diego and the mission of SDCL. If future applications for grants that support the County of San Diego's Strategic Plan and SDCL's mission result in an award, a subsequent item will be brought to the Board to appropriate the funds.

### FISCAL IMPACT:

Funds for this request are partially included in the Fiscal Year 2014-15 Operational Plan for the San Diego County Library (SDCL). If approved, this request will result in current year cost and revenue of \$74,090. The funding sources are grants from the California State Library (\$48,790), the Consulate General of Mexico in San Diego (\$10,000), and Cal Humanities (\$15,000), and the Library Fund (\$300). The total cost for the Institute for Mexicans Abroad Fellowship Program is \$10,300 and will be funded by the Consulate General of Mexico in San Diego grant of \$10,000 and the County Library contribution of \$300. There will be no change in net General Fund costs and no additional staff years.

SDCL received \$153,129 in cash and non-cash donations exceeding \$5,000 in value between July 1, 2014 and December 31, 2014. Of these donations, \$130,180 qualified for matching funds. The funding source for the match is the Library Fund available prior year fund balance. The largest donation was \$28,000 from the Friends of the Encinitas Library.

SUBJECT: AMENDMENTS TO THE COUNTY CODE REGARDING FREE SPEECH AND COMMERCIAL ACTIVITIES AT COUNTY PARK AND RECREATION FACILITIES (6/9/2015 - FIRST READING; 6/23/2015 SECOND READING (DISTRICTS: ALL)

### **OVERVIEW:**

In May of 2014, the Waterfront Park opened for public use. Since its opening, the Waterfront Park has quickly become a major tourist and popular recreational attraction. The park has also become a desired location for individuals or groups to express their rights to free speech under the First Amendment of the U.S. Constitution. Persons interested in First Amendment expression are attracted to the most heavily used portions of the park, which includes the walkways and

recreation areas. These areas are also used by the public and County of San Diego employees to gain access to the County Administration Center to conduct civil and governmental services and by the public for recreational purposes. To ensure the continued safe and compatible use of the park and County Administration Center by all users, it is important to achieve a balance of the recreation/civic use of the Waterfront Park and the ongoing business use of the County Administration Center and free speech activities.

Today's item proposes amendments that will establish a process for free speech activities throughout the Waterfront Park, establish Free Speech Zones for First Amendment free speech activities that do not infringe on the County's significant government interests outlined in the ordinance, and provide for the issuance of advance permits to conduct First Amendment free speech activities in reserved areas outside Free Speech Zones. The proposed amendments will make it unlawful to enter a private event at the Waterfront Park without permission, and will establish a fine for the infraction. This action will also amend the County's ordinance that generally governs commercial and free speech activities in all other County parks and will address other issues such as commercial photography, noise levels, and the prohibition on posting or affixing materials on park property.

Today's request requires two steps. The first step will introduce the additions to County Code Sections 41.401 through 41.412 and amendment to Section 41.136 on June 9, 2015. If the Board takes action as requested, the second reading will occur on June 23, 2015.

### FISCAL IMPACT:

There is no fiscal impact associated with the approval of the proposed ordinance amendments. There will be no change in net General Fund costs and no additional staff years.

#### **OVERVIEW:**

The County has received a request from the California Municipal Finance Authority ("CMFA" or "Authority") to conduct a public hearing as required by the Internal Revenue code and to approve the Authority's issuance of revenue bonds, pursuant to a plan of finance, in an aggregate principal amount not to exceed \$9,000,000 (the "Bonds"), for the benefit of Affirmed Housing Group ("Borrower"), a nonprofit public benefit corporation and 501(c)(3) organization duly organized and existing under the laws of the State of California. The Borrower has applied for the financial assistance of the Authority in the financing of the acquisition, and equipping of multifamily rental housing projects located within the County of San Diego, California.

The Authority is authorized to assist in financing for nonprofit public benefit organizations wishing to issue revenue obligations, including the Borrower. In order to initiate such a financing, a member jurisdiction in which the Project resides, i.e., the County of San Diego, is being asked to: (1) conduct a public hearing to satisfy the public approval requirement of Section 147(f) of the Internal Revenue Code; and (2) approve the Authority's issuance of the Bonds. Although the Authority will be the issuer of the Bonds for the Borrower, the financing cannot proceed without the approval of the County of San Diego. Today's recommendations will provide the Authority with the required authorization to pursue its determination to issue the Bonds on behalf of the Borrower for the Project.

### FISCAL IMPACT:

If approved, the proposal will result in approximately \$1,000 of unanticipated revenue to be used to reimburse the County for costs associated with this non-County financing.

The Borrower will be responsible for the payment of all present and future costs in connection with issuance of the Financing. The County will incur no obligation of indebtedness as a result of these actions.

# SUBJECT: ESCONDIDO UNION SCHOOL DISTRICT GENERAL OBLIGATION BONDS, ELECTION OF 2014, SERIES A (DISTRICTS: 3, 5)

A special bond election was duly held in the Escondido Union School District ("District") on November 4, 2014, pursuant to Section 15100 and following of the Education Code of the State of California, for the purpose of submitting a measure ("Bond Measure") to the qualified electors of the District, authorizing the issuance of general obligation bonds in the aggregate principal amount of \$182,100,000 ("Authorization"), and more than 55% of the votes cast were in favor of the issuance of the Authorization.

The Board of Trustees of the District adopted a resolution ("District Resolution") on April 30, 2015 requesting the Board of Supervisors to authorize the issuance and sale of the Escondido Union School District (San Diego County, California) General Obligation Bonds, Election of 2014, Series A Bonds ("Bonds") in an aggregate principal amount not-to-exceed \$62,000,000. Proceeds from the Bonds will be used to repair/replace outdated classrooms/school buildings with safe, modernized facilities, improve student safety/campus security, keep technology infrastructure up-to-date in K-8 classrooms, science labs, libraries/computer systems, acquire, construct, repair classrooms, sites/equipment, provide all students with access to the education, facilities, and technology needs and to pay the costs of issuing the Bonds. The Bonds will be the first series of bonds issued under the Authorization, and after their issuance approximately \$120,100,000 of the Authorization will remain.

Today's recommendation will authorize the Treasurer-Tax Collector to enter into a Paying Agent Agreement with the District and to formally direct the Auditor and Controller to maintain the tax roll for the Bonds.

The Bonds will be general obligations of the District and will be paid from ad valorem property taxes levied within its boundaries, and do not constitute an obligation of the County.

# SUBJECT: SOUTHWESTERN COMMUNITY COLLEGE DISTRICT ELECTION OF 2008 GENERAL OBLIGATION BONDS, SERIES D (DISTRICT: 1)

A bond election was duly held in the Southwestern Community College District ("District") on November 4, 2008 approved by a vote of more than two-thirds of the qualified electors authorized the issuance of general obligation bonds by the District maximum principal in the aggregate amount of 389,000,000("Authorization"). Pursuant to the Authorization, on August 12, 2009 the District caused the issuance of \$100,000,000 General Obligation Bonds, Election of 2008, Series A and Series B on May 11, 2011, the District caused the issuance of \$79,750,000 General Obligation Bonds, Election of 2008, Series C, ("Prior Bonds").

On May 13, 2015, the District Board adopted a resolution authorizing the issuance and sale of subsequent series of bonds ("District Resolution") anticipated to be designated the "Southwestern Community College District (San Diego County, California) Election of 2008 General Obligation Bonds, Series D, or as designated in the related bond purchase contract, in the aggregate principal amount of not to exceed \$135,000,000 (the "Series D Bonds"). Proceeds from the Series D Bonds will be used to finance the improvement of certain facilities of the District as approved by the voters in the November 4, 2008 election. With the issuance of the Series D Bonds, approximately \$74,250,000 of the Authorization will remain for the issuance of additional series of bonds. Today's recommendation will authorize the Treasurer-Tax Collector to enter into a Paying Agent Agreement with the District and to formally direct the Auditor and Controller to maintain the tax roll for the Series D Bonds.

### FISCAL IMPACT:

The Bonds will be general obligations of the District and will be paid from ad valorem property taxes levied within its boundaries, and do not constitute an obligation of the County.
