BACKGROUND

The decisive action taken during the COVID-19 crisis by the State and many local governments, including the County of San Diego, has highlighted the need to address housing and homelessness in the long term.

Our County has taken a number of steps during the COVID-19 outbreak to address those who are homeless and at risk or ill. In partnership with the Regional Taskforce on the Homeless we have procured a number of hotel rooms for those who have no shelter to safely isolate if they are vulnerable, have symptoms, or have tested positive for COVID-19. In addition, we have partnered with the City of San Diego to open the San Diego Convention Center to create safe-distance shelter beds for those who have been in bridge shelters.

We call upon the leaders of the State of California to build upon the leadership they have shown during this crisis to create a statewide strategy, with adequate funding, to address the issue of homelessness in our state.
