On September 8, 2020, the District Board adopted a resolution to authorize the issuance and sale of one or more series of General Obligations Refunding Bonds ("Palomar Community College District 2020 General Obligation Refunding Bonds") in an aggregate principal amount not to exceed \$335,000,000 to refund all or a portion of the Series C Bonds and the 2015 Refunding Bonds.

Today's recommendation will authorize the Treasurer-Tax Collector to enter into a Paying Agent Agreement with the District and to formally direct the Auditor and Controller to maintain the tax roll for the Palomar Community College District 2020 General Obligation Refunding Bonds ("2020 Refunding Bonds").

ADOPT RESOLUTION TO SUMMARILY VACATE IRREVOCABLE OFFERS DEDICATION OF REAL PROPERTY (FEE TITLE) FOR PUBLIC SAFETY SERVICES <u>AND QUITCLAIM OF PROPERTY</u> IN THE EAST OTAY MESA AREA (VACATION NO. 2020-0152) (DISTRICT: 1)

OVERVIEW

The Asset Management Division of the Department of General Services is processing a request to summarily vacate Irrevocable Offers of Dedication (IOD) of real property in fee for Public Safety Services. The real properties are located in East Otay Mesa, an unincorporated area of the County that is within the Otay Community Plan Area. An offer of dedication of real property for public purpose may be terminated through summary vacation if the subject interest is unused and determined to be excess. In this case, the real properties subject to the IOD's have been unused since the IOD's were recorded in 2009 and are no longer needed for the originally intended public purposes. The termination of the IOD's through summary vacation will provide a benefit by removing the existing restriction on use of the real property allowing it to be put to productive use.

Today's request is for the Board of Supervisors to adopt a Resolution to summarily vacate the IODs which are unused and no longer required for the originally intended public safety and public fire purposes. The Board is also requested to authorize the Director, Department of General Services to quitclaim property in East Otay Mesa to its previous owner, as it is also no longer required for its originally-intended purpose.

RECOMMENDATION(S) CHIEF ADMINISTRATIVE OFFICER

- 1. Find the proposed vacation is not subject to review under the California Environmental Quality Act (CEQA) pursuant to State CEQA Guidelines section 15060(c)(2) and 15060(c)(3) because the action would not have a reasonably foreseeable direct or indirect effect on the environment and is not a project subject to CEQA review as it will only result in the summary vacation of public safety service fee parcels that are not, and independently the proposed vacation is categorically exempt under State CEQA Guidelines Section 15305 Minor Alternation in Land Use Limitations.
- 2. Adopt a Resolution entitled: RESOLUTION TO SUMMARILY VACATE IRREVOCABLE OFFERS OF DEDICATION OF REAL PROPERTY (FEE TITLE) FOR PUBLIC SAFETY SERVICES IN THE EAST OTAY MESA AREA (VACATION NO. 2020-0152).

FISCAL IMPACT

Funds for this request are included in the Fiscal Year 2020-21 Operational Plan in the Department of General Services. If approved, this request will result in estimated expenses of \$4,500 to process the proposed vacation. The funding source is an internal agreement with the San Diego County Fire Authority supported by tax levies collected in County Service Area 135 (CSA 135). There will be no change in net General Fund cost and no additional staff years.

16. SUBJECT: FISCAL YEAR 2020-21 APPROPRIATION LIMIT FOR THE COUNTY OF SAN DIEGO (DISTRICTS: ALL)

OVERVIEW

Each year, pursuant to Article XIII B: Government Spending Limitation of the California Constitution and Government Code Section 7910, the Board of Supervisors establishes its appropriation limit for the County of San Diego. Today's action requests adoption of a resolution establishing the County's Appropriation Limit for Fiscal Year 2020-21, calculated to be approximately \$6 billion. Only revenues from Proceeds of Taxes (property tax and certain state subventions) are subject to this limit. The County is substantially under the limit, having approximately \$2.2 billion of appropriations tied to Proceeds of Taxes that is subject to the limit in Fiscal Year 2020-21.

21. SUBJECT: NEIGHBORHOOD REINVESTMENT AND COMMUNITY ENHANCEMENT PROGRAM GRANTS (DISTRICT: 4)

OVERVIEW

The County of San Diego is fortunate to have an opportunity to reinvest taxpayer money into our communities for the benefit of the public. This action will assist the County in meeting the needs of the community.

RECOMMENDATION(S)

SUPERVISOR NATHAN FLETCHER

- 1. Allocate \$46,135 from the Neighborhood Reinvestment Program budget (Org 15665) to Alpha Project for the Homeless to fund the purchase of a passenger van for transportation and delivery of donations and essential items such as food and cleaning supplies to clients who are most at risk of COVID-19 exposure.
- 2. Allocate \$28,400 from the Neighborhood Reinvestment Program budget (Org 15665) to

 Horn of Africa to pay facilities rent, for the purchase of groceries for delivery to community

 members, food storage cabinets, refrigerators to store food for distribution, diapers, infant
 formula, and PPE to community members adversely impacted by COVID-19.
- 3. Allocate \$10,000 from the Neighborhood Reinvestment Program budget (Org 15665) to the San Diego Council on Literacy to close learning gaps caused by "COVID slide" by funding staffing and equipment for distributing books and learning materials.
- 4. Allocate \$26,000 from the Neighborhood Reinvestment Program budget (Org 15665) to the National Foundation for Autism Research for the purchase of PPE and sanitization supplies such as plexiglass partitions, hand-s free sanitizing stations, health-check stations, and air filtration and operating expenses such as staff salaries needed to safely re-open their training facility for vocational training programs.
- 5. Allocate \$25,000 from the Neighborhood Reinvestment Program budget (Org 15665) to Miracle Babies for purchasing a shuttle to expand their regional service shuttle service which is experiencing increased demand due to COVID-19 restrictions.
- 6. Allocate \$5,000 from the Community Enhancement Program budget (Org 12900) to Transfamily Support Services to provide support for San Diego youth and families, including COVID-19 technology investments to aid in their transition to a virtual environment so they can continue delivering services.

- 7. Allocate \$16,000 from the Community Enhancement Program budget (Org 12900) to the Flying Leatherneck Historical Foundation to provide funds to offset and support ongoing and additional operational requirements such as the need for PPE due to the COVID-19 closure and to support their volunteer development initiative to recruit, train and support a new cadre of volunteers who will aid in reopening under COVID-19 restrictions.
- 8. Allocate \$3,500 from the Community Enhancement Program budget (Org 12900) to Art FORM (Found Objects Recycled Materials) to fund art and environment distance learning kits to deliver art education and environmental stewardship during the COVID crisis.
- 9. Find that the grant awards described above have a public purpose.
- 10. Authorize the Deputy Chief Administrative Officer/Chief Financial Officer to execute grant agreements or amendments to existing agreements with the organizations awarded Neighborhood Reinvestment Program funds and Community Enhancement Program funds establishing terms for receipt of the funds described above and to make minor amendments to the agreements that are consistent with the general purpose of the grants but do not increase the grant.
- 11. Waive Board Policy B-72 to allow for the allocation of Neighborhood Reinvestment Program funds to organizations listed under Recommendation Nos. 2, 3, and 4 to the extent the Policy restricts support to non-profit corporations for rent and operating expenses such as staff salaries..

FISCAL IMPACT

The fiscal impact of these recommendations is \$24,500 from the Community Enhancement Program budget (Org 12900) and \$135,535 from the Neighborhood Reinvestment Program budget (Org 15665) totaling \$160,035. Funds for these requests are included in the Fiscal Year 2020-21 Operational Plan for the Neighborhood Reinvestment Program (Org 15665) and Community Enhancement Program (Org 12900). The funding sources are General Purpose Revenue and Transient Occupancy Tax Revenues. These actions will not result in the addition of staff years or other costs.

OVERVIEW

The San Diego County Small Business Stimulus Program provides grant funds to provide financial assistance to eligible, qualified small businesses and nonprofit entities to be used towards supporting public health and response activities associated with the COVID-19 pandemic.

RECOMMENDATION(S)

OVERVIEW

On April 21, 2020 the Board of Supervisors took action to implement the Business Recovery

Loan Program for the unincorporated area. \$5 million was allocated for the program, which is

being carried out through a partnership with the San Diego Foundation. Although this has been a

vital lifeline for many small businesses that are struggling, \$4 million is still available in the

program.

In light of the overwhelming need across the entire region and the significant amount of unallocated funds, access to this program needs to be broader than just the unincorporated area. Today's action authorizes the Chief Administrative Officer to negotiate and execute an Amendment with the San Diego Foundation to expand the Business Recovery Loan Program to eligible businesses within San Diego County.

RECOMMENDATION(S)

VICE-CHAIRMAN JIM DESMOND AND SUPERVISOR DIANNE JACOB

Authorize the Chief Administrative Officer to negotiate and execute an Amendment with the San Diego Foundation to expand the Business Recovery Loan Program to eligible businesses located within San Diego County.

OVERVIEW

The Asset Management Division of the Department of General Services is processing a request to summarily vacate Irrevocable Offers of Dedication (IOD) of real property in fee for Public Safety Services. The real properties are located in East Otay Mesa, an unincorporated area of the County that is within the Otay Community Plan Area. An offer of dedication of real property for public purpose may be terminated through summary vacation if the subject interest is unused and determined to be excess. In this case, the real properties subject to the IOD's have been unused since the IOD's were recorded in 2009 and are no longer needed for the originally intended public purposes. The termination of the IOD's through summary vacation will provide a benefit by removing the existing restriction on use of the real property allowing it to be put to productive use.

Today's request is for the Board of Supervisors to adopt a Resolution to summarily vacate the IODs which are unused and no longer required for the originally intended public safety and public fire purposes. The Board is also requested to authorize the Director, Department of General Services to quitclaim property in East Otay Mesa to its previous owner, as it is also no longer required for its originally-intended purpose.

RECOMMENDATION(S) CHIEF ADMINISTRATIVE OFFICER

FISCAL IMPACT

Funds for this request are included in the Fiscal Year 2020-21 Operational Plan in the Department of General Services. If approved, this request will result in estimated expenses of \$4,500 to process the proposed vacation. The funding source is an internal agreement with the San Diego County Fire Authority supported by tax levies collected in County Service Area 135 (CSA 135). There will be no change in net General Fund cost and no additional staff years.

BACKGROUND

The County of San Diego Fire Authority has requested a summary vacation of fee title IOD's for real property for Public Safety Service. The offered fee title properties are located in an unincorporated area of East Otay Mesa within the Otay Community Planning Area (Attachment A). The properties subject to the IOD's to be vacated by the proposed action are approximately 4.43 acres in size (Attachment B). These IOD's were made by the documents recorded in the Office of the County Recorder on September 29, 2009 as Doc. No. 2009-0540374, and Doc. No. 2009-0540375, both of Official Records. The properties have not been used since the IOD's were recorded in 2009, and the County staff have determined the properties are no longer needed for public purposes because the Sherriff and Fire facilities planned for these properties are now planned to be built elsewhere within the East Otay Mesa Specific Plan Area. This action would vacate only the subject fee title IOD areas, and no parcels would be land-locked by the proposed vacation.

The summary vacation of the IODs can be completed by Board approval and adoption of the attached, RESOLUTION TO SUMMARILY VACATE IRREVOCABLE OFFERS OF DEDICATION OF REAL PROPERTY(FEE TITLE) FOR PUBLIC SAFETY SERVICES IN THE EAST OTAY MESA AREA (VACATION NO. 2020-0152), attached as Attachment C.

Under the Act, the following findings must be made by the Board to approve the proposed summary vacation:

- 1. The real property subject to the IOD's has not been used for the purpose for which it was dedicated at any time since the IOD's were recorded in 2009, and such real property is determined to be excess and not required for public purposes because the Sheriff and Fire facilities planned for these properties are now planned to be built elsewhere within the East Otay Mesa Specific Plan Area. Therefore, the Board may find that the IOD may be summarily vacated pursuant to California Government Code section 7050 and California Streets and Highways Code section 8333.
- 2. Pursuant to California Streets and Highways Code section 8334.5, the Board is required to ensure that the vacation will not affect in-place public utility facilities. There are no in-place public utility facilities that would be affected by the proposed vacation.
- 3. Pursuant to California Streets and Highways Code sections 892 and 8314, consideration of the IOD areas for non-motorized transportation use must be reviewed before the vacation can be approved. The County's Department of Parks and Recreation has determined that the IOD area to be summarily vacated is not needed for trail purposes because there are no community adopted trails, or any pathways planned for this area in the Community Trails Master Plan.
- 4. Pursuant to California Streets and Highways Code section 8313 and California Government Code section 65402, the Board shall consider the General Plan prior to vacating a right-of-way. Staff from the County's Department of Planning & Development Services has reviewed the proposed summary vacation and determined that it is in conformance with the San Diego County General Plan.

The proposed summary vacation is in the public interest because it will remove encumbrances on private lands no longer needed by the public. The existing and planned public safety services will provide adequate public safety services for the area, and the summary vacation would remove restrictions that would otherwise preclude future development.

The Board is also requested to authorize the Director, Department of General Services to execute a quitclaim deed for APN 646-080-35, more particularly described in Attachment D. The County acquired this property for purposes of constructing the originally-contemplated fire station, and this property is no longer needed now that the fire station is proposed to be built elsewhere.

OVERVIEW

The County of San Diego is fortunate to have an opportunity to reinvest taxpayer money into our communities for the benefit of the public. This action will assist the County in meeting the needs of the community.

RECOMMENDATION(S) SUPERVISOR NATHAN FLETCHER

- 1. Allocate \$46,135 from the Neighborhood Reinvestment Program budget (Org 15665) to Alpha Project for the Homeless to fund the purchase of a passenger van for transportation and delivery of donations and essential items such as food and cleaning supplies to clients who are most at risk of COVID-19 exposure.
- 2. Allocate \$28,400 from the Neighborhood Reinvestment Program budget (Org 15665) to Horn of Africa to pay facilities rent, for the purchase of groceries for delivery to community members, food storage cabinets, refrigerators to store food for distribution, diapers, infant formula, and PPE to community members adversely impacted by COVID-19.
- 3. Allocate \$10,000 from the Neighborhood Reinvestment Program budget (Org 15665) to the San Diego Council on Literacy to close learning gaps caused by "COVID slide" by funding staffing and equipment for distributing books and learning materials.
- 4. Allocate \$26,000 from the Neighborhood Reinvestment Program budget (Org 15665) to the National Foundation for Autism Research for the purchase of PPE and sanitization supplies such as plexiglass partitions, hand-s free sanitizing stations, health-check stations, and air filtration and operating expenses such as staff salaries needed to safely re-open their training facility for vocational training programs.

- 5. Allocate \$25,000 from the Neighborhood Reinvestment Program budget (Org 15665) to Miracle Babies for purchasing a shuttle to expand their regional service shuttle service which is experiencing increased demand due to COVID-19 restrictions.
- 6. Allocate \$5,000 from the Community Enhancement Program budget (Org 12900) to Transfamily Support Services to provide support for San Diego youth and families, including COVID-19 technology investments to aid in their transition to a virtual environment so they can continue delivering services.
- 7. Allocate \$16,000 from the Community Enhancement Program budget (Org 12900) to the Flying Leatherneck Historical Foundation to provide funds to offset and support ongoing and additional operational requirements such as the need for PPE due to the COVID-19 closure and to support their volunteer development initiative to recruit, train and support a new cadre of volunteers who will aid in reopening under COVID-19 restrictions.
- 8. Allocate \$3,500 from the Community Enhancement Program budget (Org 12900) to Art FORM (Found Objects Recycled Materials) to fund art and environment distance learning kits to deliver art education and environmental stewardship during the COVID crisis.
- 9. Find that the grant awards described above have a public purpose.
- 10. Authorize the Deputy Chief Administrative Officer/Chief Financial Officer to execute grant agreements or amendments to existing agreements with the organizations awarded Neighborhood Reinvestment Program funds and Community Enhancement Program funds establishing terms for receipt of the funds described above and to make minor amendments to the agreements that are consistent with the general purpose of the grants but do not increase the grant.
- 11. Waive Board Policy B-72 to allow for the allocation of Neighborhood Reinvestment Program funds to organizations listed under Recommendation Nos. 2, 3, and 4 to the extent the Policy restricts support to non-profit corporations for rent and operating expenses such as staff salaries..

FISCAL IMPACT

The fiscal impact of these recommendations is \$24,500 from the Community Enhancement Program budget (Org 12900) and \$135,535 from the Neighborhood Reinvestment Program budget (Org 15665) totaling \$160,035. Funds for these requests are included in the Fiscal Year 2020-21 Operational Plan for the Neighborhood Reinvestment Program (Org 15665) and Community Enhancement Program (Org 12900). The funding sources are General Purpose Revenue and Transient Occupancy Tax Revenues. These actions will not result in the addition of staff years or other costs.

BACKGROUND

Alpha Project for the Homeless

Alpha Project for the Homeless is a human services organization that serves over 4,000 men, women, and children each day. Services offered include affordable housing, residential substance abuse treatment, supportive housing for people with special needs, basic and emergency services for the homeless, transportation assistance, mental health counseling, employment training, preparation and placement, emergency shelter, HIV/AIDS, education, outreach and prevention, and community services. Today's allocation of \$46,135 from the Neighborhood Reinvestment Program budget (Org 15665) to Alpha Project will fund the purchase a passenger van that will be utilized by these programs for transportation and the delivery of donations and essential items such as food and cleaning supplies to clients who are most at risk if exposed to COVID-19, and to assist clients with moving. A passenger van will allow these programs to continue providing services safely, especially critical now as they continue to respond to the current COVID-19 pandemic.

Horn of Africa

Horn of Africa promotes the successful integration and physical and emotional health of the East African refugee population in San Diego, the largest in California and second largest nationwide. In a typical year, they reach approximately 1,500 individuals with their services. Horn of Africa staff combine cultural and linguistic know-how with vast professional experience in social service delivery. Today's allocation of \$28,400 from the Neighborhood Reinvestment Program budget (Org 15665) to Horn of Africa will fund one-time expenses caused by the COVID-19 pandemic for Horn of Africa (HoA) and their community of low-income to impoverished African refugees/immigrants who are disproportionately affected by the virus with higher rates of contraction and death than other ethnicities. Many from this population work in the food and cleaning service industries which have been economically devastated by COVID-19. Refugees/immigrants in these industries constituted 20% of this workforce before the outbreak. The purpose of these funds are to help HoA pay rent, to provide food to community members, to purchase food storage cabinets/refrigerators for HoA to store food for distribution, diapers, infant formula, and PPE.

San Diego Council on Literacy

San Diego Council on Literacy's (SDCOL) mission is to unite the community to support literacy by documenting the state of literacy in San Diego, instilling the importance of literacy in the region, increasing the impact of services through coordinated community-scaled efforts, fill services gaps via initiatives and support SDCOL affiliated literacy programs, and to generate resources that support local literacy priorities. Today's allocation of \$10,000 from the Neighborhood Reinvestment Program budget (Org 15665) to SDCOL will support their partnership with their 30 affiliated programs and other partners to transcend social distancing to provide 106,000 new books to local, low-income children through food distribution programs,

breakfasts, and other avenues. 20% of low-income children who are out of school do not have connectivity to the internet. With the provision of books and other resources, potential learning gaps/"COVID-slide" will be minimized. With or without COVID-19, 60% of local low-income children, ages 0-5, have no books at home. SDCOL's expenses for this project relate to staffing for coordination, collection and promotion of online instructional programming, and book (heavy pallet) deliveries, and operational expenses for equipment, rentals, and manpower.

National Foundation for Autism Research

The National Foundation for Autism Research's (NFAR) mission is to help in the development, expansion and support of autism programs and services that improve the quality of life for individuals with autism. Today's allocation of \$26,000 from the Neighborhood Reinvestment Program budget (Org 15665) to NFAR will support their operations by purchasing PPE and sanitization supplies needed to safely re-open their training facility for vocational training programs. In light of extreme COVID-19 economic hardships (on-site cancellation of their annual fundraiser that accounts for 40% of their annual operating revenue and ongoing cessation of their vocational training programs for those with autism and reduced headcount), NFAR needs funds to stay operational and to purchase necessary PPE and sanitizing supplies needed to safely re-open their training facility. Needed PPE and sanitation supplies include plexiglass sheets and piping needed to assemble partitions, hands-free sanitizing stations, health-check stations, and air filtration to decrease possible virus spread. These expenditures would allow them to reopen their vocational training programs and get back to the business of helping those unemployed San Diegans with Autism Spectrum Disorder connect to meaningful employment.

Miracle Babies

Miracle Babies provides direct and supportive services to families who need to be with their critically ill babies in the neonatal intensive care unit (NICU), thereby reducing the babies' stress and changing health outcomes. Today's allocation of \$25,000 from the Neighborhood Reinvestment Program budget (Org 15665) will provide funds to purchase a vehicle for their special delivery program which enables parents to be united with their infants in the NICU. Their home to hospital shuttle service is provided to parents who exhibit barriers to transportation or are medically unable to drive. Providing transportation during those critical first days of a baby's life can dramatically impact the well-being of both the new mother and the baby, since it enables increased opportunities for the mother and NICU baby to be together for breastfeeding and kangaroo care.

Transfamily Support Services

Transfamily Support Services (TFSS) guides transgender/non-binary youth and their families through the gender transitioning process to help make it the most positive experience possible. They provide family coaching, assistance with healthcare and insurance issues, help navigate the legal system, and support at schools. All their services are provided at no fee. Today's allocation of \$5,000 from the Community Enhancement Program budget (Org 12900) to TFSS will provide funding that will be used to support TFSS's programming for Trans youth and their families, delivered virtually in the wake of COVID-19. They connect one-on-one and have stepped up their support group schedule in the face of increasing demand. It will also be used to assist with

COVID-19 specific technology investments. Their work includes outreach to SD County educators, professionals, and youth-serving nonprofits. With the transition to a virtual environment, TFSS has had to make unanticipated investments in technology (hardware and software) to deliver services.

Flying Leatherneck Historical Foundation

The Flying Leatherneck Historical Foundation (FLHF), through its support of the Flying Leatherneck Aviation Museum and its educational programs, preserves the history of United States Marine Corps aviation, honors military service and works to instill in all generations an appreciation of America's freedoms and the heroes who helped to protect those freedoms. Today's allocation of \$16,000 from the Community Enhancement Program budget (Org 12900) to FLHF will provide support to offset and provide for ongoing and additional operational requirements such as a need for PPE as a result of the COVID-19 closure. The funds will also support their Volunteer Development Initiative to recruit, train and support a new cadre of volunteers who will aid in reopening under COVID-19 restrictions. After recruitment, these volunteers will need to be trained with an upgraded engagement and management program. In 2019, they relied on more than 70 Foundation volunteers who donated more than 20,000 hours to the museum.

Art FORM (Found Objects Recycled Materials)

Art FORM's mission is to instill art education and environmental stewardship through creative reuse. They offer free workshops to eligible public Title 1 schools. Today's allocation of \$3,500 from the Community Enhancement Program budget (Org 12900) to Art FORM will fund art & environment distance learning kits which will deliver art education and environmental stewardship during the COVID-19 crisis through kits that launch hands-on activities and bridging gaps in learning. These kits engage art/science projects that connect under-served public school students to nature, climate changes, and animal habitat.

OVERVIEW

On April 21, 2020 the Board of Supervisors took action to implement the Business Recovery Loan Program for the unincorporated area. \$5 million was allocated for the program, which is being carried out through a partnership with the San Diego Foundation. Although this has been a vital lifeline for many small businesses that are struggling, \$4 million is still available in the program.

In light of the overwhelming need across the entire region and the significant amount of unallocated funds, access to this program needs to be broader than just the unincorporated area. Today's action authorizes the Chief Administrative Officer to negotiate and execute an Amendment with the San Diego Foundation to expand the Business Recovery Loan Program to eligible businesses within San Diego County.

SUBJECT: SAN DIEGO COUNTY BUSINESS RECOVERY LOAN PROGRAM (DISTRICTS: ALL)

BACKGROUND

On April 21, 2020 the Board of Supervisors took action to implement the Business Recovery Loan Program for the unincorporated area. \$5 million was allocated for the program, which is being carried out through a partnership with the San Diego Foundation. The program is limited to businesses with 50 or fewer employees, with a loan amount not to exceed \$50,000, an interest rate not to exceed 2% and a term not to exceed 2 years. San Diego Foundation is ensuring that all loans funded are covered by the State of California Small Business Loan Guarantee Program or comparable program. In addition, the Foundation will return at least 95% on defaulted loans and 100% on loans that are paid off no later than 30 months after the County contribution is distributed, minus any agreed upon administrative costs and fees.

To date, 27 businesses have received loans totaling \$872,000. Another four businesses are in the process of qualifying or closing for a total of \$125,500. Although this has been a vital lifeline to many small businesses that are struggling, \$4 million is still available in the program.

In light of the overwhelming need across the entire region and the significant amount of unallocated funds, access to this program needs to be broader than just the unincorporated area. Today's action authorizes the Chief Administrative Officer to negotiate and execute an Amendment with the San Diego Foundation to expand the Business Recovery Loan Program to eligible businesses within San Diego County.
