Today's Board action will express and acknowledge the sense of the Board that a lack of affordable housing is the primary driver of our homelessness crisis and further represents the greatest risk to the long-term economic health and prosperity of the region, and that the Board will support collaborative efforts with the City Council to increase the supply of affordable housing to meet and exceed the goal of 10,000 new units of affordable housing by 2030.

SUBJECT: JOINT ACKNOWLEDGEMENT OF THE IMPACTS OF THE LACK OF AFFORDABLE HOUSING IN SAN DIEGO AND DECLARING INTENT TO WORK TOGETHER TO SUPPORT INCREASING THE REGION'S AFFORDABLE HOUSING SUPPLY (DISTRICTS: ALL)

Many experts believe that a lack of affordable housing is the largest driver of homelessness (as opposed to substance abuse, mental health, domestic violence, general conditions of poverty, and other commonly associated factors), and a recent piece in the Union-Tribune highlighted this interconnection.

The topic of "a lack of affordable housing driving homelessness" will serve as this meeting's focus. This meeting will highlight the leading role that our housing market is playing in stifling economic growth, financially burdening middle, moderate and low-income families with expensive housing costs, and fueling the rise of homelessness in our region.

Government agencies can play a critical role in unlocking the potential of government-owned land. This discussion will focus on exploring initial findings from the San Diego Foundation's assessment of government-owned land in San Diego County.

The region needs well over 100,000 additionally housing units to address the local housing and homelessness crisis. Average rent in the City of San Diego is \$2,916 per month, with other cities in San Diego County not far behind. The region's lack of affordable housing limits job growth and economic potential as housing costs become prohibitive for many families and businesses. The crisis also disproportionately impacts Black, Indigenous, and People of Color (BIPOC), undocumented, tribal, and other vulnerable community members, including people with disabilities.

The lack of affordable housing in San Diego County has become a crisis, with our region slated to lose tens of thousands of affordable housing units over the next 20 years. The housing crisis makes the region increasingly unaffordable for low and moderate-income families who are becoming more at-risk of becoming homeless. There are approximately 4,800 people experiencing homelessness within the City of San Diego and 8,500 across our whole San Diego County.

This joint meeting of the Board and City Council will provide an opportunity to address these issues holistically and discuss actionable solutions that both entities can drive forward. This meeting will include consideration of a resolution to take cooperative action to address the affordable housing crisis.

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AND THE BOARD OF SUPERVISORS OF THE COUNTY OF SAN DIEGO TO FORMALLY EXPRESS THEIR INTENT TO TAKE JOINT ACTION TO INCREASE THE AVAILABILITY OF AFFORDABLE HOUSING IN OUR REGION CONSISTENT WITH THEIR RESPECTIVE AUTHORITY.

WHEREAS, there is a need for well over 100,000 additional housing units within our region to tackle our local housing and homelessness crisis; and

WHEREAS, the average rent in September in San Diego is \$2,047 a month; and the median rent for the City of San Diego is \$2,961 for a one-bedroom apartment; and

WHEREAS, many of our region's residents spend well over 30 percent of their income on rent; and many others have been priced out of their homes and neighborhoods; and

WHEREAS, due to a limited supply of homes, residents in neighborhoods across the region experience higher housing costs, overcrowding, and sub-par housing conditions; and

WHEREAS, the region's lack of affordable housing is limiting the region's job growth and economic potential as housing costs become prohibitive for many families and businesses; and

WHEREAS, the affordable housing crisis disproportionately impacts Black, Indigenous, and People of Color (BIPOC), undocumented, tribal, and other vulnerable community members, including people with disabilities; and

WHEREAS, there are approximately 4,800 people experiencing homelessness within the City of San Diego and 8,500 across our whole San Diego County; and

WHEREAS, the lack of affordable housing in San Diego has become a crisis, with our region slated to lose tens of thousands of affordable housing units over the next 20 years; and

WHEREAS, the San Diego region is increasingly unaffordable for low and moderateincome families, which means our region's residents are becoming more at-risk of becoming homeless; and

WHEREAS, to meet our housing goals, housing production must be accelerated at all income levels and it is imperative that San Diego County and the City of San Diego join forces to address the affordable housing crisis; and

WHEREAS, the San Diego region's vibrant, diverse neighborhoods are at risk if only the wealthy can afford to rent or own homes; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, that the Council of the City of San Diego and Board of Supervisors of the County of San Diego formally express their intent to take joint action to increase the availability of affordable homes in our region consistent with their respective authority by:

- 1. Supporting efforts to strengthen, streamline, and address permitting and other barriers to accelerating housing production.
- 2. Supporting efforts to build 10,000 affordable homes on government-owned land and maximize the community benefits on these properties, including alignment with transit lines, Climate Action Plan goals, and ensuring that construction creates goodpaying jobs.

- 3. Supporting efforts to leverage public, private, and other funds to accelerate affordable housing with the urgency it deserves.
- 4. Supporting the densification of the San Diego Housing Commission properties and further expanding our housing services in our region.

OVERVIEW:

The San Diego City Council and County Board of Supervisors are coming together to jointly acknowledge and address the region's top issue: the affordable housing crisis. The lack of affordable housing in our region is negatively impacting our economic growth and is the primary driver of our homelessness problem. The City and the County will commit, to working together on innovative and practical steps to help us realize 10,000 new units of affordable housing by 2030.

PROPOSED ACTIONS:

Adopt joint resolution, to the extent legally permissible by the body's respective authority and jurisdiction, that the lack of affordable housing is the primary driver of our homelessness crisis and further represents the greatest risk to the long-term economic health and prosperity of the region. The body will jointly resolve to continuing to work together to support increasing the supply of affordable housing to meet and exceed the goal of 10,000 new units of affordable housing by 2030.

DISCUSSION OF ITEM:

<u>Many experts believe</u> that a lack of affordable housing is the largest driver of homelessness (as opposed to substance abuse, mental health, domestic violence, general conditions of poverty, and other commonly associated factors), and <u>a recent piece in the Union-Tribune highlighted this</u> interconnection.

The topic of "a lack of affordable housing driving homelessness" will serve as this meeting's focus. and will highlight the leading role that our housing market is playing in stifling economic growth,

financially burdening middle, moderate and low-income families with expensive housing costs, and fueling the rise of homelessness in our region.

Government agencies can play a critical role in unlocking the potential of government-owned land. This discussion will focus on exploring initial findings from the San Diego Foundation's assessment of government-owned land in San Diego County.

The region needs well over 100,000 additionally housing units to address the local housing and homelessness crisis. Average rent in the City of San Diego is \$2916 per month, with other cities in San Diego County not far behind. The region's lack of affordable housing limits job growth and economic potential as housing costs become prohibitive for many families and businesses. The crisis also disproportionately impacts Black, Indigenous, and People of Color (BIPOC), undocumented, tribal, and other vulnerable community members, including people with disabilities.

The lack of affordable housing in San Diego County has become a crisis, with our region slated to lose tens of thousands of affordable housing units over the next 20 years.⁴ The housing crisis makes the region increasingly unaffordable for low_and moderate-income families who are becoming more at-risk of becoming homeless. There are approximately 4,800⁵ people experiencing homelessness within the City of San Diego and 8,500 across our whole San Diego County.⁶

The City Council and County Board of Supervisors will hear from a few experts within the field to provide information:

- 1. LeSar Development Consultants:
 - a. Overview of Homelessness and the Home Developmental Crisis Locally within San Diego.
- 2. Mark Stuart, San Diego Foundation
 - a. Presentation on GIS Mapping of Open Parcels to Develop for the County of San Diego and The San Diego Foundation's Housing Impact Fund. The inventory incorporates public lands under control and within the jurisdiction of the City of San Diego, the City of Chula Vista, and the County of San Diego, as well as excess state lands. The interactive web map allows one to investigate results, including key performance indicators. The visual quality, accessibility, and effectiveness at communicating key data are critical to the parcel map. The web-based map will be dynamic and allow one to visualize different layers of information for each site (e.g., flat, zoning, ownership, size, and undeveloped sites).
