San Mateo County Update

Pending Criminal Court Cases

Rainbow Bright case – filed Sept. 2018 (18CIV04759)

The defendants— Joshua, 42; Noel, 40; Gerlen, 38; and Carlina Gamos, 67 — were charged with a total of 59 criminal counts, including human trafficking and rape. The defendants targeted members of the Filipino community, many of whom were new to the United States, for labor exploitation. Over 50 victims.

De Los Reyes case – filed March 2019 (19NF004117B0

Maria Delosreyes, 45, and her husband Ricardo Delosreyes, 55, allegedly convinced a woman in her early 20s to move from the Philippines to their home in San Bruno on the promise of a job and a better life. The case spans from May 2009 to November 2015, when the victim talked to a coworker about what was happening, prosecutors said.

Castillo case – filed March 2020 (20NF004379A) Christopher Edward Castillo alleged sex trafficking of a female minor.

Cyntoia was trafficked as a teen and, at the age of 16, was arrested for killing a man who solicited her for sex. She was tried as an adult and sentenced to life in prison without the chance of parole for 51 years. Her trafficker was never arrested. Cyntoia's journey has included a Netflix documentary and a commuted sentence after receiving national and international support. She was released from prison on August 7, 2019.
