

2025 CONFERENCE FAQ

Q: Is the conference In person or Virtual?

A: BOTH! The Conference will be held July 8th through July 11th at the Beaver Run Resort in Breckenridge. All Regular Conference Sessions, Keynotes, and Presentations will be recorded and available for viewing for 90 days. The virtual option will NOT be lived streamed. Online Only attendees will have access to the recordings for 90 days after they are posted to the Attendee Hub. If you would also like access to the Pre-Conference Session Recordings, you must purchase the Pre-Conference + Regular Conference Package even if you are planning on not coming to the conference in person.

Q: Is there a Hybrid Option?

A: Yes! You can attend and few or as many conference days as you wish! Those who wish to attend ANY of the conference in Breckenridge must register for the In-Person Option! We are also hosting a Pre-Conference on Tuesday, July 8th. These are advance, intensive workshops presented by experts in the field.

Q: When is the deadline to register and pay?

A: Deadline to Register for the conference is June 30th, 2025. The deadline to pay your outstanding balance is June 30th, 2025. The Early Bird pricing will end on May 31st.

Q: Is the registration fee refundable?

A: No, there are no refunds if you don't attend the conference. All conference sessions will be available to view by all registrant for 90 days after the conference so you still be able to view the sessions (Pre-conference recordings will only be available to those that pay for the Pre-Conference).

Q: Can I switch my sessions at the last minute?

A: Yes, go to the event website, click on "Modify registration" and follow the prompts. You will also be able to change your sessions on the Conference Mobile App.



Q: When will you announce scholarship winners?

A: The submissions are due May 21, 2025, and the winners will be informed on May 22, 2025. Scholarship winners will still need to register for the conference by June 30th (they will be given a code to use at checkout). The Early Bird pricing ends on May 31st.

Q: Can I register a group of people for my agency?

A: Yes, once you register the first person in your group, on the Registration Summary page you will see button "Add a group Member". Click on that button and follow the same registration process. In the end you will see an Order Summary page with everyone's registrations, a place where you can pay for everyone at once.

Q: How will I get my certificate of completion?

A: In Person attendees will get certificates of completion through the Attendee Hub once the survey is completed, the hours will be added to your online certificate. At the end of the conference, you will receive ONE certificate of completion with all the sessions.

Recording Only attendees will need to register and stay in the session for a minimum of 75 minutes. Once that session is complete, you will receive a survey. When that is completed, you will receive ONE certificate of completion with all of the sessions

Q: Can I earn continuing education towards my SOMB and DVOMB provider status?

A: Yes, all sessions offered at the Conference can be used as training hours for SOMB and DVOMB approved providers.

Q: What fees am I being charged?

A: The cost of registration fee is \$490 for the In-Person Pre-Conference + Conference, \$375 for the In-Person Conference (No Pre-Conference), and \$375 for the Recording Only Option (these are not Early Bird Prices). If you pay with a credit card, there is a credit card processing fee of 3.95% which equals to about \$7.50. There is no processing fee if you pay by check. Early Bird Pricing will be available if you register by May 31st!
