

Tech Debt | eFORT Data Center Relocation FAQ

General Information

1. What is the eFORT Relocation Project?

This project will move all the services and physical equipment housed within the leased eFORT Data Center facility to the state-owned data center or the cloud by the end of 2024.

2. Why is OIT doing this?

The eFORT Data Center is one of the most expensive capital leases in the State's budget. As we strive to be good stewards of taxpayer dollars, we realized significant savings could be achieved by relocating hardware to the newly modernized state-owned or moving services to the cloud.

This work will eliminate the costly colocation lease, saving the state over \$1.5 million annually. It also reduces the state's data center footprint, consolidates individual agency usage and realigns associated funding toward more cost-effective (state-owned) data center options.

This shift encourages cloud adoption for existing workloads, positions workloads for cloud modernization opportunities, provides better management of physical assets and streamlines data center support.

3. Who is affected?

Practically every state agency is affected in some way. At the beginning of the project, 24 state agencies had physical or virtual equipment housed in the eFORT Data Center. All physical and virtual assets must be moved out of the data center.



4. When will this happen?

The final eFORT lease started in February 2022. It is a three-year lease ending on Jan. 31, 2025. The project team began migrations in January 2023. The project is scheduled for completion by the end of 2024.

5. How will it be completed?

The project team has focused efforts on several agencies at the same time. This allows them to minimize confusion, maximize output, and aim for quick wins. The project team has refined the migration process through previous agency migrations. The work is managed by the OIT server, network and network security teams following OIT standard protocol. OIT performs internal connectivity testing to ensure successful agency testing after the migration.
