NOTICE OF STAKEHOLDER MEETING ON THE GUIDANCE FOR REQUESTS TO DISTURB 50 ACRES OR MORE UNDER THE NPDES CONSTRUCTION STORMWATER PERMITS

The Georgia Environmental Protection Division (Division) has published a draft Guidance for Requests to Disturb 50 Acres or More under the National Pollutant Discharge Elimination System (NPDES) Construction Stormwater Permits. This notice is to announce that the Division will be holding a virtual stakeholder meeting on the draft guidance on **December 7**, 2023, and accepting public comments on the draft guidance through **December 15**, 2023.

The NPDES Stormwater Discharges Associated With Construction for Stand Alone Construction Projects (GAR100001) and for Common Development (GAR100003) (collectively, the NPDES Permits) each mandate that there be no more than 50 acres of disturbance at any one time unless the permittee has received prior written authorization from the appropriate Division District Office. The permittee for any such site must provide this information sufficiently in advance of disturbing 50 or more acres for the Division to evaluate the request and to determine what additional conditions may be applied to that activity. The draft guidance outlines the review criteria and specifies design components expected for such requests.

This requirement has been in the construction stormwater NPDES permits since 2008. Over time, the Division developed a process to evaluate these sites. This process was previously reflected in internal documents and correspondence between the Division and permittees. Due to an increase in requests to disturb 50 acres or more and requests from stakeholders, the Division is formalizing this process in this draft guidance document.
