You are hereby notified that the undersigned Board of Stewards is summarily suspending your license in accordance with 491 IAC 4.6(4). Effective immediately you are summarily suspended pending the Board of Stewards decision regarding your hearing. Under 491 IAC 4.47(17A), 491 IAC 4.47(1), you pose an immediate danger to the public health, safety, or welfare for the alleged violation of; 491 IAC 6.5(3)(i) & (p).

On June 16, 2022 the Board of Stewards received a report from the Department of Criminal Investigative Unit (DCI) and Prairie Meadows Security stating on June 15, 2022, James Hume was found to be in possession of multiple injectables, hypodermic needles and syringes on the backside.

491 IAC 6.5(3) Has been involved in any fraudulent or corrupt practices, including, but not limited to: 6.5(3)(i): Conduct in Iowa or elsewhere has been dishonest, undesirable, detrimental to, or reflects negatively on, the integrity or best interests of racing and gaming; 491 IAC 6.5(3)(p): Possessing any equipment for hypodermic injection, any substance for hypodermic administration, or any container designed to hold an injectable substance . . . by anyone other than a veterinarian licensed by the commission

You engaged in conduct in Iowa that has been dishonest, undesirable, detrimental to, or reflects negatively on, the integrity or best interests of racing and gaming. Based upon the totality of your alleged conduct and the sufficiency of the factual information submitted, a summary suspension of your license is warranted.

You will be notified in writing by the Board of Stewards regarding the date and time of your hearing. You are barred from participating in, or working at, any pari-mutuel racetrack or gaming facility licensed to operate in the state of Iowa.
