Judgment of Conviction

The Defendant, Ryan Nathaniel Greene personally appeared for sentencing on February 03, 2023, represented by Luke Andrew Hagelberg. The State of Idaho was represented by Daniel Rodriguez . District Judge Lamont C. Berecz presided. The Defendant was duly informed of the information filed against him and the Court earlier accepted a guilty plea and ordered the same entered for the crimes of:

JUDGMENT IS ENTERED

Judgment of Conviction. Defendant is sentenced, pursuant to I.C. § 19-2513, to the custody of the state board of correction to be confined for a period of time as follows:

COUNT 1: For the crime of Arson III-Burn Real, Personal Property or Forest Land a minimum fixed and determinate period of custody of 5 year(s) followed by an indeterminate period of custody of up to 5 year(s) for a total unified sentence not to exceed 10 year(s).

COUNT 2: For the crime of Arson III-Burn Real, Personal Property or Forest Land a minimum fixed and determinate period of custody of 5 year(s) followed by an indeterminate period of custody of up to 5 year(s) for a total unified sentence not to exceed 10 year(s).



COUNT 3: For the crime of Arson III-Burn Real, Personal Property or Forest Land a minimum fixed and determinate period of custody of 5 year(s) followed by an indeterminate period of custody of up to 5 year(s) for a total unified sentence not to exceed 10 year(s).

COUNT 4: For the crime of Arson III-Burn Real, Personal Property or Forest Land a minimum fixed and determinate period of custody of 5 year(s) followed by an indeterminate period of custody of up to 5 year(s) for a total unified sentence not to exceed 10 year(s).

COUNT 5: For the crime of Arson III-Burn Real, Personal Property or Forest Land a minimum fixed and determinate period of custody of 5 year(s) followed by an indeterminate period of custody of up to 5 year(s) for a total unified sentence not to exceed 10 year(s).

COUNT 6: For the crime of Arson III-Burn Real, Personal Property or Forest Land a minimum fixed and determinate period of custody of 5 year(s) followed by an indeterminate period of custody of up to 5 year(s) for a total unified sentence not to exceed 10 year(s).

Concurrent: The sentences in **COUNTS 1 through 6** shall run concurrent. The sentences in this case shall run concurrent with the sentence imposed in Bonner County Cases No. **CR2016-6780 and CR09-20-3361**.

FINES, FEES, COSTS AND RESTITUTION

Defendant is ORDERED to pay:

Count 1 Court Costs: \$ 245.50 Amounts due for fine and costs shall constitute a lien in like manner as a judgment for money in a civil action. I.C. §§ 19-2518, 19-2702.

Count 2 Court Costs: \$ 245.50 Amounts due for fine and costs shall constitute a lien in like manner as a judgment for money in a civil action. I.C. §§ 19-2518, 19-2702

Count 3 Court Costs: \$ 245.50 Amounts due for fine and costs shall constitute a lien in like manner as a judgment for money in a civil action. I.C. §§ 19-2518, 19-2702



Count 4 Court Costs: \$ 245.50 Amounts due for fine and costs shall constitute a lien in like manner as a judgment for money in a civil action. I.C. §§ 19-2518, 19-2702

Count 5 Court Costs: \$ 245.50 Amounts due for fine and costs shall constitute a lien in like manner as a judgment for money in a civil action. I.C. §§ 19-2518, 19-2702

Count 6 Court Costs: \$ 245.50 Amounts due for fine and costs shall constitute a lien in like manner as a judgment for money in a civil action. I.C. §§ 19-2518, 19-2702

Restitution is to Remain Open for 90 Days from date of Order.

CREDIT FOR TIME SERVED

The Defendant is given credit for time served on this case to date of this judgment (I.C. § 18-309) in the amount of:

Counts 1- 6: 169 days

ORDER FOR DNA SAMPLE AND THUMBPRINT IMPRESSIONS I.C. § 19-5507(2); ORDER FOR FINGERPRINT I.C. § 67-3004(6)

Defendant is incarcerated at the time of sentencing, or is being sentenced to the custody of the state board of correction and will be processed through RDU. Defendant, having been convicted of, or pled guilty to, a felony, is ordered to provide a DNA sample and right thumbprint impressions as required by I.C. § 19-5506.

RIGHT TO APPEAL/LEAVE TO APPEAL IN FORMA PAUPERIS

The Right: The Defendant has the right to appeal this judgment within forty-two (42) days of the date it is file stamped by the clerk of the court. I.A.R. 14(a).

In forma Pauperis: The Court further advised the Defendant of the right of a person who is unable to pay the costs of an appeal to apply for leave to appeal *in forma pauperis*, meaning the




right as an indigent to proceed without liability for court costs and fees and the right to be represented by a court appointed attorney at no cost to the Defendant. I.C.R. 33(a)(3); I.C. § 19-852(a)(1) and (b)(2).

ORDER OF COMMITMENT

Defendant is hereby committed to the custody of the BonnerCounty Sheriff, for delivery forthwith to the board of correction at the Idaho State Penitentiary, or other facility designated by the board of correction. I.C. § 20-237.
