

Idaho Constitution: Article IX § 7 and 8

Article IX section 7 of the Idaho Constitution established that "the State Board of Land Commissioners... shall have the direction, control, and disposition of the public lands of the state, under such regulations as may be prescribed by law."

Article IX section 8: "It shall be the duty of the State Board of Land Commissioners to provide for the location, protection, or rental of all the lands heretofore, or which may hereafter be granted to or acquired by the state by or from the general government, under such regulations as may be prescribed by law, and in such a manner as will secure the maximum long term financial return to the institution to which is was granted."

Idaho Department of Lands

Mission: To professionally and prudently manage Idaho's endowment assets to maximize long-term financial returns to public schools and other trust beneficiaries and to provide professional assistance to the citizens of Idaho to use, protect and sustain their natural resources.

Established under Idaho Code Title 58

Manage and generate revenue on 2.5 million acres for endowment beneficiaries

K-12 public schools is the largest endowment beneficiary

Revenue through timber sales and land leasing (grazing, minerals, comm sites, recreation, etc.)

Provide assistance to private landowners and partner with Fed agencies to address forest health

Regulate mining activities and enforce the Lake Protection Act and Forest Practices Act

Wildfire suppression responsibility on 9 million acres of state, federal and private timberlands

Wildland Fire Protection is a Big Part of What We Do...

- IDL cooperates with federal land management agencies and Fire Service Organizations to suppress fire (TPAs and RFPAs included).
- IDL protects nearly 9 million acres of state and private lands and some federal lands.
- Big focus for IDL is protecting state, industrial and private timberlands.
- Idaho Code 38-107, "Any forest or range fire burning out of control or without adequate and proper precautions having been taken to prevent its spread, is hereby declared a public nuisance, by reason of its menace to life and/or property"......the Department of Lands shall "summarily abate the nuisance thus constituted by controlling or extinguishing such fire".
- Fight fire aggressively, full suppression as long as its **SAFE** to do so.
- Maintain our success rate of keeping 95% of our fires to <10 acres.



Heyburn Boat Garages

Idaho Lake Protection Act I.C Title 58 Chapter 13

- Early in 2024, Idaho Department of Parks and Recreation announced that the 87 privately-owned boat garages that resided there would need to be removed in order to rebuild the marina at Heyburn State Park.
- IDL acted quickly to manage the relocation of the boat garages across navigable lakes.
 Garage owners at the park could apply for Temporary Permits with IDL so that they could remove and relocate the garages in a manner that adhered to IDL rules and statutes.
- IDL staff worked closely with Parks Department staff to coordinate inspections of all boat garages to ensure compliance.
- In less than two months, 68 garage owners have worked with IDL to receive Temporary Permits.
