Des Plaines Police responded to the 300 Block of Northwest Highway for the report of a gold Lexus on the Union Pacific railroad tracks. When the officer's arrived on scene it was learned that the Lexus being driven by the subject, Terence Langan, was northbound on Mt. Prospect Road and was intending to travel southeast on Northwest Highway when he misjudged the turn and turned instead onto the railroad tracks. Langan continued along the railroad tracks before the vehicle stopped. The original officer on scene located Langan inside the driver's seat along with a witness and commanded the subject to exit the vehicle due to incoming trains approaching their area. Langan refused to comply and was then physically pulled out of his vehicle not knowing whether the Metra trains were advised to stop. After Langan was removed, the officer noted that he appeared intoxicated and then Langan admitted to consuming alcohol prior to driving. Des Plaines Fire Department arrived on scene and treated Langan for minor injuries and then released to DPPD. Officer's on scene also noted there was an odor of alcohol emitting from Langan's breath and his eyes to be watery. Langan was taken into custody for suspected driving under the influence and transported to a safe and secure location, the Des Plaines Police station, where he was requested to perform Standardized Field Sobriety Tests. Upon completion, Langan showed visible signs of impairment and was also requested to provide a breath alcohol sample. Langan submitted and provided a breath sample of .122. Langan was subsequently arrested for Driving Under the Influence of Alcohol and DUI with a BAC Over .08 and also issued a citation for Improper Traffic Lane Usage.

Des Plaines Police responded to the 1000 Block of S Elmhurst Road regarding the report of a disturbance. When the officer's arrived on scene they spoke with two parties, one of which is the subject, Brigidio Gomez-Garcia, who advised they had gotten into a verbal argument at a nearby restaurant. Both parties admitted the altercation turning physical at which time Gomez-Garcia's information was run through the database yielding two warrants out of the DuPage County Sheriff's Department. Gomez-Garcia was made aware of the warrants and complied with being taken into custody without further incident. A search of his person resulted in finding a clear plastic bag with an unknown white powdery substance, suspected of being cocaine inside his wallet which was located in his pant pocket. When asked what the substance was, Gomez-Garcia admitted it was cocaine and that it was not his. Gomez-Garcia was transported to the Des Plaines Police station along with the white powdery substance which was then tested in a Narcotics Identification Kit. The result of that was positive for the probable presence of cocaine. The substance was then recovered as evidence. Des Plaines dispatch contacted DCSPD regarding the warrants. Gomez-Garcia was subsequently arrested for Possession of a Controlled Substance and possessing the above mentioned Warrants.

Des Plaines Police responded to the 3000 Block of S Des Plaines River Road for the report of an intoxicated subject, later identified as Ying Feng, who was refusing to leave the property. When the officer's arrived, they spoke with River's Casino security who advised that their attention was brought to a vehicle because the subject/Feng, was sleeping inside the vehicle for approximately an hour and a half. Security approached the vehicle and through the window observed Feng sleeping and what appeared to be vomit all over the car and his own jacket. Through surveillance it was learned that Feng never entered the business but instead remained in the parking lot. Due to the suspicion that Feng was intoxicated security decided to escort him to taxi boarding and attempted to convince Feng to take a taxi but he refused. The officer approached Feng himself who also noted what appeared to be vomit on his jacket and also the odor of alcohol emitting from his breath. Feng was yelling at security staff and appeared upset. Feng advised he could drive and self-administered different known field sobriety tests without the officer's requesting him to do so. The officer's and security again attempted to get Feng an alternative ride home but he still refused. At that time, the officer's advised Feng that if he was unwilling to accept a safe ride home and leave the property he would be considered trespassing. Feng refused and was then told he was under arrested and asked to place his hands behind his back. Feng refused and the officer's told him to stop resisting multiple times, to which he eventually complied. Feng was taken into custody without further incident and transported to the Des Plaines Police station. Feng was subsequently arrested for Criminal Trespass to Real Property.
