On Nov 15, 2021 at 3:30 a.m. Des Plaines Police responded to the 300 Block of S Westgate Road for the report of a domestic disturbance. The officer's arrived on scene and spoke with the victim who advised that during a verbal argument with the subject, Thomas Macnak, he grabbed her arms and hair and started shoving her around the room. The victim stated that the physical violence continued until Macnak then left the area. On Nov 23, 2021 the officer's responded back to the residence and Macnak was taken into custody without further incident. Macnak was subsequently arrested for Domestic Battery.
