Des Plaines Police were conducting traffic enforcement in the area of Oakton Street and Mt. Prospect Road when they observed a white Ford pick-up with a female subject, later identified as Stephanie Cornell, using a handheld electronic device while driving. The officer provided dispatch with the license plate after he began to follow the pick-up and activated his overhead emergency lights effectively curbing the vehicle. After approaching the vehicle and speaking with Cornell, the officer requested her information and advised of the reason she was being stopped. Dispatch informed the officer after he had given them Cornell's information that she did not have a valid driver's license, said license was revoked by the Illinois Secretary of State. Additionally, dispatch advised that the current registration for the pick-up was suspended. At that time, Cornell was informed of the above information and taken into custody. After being transported to the Des Plaines Police station, Cornell was subsequently arrested for Driving While License Revoked and Operation of a Motor Vehicle with Suspended Registration while also being cited for the Use of Electronic Communication Device on a Roadway.

Des Plaines Police responded to the 1600 Block of Henry Avenue for the report of a domestic battery. While en route, dispatch advised the officers that the subject, Erasmo Ramirez, was armed with a knife after having been in a physical confrontation with the victim. When the officers arrived, they learned that the victim and Ramirez had engaged in a verbal dispute that lead to Ramirez punching the victim several times. Ramirez at one point grabbed a kitchen knife and threatened the victim with it as well. Ramirez appeared at the front door briefly and was taken into custody without further incident. After being transported to the Des Plaines Police station, Ramirez was subsequently arrested for Domestic Battery, Aggravated Assault and Criminal Damage to Property.

On March 10, 2022 Des Plaines Police responded to the 700 Block of W Dulles Road regarding the report of a home invasion. While the officers were on scene, they learned that the subject, Edgar Pedraza-Perez, had threatened the victim via text message and later entered her residence by forcing open the door, causing damage to the frame. One of the pieces flew off the frame and struck the victim. Once Pedraza-Perez was inside the residence he grabbed the victim's arms however, she was eventually able to break free and run away. After the victim fled from her own residence she called 9-1-1 and waited for officers to arrive. The officers conducted a search of the residence, later learned that Pedraza-Perez fled eastbound Dulles Road prior to their arrival. Additional property within the residence had been damaged as well. The incident was then assigned to the Detective Bureau for follow up investigation.

On March 29, Detectives went to the 800 Block of College Boulevard in Addison in the attempt of locating Pedraza-Perez. The Detectives were successful and upon making contact with Pedraza-Perez took him into custody and later transported him to the Des Plaines Police station. While running Pedraza-Perez' information through the database, the Detectives were made aware of two outstanding warrants, one with the Addison Police Department and the other with the DuPage County Sheriff's Department. Once at the station and due to the nature of the crime, the Cook County State's Attorney's Office was contacted and later approved a felony charge. Pedraza-Perez was subsequently arrested for one felony count of Home Invasion as wells misdemeanor charges for Domestic Battery and Criminal Damage to Property and two counts of the possession of said Warrants.
