NOTEWORTHY INCIDENTS:

On September 14, 2021 Des Plaines Police responded to the 400 Block of Stratford Road for the report of a residential burglary. When the officers arrived on scene, they spoke with the victims who stated that an unknown male subject knocked on the front door of the residence and was then directed to the inside rear of the house. The male subject advised he worked for ComEd and needed to fix cables in the backyard due to a fire in the neighborhood. During this time, it was believed a second unknown subject entered the residence and stole a safe from one of the rooms within the house. At the time, an evidence technician processed the scene and collected samples from around the house and the investigation was turned over to the Detective Bureau for follow up.

During the course of the next several months, a DNA sample that was submitted to the Illinois State Police Crime Lab came back positive for the above subject, Leo Ely. On October 11, 2022 Des Plaines Police Detectives were contacted by the Glencoe Police Department in reference to Ely. GPD advised they had Ely at the station when DPPD then traveled to them and took custody of him. After transporting Ely back to DPPD, the Cook County State's Attorney's Office was contacted who approved felony charges on him. Ely was subsequently arrested for one felony count of Residential Burglary and was transported to the courthouse for bond hearing the following day.

Des Plaines Police responded to the report of a battery in the 2100 Block of E. Touhy Avenue where it was reported that the female victim had visible bruising on her person. When the officers arrived, they spoke with the caller who stated that she heard screaming coming from room registered the victim and the subject, Brahyan Melendez. In addition, another party also advised that the victim admitted to being struck by Melendez. While speaking with the victim she stated that her and Melendez are in a relationship and an argument ensued on October 10, 2022. During the argument, Melendez reportedly kicked, pushed and hit the victim multiple times. Melendez was taken into custody and transported to the Des Plaines Police station where he was given his Miranda Warnings. After doing so, Melendez agreed to provide the officers with a statement where he provided different accounts of what happened before saying that the victim was the aggressor. There were no markings on Melendez to verify his version of the events. Melendez was subsequently arrested for Domestic Battery and transported to the courthouse for bond hearing the following day.
