NOTEWORTHY INCIDENTS:

OFFENSE: Theft

LOCATION: 700 Block of S. Des Plaines River Road

The Unknown Offender(s) entered the common area of a building in the 700 Block of S. Des Plaines River Road and stole the victims package that was delivered on January 25, 2023. The victim reported that after delivery, she checked the area and was unable to find the items.

The victim and Unknown Offender were both northbound on Elmhurst Road traveling from Oakton Street in the inside lane when the offender struck the victim's rear bumper. After the accident, the victim exited his vehicle to speak with the driver of the offending vehicle when instead she fled north on Elmhurst Road without providing information. The victim describes the offender as a black female driving a grey Ford Fusion.

Due to the recent increase in crime happening at the YMCA building located at 300 E. Northwest Highway, the following are reported incidents at that location:

On February 14, 2023, Des Plaines Police responded to the 800 Block of E. Oakton Street for the report of a hit and run accident. While the officers were on scene investigating the incident, they learned that the offending vehicle was a white Lincoln MKX being driven by the subject, Michael Angsten. After speaking with the victim, it was determined that the victim's vehicle was parked facing eastbound in the parking lot while the white Lincoln MKX sideswiped the passenger side with his front drivers side. After the accident, the Lincoln fled the scene with a heavyset male white driver with a dark hooded sweatshirt. The victim stated that Angsten lives in the area and after speaking with a member of the residence, it was verified that Angsten does in fact drive a white Lincoln SUV however, he was not home at the time.

On February 15, two officers on patrol in the area of Oakton Street and Cora Street when a white Lincoln MKX was seen driving westbound on Oakton Street. The officers noted visible damage to the front driver's side consistent with the damage from the accident the day before. The officers believed the vehicle to be the offending vehicle from the incident and activated their overhead emergency lights effectively curbing the vehicle near Webster Lane and Everett Avenue. The officers approached the driver's side and identified the driver as Angsten and informed him that he was seen leaving the scene of an accident the day before. The officers asked Angsten to step out of the vehicle, to which he complied, and was taken into custody. Angsten was transported to the Des Plaines Police station where he was given his Miranda Warnings. Angsten provided a statement to the officers that he was involved in an accident and did leave the scene.

Angsten was subsequently arrested for Failure to Notify Damage to an Unattended Vehicle. After posting the required bond, Angsten was released from the station and provided his court information.

Des Plaines Police responded to the 400 Block of S. Des Plaines River Road for the original report of an unwanted subject. Des Plaines Dispatch informed the officers that a male black subject wearing a grey hooded sweatshirt and white pants was not wanted on the property anymore. The complainant also stated that they had the same issue with the same subject the day before and wanted the subject advised he was no longer welcome to come into the

business. Prior to the officers arriving on scene the subject left the area and was unable to be located at that time. However, while the officers were in the area, Dispatch advised of that a second business nearby was reporting the same subject was at that location and was yelling profanities at the complainant causing him to be alarmed and disturbed. The officers located the subject in the 1500 Block of Ellinwood Avenue and attempted to make contact with him. As the officers called to him, the subject ignored the officers and continued to walk away from them. The subject was advised of the incident and taken into custody without further incident and identified as the above, Trevaughn Adams. Adams was transported to the Des Plaines Police station where he refused to provide a statement and was subsequently arrested for Disorderly Conduct. After posting the required bond, Adams was released from the station and provided with his court information.

Des Plaines Police responded to the report of a disturbance in the 700 Block of Fifth Court where the above subject, Lamont Williams, was said to have been kicking the victims door. Williams was described as a male subject with a red hat and as officers were responding, fled the area. The officers arrived on scene and located Williams, who matched the provided description, walking south on Fifth Avenue near Greenview Avenue. Further investigation of the incident resulted in finding that Williams had kicked the front door approximately three to four times causing damage after engaging in a verbal dispute with the victim. Williams was taken into custody and transported to the Des Plaines Police station where he was read his Miranda Warnings and provided a statement admitting that he had kicked the door. Williams was subsequently arrested for Criminal Damage to Property and was brought to the Cook County Courthouse in Skokie, IL the following day for a bond hearing.

The victim stated that Vargas had confronted him and then began punching him several times. Vargas admitted to being in the physical altercation and that he was the first to strike the victim. Vargas was taken into custody and transported to the Des Plaines Police station where he was subsequently arrested for Battery. After posting the required bond, Vargas was released from the station and provided his court information.
