On 10/01/2023 at 8:12 p.m. a Des Plaines officer was working the front desk at the police station when a female walked in to report she was the victim of a domestic battery. She relayed that around 1:00 p.m. she got into a verbal argument with subject/ Vazquez, Reyes. The argument escalated at which time Vazquez pushed her down onto the bed and straddled her and pinned her arms down. The victim was eventually able to free her arm and struck Vazquez. This made him angry so he struck the victim in her eye. The victim was able to get up and attempted to pack some belongings to leave. The victim was then pushed down again by Vazquez who again straddled her and placed his hands are her neck. The victim was again able to get away and attempted to leave the residence however Vazquez blocked the door. During the above incident Vazquez also took the victim's cell phone from her. The victim then left the scene in her vehicle and was followed by Vazquez. Another argument ensued outside of the vehicles and Vazquez destroyed the victim's cell phone. The victim then went to the police station to report the incident. On 10/13/2023 Des Plaines Police Department Detectives went and took Vazquez into custody in Chicago and transported him back to Des Plaines. A search of Vazquez's information also showed him to have an active warrant out of the Illinois Department of Corrections. Vazquez was subsequently arrested for Domestic Battery, Interference with Reporting Domestic Violence, Criminal Damage to Property and the Warrant. He was transported to the Cook County Courthouse for a detention hearing.

A Des Plaines officer was on patrol in a mark squad car when he observed a vehicle fail to properly use their turn signal and also disobey a stop sign. He conducted a traffic stop on the vehicle and upon approaching the driver he detected a strong odor of cannabis emitting

from inside the vehicle. The officer requested the driver, later identified as subject/Orozco, Christohper, to exit the vehicle which he did. When the officer inquired about the cannabis, Orozco admitted he had things inside of a backpack in the car as well as a firearm. At this time Orozco was placed in custody and into a squad car. A search of the vehicle yielded a firearm underneath the driver's seat with a loaded magazine and no serial number. In a backpack in the rear of the vehicle there was approximately 504 grams of green leafy substance suspected to be cannabis separated into separate bags. Orozco was transported to the Des Plaines Police Station where he was provided with his Miranda Warnings. Orozco stated he understood his rights and waved them agreeing to speak with officers where he admitted to the firearm being his. Due to the nature of the charges the Cook County State's Attorney's Office was contacted and they approved 2 felony counts of Aggravated Unlawful Use of a Weapon. Orozco was also charged with Possession of Cannabis more than 500 grams, Manufacture, Deliver, Possess with Intent to Deliver Cannabis more than 500 grams, Unlawful Possession of Firearms and Ammunition and Prohibition on Unserialized Firearms. He was also cited for Improper Stop or Turn Signal, Disregard Stop Sign and Operation of Uninsured Motor Vehicle. Orozco was transported to the Cook County Courthouse for a detention hearing.

While speaking with Sapp the officer observed she had bloodshot watery eyes and an odor of alcohol emitting from her breath. Sapp denied consuming alcohol prior to driving however she admitted to smoking marijuana from a vape which was located inside of her vehicle. The officer requested Sapp to submit to Standardized Field Sobriety Tests but she refused. Sapp was taken into custody at this time and transported to the hospital for further chemical testing. She was then transported to the Des Plaines Police Station. It was

Des Plaines officers responded to the initial report of a hit and run crash that occurred in the area of Wolf Road and Seegers Road. The victim of the crash called 9-1-1 and relayed he was traveling north on Wolf Road when he was rear ended by a vehicle, the vehicle was fleeing the scene and he was still following the vehicle. The driver of the offending vehicle was later identified as subject/ Block, Austin. Block then struck a traffic sign in the area of Northwest Highway and State Street. He continued on and in the area of Graceland Avenue and Ellinwood Street, he struck a landscaping structure before finally coming to a stop. The officer ordered Block out of his vehicle and was he was placed in handcuffs. While speaking with Block the officer detected an odor of alcohol emitting from his breath. Block agreed to submit to Standardized Field Sobriety Tests and upon completion of the tests, Block showed visible signs of impairment. At the Des Plaines Police Station Block agreed to submit to further chemical testing which showed a blood alcohol concentration of over twice the legal limit. Block was subsequently arrested for Driving Under the Influence of Alcohol, DUI with a BAC over .08 and Failure to Remain at the Scene of a Vehicle Damage Accident. He was also cited for Fail to Reduce Speed, Improper Lane Usage, Operation of Uninsured Motor Vehicle and Improper Turn. She was subsequently arrested for Driving on a Revoked License and Obstructing Identification. She was also cited for Illegal Transportation of Open Alcohol. She was released from the station and provided a Notice to Appear with her court information.
