### NOTEWORTHY INCIDENTS:

**OFFENSE:** Burglary from Motor Vehicle

The victim's GMC Acadia was parked on the roadway in the 500 Block of W. Kathleen Drive during the above time frame when the Unknown Offender(s) entered and stole the victim's purse. There were no visible signs of forced entry to the vehicle and the purse was located on the front passenger seat at the time of the theft.

On October 27, 2023, the victim reported to the Des Plaines Police station that the subject, Annette Eck, had violated an order of protection. The victim stated, and was later confirmed, that the order of protection was issued and served to Eck on October 13, 2023, advising she is to have no communication with the victim. On November 30, Eck came into the station to turn herself in. At that time, Eck was escorted into a secure area of the station and subsequently arrested for Violation of an Order of Protection and later brought to a Cook County Courthouse for a detention hearing.

Des Plaines Police were dispatched to Touhy Avenue and Lee Street for the report of a hit and run accident. When the officers arrived, they observed a Jeep Wrangler in the intersection with a male standing near it who had stated that he was westbound on Touhy Avenue in the intersection when a grey Nissan Sentra ran the red light northbound on Lee Street and caused a collision. The Nissan continued north on Lee Street and parked on the east side of the road. A male subject was seen exiting the driver's seat followed by a young female. Both fled west into the Lake Park area off of Touhy Avenue.

Approximately one hour later, the officer had received a phone call at the Des Plaines Police station from the above subject, Yazmin Pacheco, admitting to being in the accident. Pacheco was asked and agreed to come into the Des Plaines Police station. Once at the station, Pacheco admitted to driving the vehicle when it was involved in the accident. During the interview, Pacheco was unable to provide details of the accident including any about the other vehicle involved. When officers had previously searched the Nissan, a backpack and a debit card not belonging to Pacheco were located indicating to officers that Pacheco was not the driver at the time of the accident and that she being untruthful in her statement. Pacheco was subsequently arrested for Obstructing a Peace Officer. Pacheco was cited and released with her court information.

Des Plaines Police were on patrol in the 100 Block of S. Wolf Road when an officer observed a blue BMW 550i traveling at a high rate of speed. The officer observed that the BMW was traveling more than 40 MPH over the designated speed limit. After pulling behind the BMW and observed it make an improper lane use, the officer activated his overhead emergency lights and curbed the vehicle. While speaking with the driver/subject, Sayyid Quadri, the officer advised him of the violation and asked him to exit the vehicle. Upon doing so, the officer took Quadri into custody and transported him to the Des Plaines Police station where he was subsequently arrested for one misdemeanor count of Speeding 40 MPH Over the Posted limit and ticketed for Improper Lane Usage. Quadri was cited and released with his court information.

On November 30, 2023, at 11:19 p.m. Des Plaines Police responded to the Rivers Casino located in the 3000 Block of S. Des Plaines River Road for the report of an intoxicated subject in a Dodge Caravan attempting to drive on the third floor of the parking garage. When the officers arrived on scene, they located a blue Dodge Caravan on the third floor that was pulling out of a parking space. The officer activated his overhead emergency lights and blocked the vehicle from exiting. Upon approaching the driver's side window, the officer smelled a strong odor of alcohol emitting from the subject, Stavroula Kritikos's, breath. Kritikos admitted to consuming alcohol inside the business and was then asked to exit her vehicle and suggested she use a taxi to leave. Kritikos initially agreed to do so but while exiting the vehicle, became agitated and confrontational, stating she wanted to hit the officer and even attempted to grab his hat. Throughout the officer and Kritikos' interaction, Kritikos displayed changing moods and at one point requested an ambulance. The Des Plaines Fire Department was then called to the scene and Kritikos was provided a safe ride to an area the ambulance could respond to. When DPFd arrived on scene, Kritikos refused medical treatment and was again asked to leave the casino using a taxi or ride share. Kritikos agreed and was advised she was no longer allowed on the property and any further incident would be trespassing.

On December 1 at 12:33 a.m., officers were again called to the casino regarding Kritikos returning to the business and was now out with security representatives. The officers responding located Kritikos and issued her a city ordinance ticket for Trespassing and

again asked her to leave. Kritikos stated she would not leave and was then advised that she was being taken into custody for the violation. Kritikos tensed her arms and refused to comply with the officers' requests to place her hands behind her back. When the officers attempted to handcuff Kritikos, she would pull her arms away from them. Eventually, officers were able to handcuff Kritikos and place her in the back of a patrol squad where she was then transported to the Des Plaines Police station. Kritikos was subsequently arrested for one misdemeanor count each of Criminal Trespass to Real Property and Resisting a Peace Officer. Kritikos was cited and released with her court information.
