NOTEWORTHY INCIDENTS:

OFFENSE: Hit and Run Accident

The victim and the Unknown Offender were southbound in the 1600 Block of Elmhurst Road traveling in the center lane. The victim attempted to change into the left lane when the offender made a quick lane change also into the left lane and sped up striking the victim's driver's side quarter panel. After the accident, the offender fled south in a silver Volkswagen sedan.

Des Plaines Police responded to the 1700 Block of E. Oakton Street for the report that a female subject may be breaking into cars in the back parking lot. The caller advised that the female was in or near a blue Buick Enclave and was screaming while banging on cars. When the officer arrived, he located the female subject, later identified as Bridget Maguire, who started yelling and then walk south through the parking lot away from the officer. The officer verbally advised Maguire to stop so he could investigate the reason she was screaming. Maguire continued to yell and then turned towards the officer and walked directly up to him touching his chest. Maguire refused to create space between herself and the officer, so the officer pushed her slightly back with one of his fingers when she again started yelling and walking away from the officer. Maguire was ultimately detained pending the investigation into the incident. During this time, Maguire refused to provide her name or date of birth however, the officer had recognized her from a previous call and identified her.

The officer then spoke with the victim who stated that she lives in the apartment complex the parking lot is attached to when her and her family were woken up by Maguire yelling and banging on a vehicle. The screaming was in close proximity to where the victim lives and members of the household have had dealings with Maguire in the past causing her to be alarmed at Maguire's actions on this night. Maguire was advised of the incident when she then requested an ambulance to respond to the scene for a previous injury. DPFDP arrived on scene and transported Maguire to a local hospital for non-life-threatening injuries and she was subsequently arrested for one misdemeanor count each of Disorderly Conduct and Obstructing a Peace Officer. Maguire was cited and released with her court information.

Des Plaines Police were on patrol in the area of Golf Road and Mount Prospect Road when the officer heard a scream from a female on the northwest corner of the intersection. The female was seen knocking on the front door to the business in the 0-100 Block of W. Golf Road and when approached by the officer, she stated that a subject had struck her with a car. The victim's clothes were wet and disheveled showing signs of an incident occurring, so the officer asked the Des Plaines Fire Department to respond to the scene. The victim was later transported to a local hospital for non-life-threatening injuries. While investigating the incident, the officer learned that the victim had met the subject, Jose Roldan Vazquez, on a dating app in a parking lot across the street. Once both parties were in the parking lot, the victim entered Roldan Vazquez' white Ford SUV and they drove away from the area. Shortly after returning to the parking lot, a verbal argument ensued, and the victim exited the vehicle to get away from Roldan Vazquez. Shortly after that, Roldan Vazquez drives his vehicle towards the victim causing her to fall to the ground. Officers were able to locate a home address of Roldan Vazquez in Mount Prospect and upon checking the area, located and then took Roldan Vazquez into custody. Additional officers checked the area for surveillance from nearby businesses and located one showing the white SUV striking the victim. Due to the nature of the incident, the Cook County Sheriff's Police Department was contacted and approved felony charges. Roldan Vazquez was subsequently arrested for one felony count each of Aggravated Battery and Failure to Report a Personal Injury Motor Vehicle Accident; and ticketed for the Operation of an Uninsured Motor Vehicle. Roldan Vazquez was later brought to a Cook County Courthouse for a detention hearing.

Des Plaines Police were on patrol in the area of Oakton Street and Webster Lane when the officer observed a beige Toyota Corolla driving west on Oakton Street. The officer ran the license plate number on the rear of the vehicle and noticed that the registration came back to a blue Toyota and the registration was also suspended. After activating the overhead emergency lights and curbed the vehicle in the 1500 Block of S. Fifth Avenue and approached the driver's side where the officer met the subject, Angel Ruiz. Ruiz

was informed for the reason of the traffic stop and asked for his driver's license and proof of insurance, neither of which he was able to produce. The officer obtained Ruiz' information and ran him through the database when he was alerted that Ruiz did not have a valid driver's license, said license was suspended by the Illinois Secretary of State. Ruiz was able to provide the registration form for the vehicle, but the officer noted the Vehicle Identification Number was different on the paperwork from the vehicle that he was currently driving. At that time, Ruiz admitted to using another vehicle's license plates since his were not valid. The officer requested Ruiz exit the vehicle where he was taken into custody and transported to the Des Plaines Police station. Ruiz was subsequently arrested for one misdemeanor count each of Unlawful Possession of Title or Registration Documents, The Operation of a Motor Vehicle When Registration is Suspended, and Driving While Driver's License is Suspended; and ticketed for the Operation of an Uninsured Motor Vehicle. Ruiz was cited and released with his court information.

Des Plaines Police responded to the 100 Block of S. Wolf Road for the report of a single vehicle accident. A caller stated that the driver of the vehicle was possibly intoxicated and was attempting to leave the scene. When the officers arrived on scene, they spoke with a witness who stated he observed the gray Honda CR-V traveling east on Golf Road at a high rate of speed and while navigating the turn, struck the curb and exited the roadway, drove onto the center median at the intersection with Seegers Road and then come to a rest on the parkway in the 100 Block of S. Wolf Road. An additional officer made contact with the driver of the Honda, subject Jargalmaa Ganbayar, who stated she was driving home and that nothing had happened. While Ganbayar spoke, the officer noticed that she appeared confused and was unable to tell the officer where she was coming from, her speech was slurred, and her eyes were watery/bloodshot. A strong odor of alcohol was emitting from Ganbayar's breath when she spoke, and she admitted to consuming alcohol prior to driving when asked by the officer. Ganbayar was asked to perform Standardized Field Sobriety Tests, to which she agreed, and upon completion showed visible signs of impairment. Ganbayar was taken into custody and transported to the Des Plaines Police station where she was also asked to provide a breath alcohol sample. Ganbayar agreed and provided a sample reading over two times the legal limit and was subsequently arrested for one misdemeanor count each of Driving Under the Influence of Alcohol and DUI with a BAC Over .08; ticketed for Improper Lane Usage and the Operation of an Uninsured Motor Vehicle. Ganbayar was cited and released with her court information.
