NOTEWORTHY INCIDENTS:

OFFENSE: Criminal Damage to Vehicle

The victim's Toyota sedan was parked on the roadway in the 1000 Block of East Grant Drive when the Unknown Offender(s) smashed the rear driver's side window. The window was smashed by an unknown object, and it did not appear that entry was made to the vehicle as nothing was missing or disturbed.

Des Plaines Police responded to a disturbance at the Rivers Casino located in the 3000 Block of S. Des Plaines River Road where the subject, Jose Villagomez, was threatening an employee inside the property. When the officers arrived, they spoke with the victim who stated that he is a card dealer and Villagomez was at his table. Villagomez was calling him names and then stated that he would wait for the victim outside until he got out of work. The victim believed that Villagomez was going to harm him at that time and alerted security to the incident. The officers approached Villagomez and requested his information, which he refused to do. After multiple refusals, Villagomez was taken

Villagomez was subsequently arrested for one misdemeanor count each of Disorderly Conduct and Obstructing a Peace Officer. Villagomez was cited and released with his court information.

Des Plaines Police responded to a call for service in the 100 Block of S. Des Plaines River Road to check the well-being of a subject wearing a grey hooded sweatshirt in the middle of the roadway. When the officers arrived, they located the subject matching that description and requested his information. The subject provided his information, Erik Bobka, to the officers who then ran him through the database. Des Plaines Dispatch alerted the officers that Bobka has one warrant through the McHenry County Sheriff's Police Department and one warrant through the Cook County Sheriff's Police Department. After confirming the warrants were valid and extraditable, Bobka was taken into custody and transported to the Des Plaines Police station where he was subsequently arrested for the two Warrants. Bobka was later brought to a Cook County Courthouse for a detention hearing.

Des Plaines Police were on patrol on Touhy Avenue when the officer observed a white Dodge Durango traveling westbound. The officer ran the Illinois state registration affixed to the rear of the vehicle and noted that the information was returned on a black Volvo. The officer activated his overhead emergency lights and curbed the vehicle in the 2100 Block of E. Touhy Avenue and approached the driver's side. The officer requested the subject's information at which time he provided a first name of Fiore and a birthday of May 8, 1976. The officer ran it through the database and pulled up the driver's license image for the subject when he discovered that the information the subject had provided was not his. The officer then approached the subject and confronted him with his discovery when the subject then identified himself as John Petrassi and stated he does not have a valid license. Upon running the proper information, the officer was alerted that Petrassi does not have a valid license, said license was suspended by the Illinois Secretary of State. After being asked to step out of the vehicle, Petrassi complied and

also was unable to provide any registration or paperwork for the Dodge Durango he was driving. Petrassi admitted that he did not know the vehicle the license plate belonged to but did know that it did not belong to the Dodge Durango when he purchased the vehicle. Petrassi was taken into custody, transported to the Des Plaines Police station, and subsequently arrested for one misdemeanor count each of Unlawful Possession of Title or Registration Documents and Driving While Driver's License is Suspended; ticketed for the Operation of an Uninsured Motor Vehicle. Petrassi was cited and released with his court information.
