When the officers arrived, they spoke with the victim who stated that she received multiple phone calls and text messages from the above subject, Benjamin Redzic. The victim further stated and was then confirmed after running Redzic's information, that he had a valid order of protection listing the victim as the protected party. Des Plaines Police were on patrol in the 1200 Block of S. Des Plaines River Road when a Mazda CX-5 was seen on the roadway disobeying a red light at the intersection with Des Plaines River Road and Algonquin Road. The officer pulled behind the Mazda and activated his overhead emergency lights, curbing the vehicle. Upon approaching the driver, Julian Wilkinson, he refused to provide his name or information to the officers. While speaking with Wilkinson, the officer observed an open bottle of liquor on the passenger floor area, accessible to Wilkinson. Eventually, Wilkinson's information was obtained and then run through the database alerting officers that he did not have a valid driver's license, said license was revoked by the Illinois Secretary of State. Wilkinson was advised of the violation, requested to step out of the vehicle, and was taken into custody. After being transported to the Des Plaines Police station, Wilkinson was subsequently arrested for one misdemeanor count of Driving on a Revoked Driver's License; ticketed for Disobeying a Red Light, the Operation of an Uninsured Motor Vehicle, and the Illegal Transportation of Alcohol by a Driver. Des Plaines Police responded to Oakton Street and Elmhurst Road for the report of a motor vehicle accident. When officers arrived, they spoke with a witness who stated that he was traveling on Elmhurst Road at Oakton Street when he observed a silver Nissan Maxima lose control of the vehicle, travel over the curb, and struck a light pole before proceeding east on Oakton Street. Responding officers located the Nissan in the 700 Block of W. Oakton Street with the above subject, Jonathan Ascencio Gonzalez, standing outside of the vehicle talking on his cellphone. While speaking with Ascencio Gonzalez the officer observed that his eyes were watery/bloodshot, his speech was slurred, and he was having trouble maintaining his balance. The officer requested that Ascencio Gonzalez perform Standardized Field Sobriety Tests, to which he agreed, and upon completion, showed visible signs of impairment. Ascencio Gonzalez was taken into custody and transported to the Des Plaines Police station where he provided a breath alcohol sample nearly three times the legal limit. Ascencio Gonzalez was subsequently arrested for one misdemeanor count each of Driving Under the Influence of Alcohol, DUI with a BAC Over .08, and No Valid Driver's License; ticketed for Failure to Reduce Speed to Avoid an Accident and Improper Lane Usage. Ascencio Gonzalez was cited and released with his court information.

Des Plaines Police were dispatched to the train station located in the 1500 Block of E. Miner Street for the report that multiple subjects were drinking and fighting near the station. When the officers arrived on scene, approximately five subjects, including the above Christopher Scott and Scottie Altpeter, were seen sitting on a bench with multiple open containers of alcohol and drinking in public. All subjects were detained, and the officers were issuing them city ordinance citations for the incident. The officer spoke with Altpeter who was upset that the officers took the open container from him and refused to provide his information. Eventually, the officer informed Altpeter that failure to provide his information is considered obstructing the officer at which time he provided only his first and last name. Altpeter put his backpack on and attempted to leave the area when he was taken into custody and transported to the Des Plaines Police station. The officer then began to cite Scott for his violation and upon issuing him the





ticket, Scott ripped it up and took a fighting stance towards the officers. The officers believed that Scott was going to escalate and strike them when he was also taken into custody and transported to the Des Plaines Police station. At the station, Scott was subsequently arrested for one misdemeanor count of Aggravated Assault and issued two City Ordinance citations. Altpeter was subsequently arrested for one misdemeanor count of Obstructing a Peace Officer and issued one City Ordinance citation. Both Scott and Altpeter were cited and released with their court information.

Des Plaines Police were on patrol near Oakton Street and Mount Prospect Road when a black Ford Edge was seen traveling east on Oakton Street without headlights on. The officer pulled behind the vehicle and observed it sway within its traffic lane, but never crossed the lane dividers. After activating his overhead emergency, the vehicle made an immediate right/southbound turn onto Wolf Road and came to an initial stop. The Ford then rolled slowly until it ultimately pulled into a driveway in the 1700 Block and stopped. The officer approached the driver's side and spoke with the subject, Laura Jaimes, who had watery/bloodshot eyes and noted an odor of alcohol emitting from her breath. While Jaimes spoke, she had rapid and slurred speech when the officer informed her the reason for the traffic stop. The officer saw an empty bottle of alcohol on the rear seat along with a case of alcohol. Jaimes denied consuming alcohol but was asked by the officer if she would perform Standardized Field Sobriety Tests, to which she agreed. Upon completion, Jaimes showed visible signs of impairment and was taken into custody. Jaimes was transported to the Des Plaines Police station where she refused any further tests or questions asked by the officer. Jaimes was subsequently arrested for one misdemeanor count of Driving Under the Influence of Alcohol; ticketed for Driving Without Headlights when Required and the Illegal Transportation of Alcohol by a Driver. She was cited and released with her court information.

Des Plaines Police responded to the 1500 Block of Rand Road for a hit and run motor vehicle accident. After the officers arrived on scene and during the investigation they obtained security footage of the incident which shows a red Ford Focus attempting to exit the private driveway onto westbound Rand Road traveling in the outside lane. The Ford is then seen making an illegal U-turn from the outside lane and strikes the vehicle traveling the same direction in the inside lane. After the accident, the Ford flees the scene without leaving information. The surveillance footage showed a black female subject wearing glasses, a grey work shirt, using a company vehicle as the driver at the time of the accident. The officer went to the location of the business associated with the Ford in the 500 Block of S. Des Plaines River Road and an employee identified the female as the above. Sonia Smith.

At the Des Plaines Police station, the officer contacted Smith who stated she knew about the accident and would come to the station to speak with the officer. A check of Smith's information revealed that she did not have a valid driver's license, said license was suspended or revoked by the Illinois Secretary of State. At 7:33 p.m., Smith came into the station and was subsequently arrested for one misdemeanor count each of Failure to Remain on Scene of a Vehicle Damage Accident and Driving While Driver's License Suspended or Revoked; ticketed for Failed to Yield Exiting from a Private Drive and Improper Lane Usage. Smith was cited and released with her court information.
