NOTEWORTHY INCIDENTS:

OFFENSE: Burglary To Motor Vehicle

DATE/TIME: 07/21/2024 8:00 p.m. – 07/22/2024 8:30 a.m.

LOCATION: 1500 Block of Maple Street

REPORT #: 24-16966

The victim's Ford E150 work van was parked in the 1500 Block of Maple Street during the above time frame when the Unknown Offender(s) entered the vehicle and stole power tools. Damage to the locking area of the doors was observed by the victim and the officer allowing the offender(s) access to the compartment with the tools.
