Des Plaines Police responded to the 1600 Block of Maple Street for a suspicious incident where the complainant advised a red Jepp Wrangler was parked in the area and the driver had made a threat towards him. The complainant related that driver was a thin Hispanic male with a long black beard. Once on scene, the officer spoke with the complainant and while doing so, they observed the red Jeep Wrangler east on Riverview Drive where the complainant identified that as the vehicle in question. The officer entered his patrol vehicle and followed the Jeep through the neighborhood and then activated his overhead emergency lights in the 1600 Block of Maple Street. Upon approach of the vehicle, the officer spoke with the driver, later identified as the above Jesus Zavala Cuello, and requested his driver's license and proof of insurance. Zavala Cuello stated he does not have his driver's license on his person and provided an expired insurance card. Zavala Cuello stated that his name was "Jesus Savala" and provided a birthdate of December 22, 1992. That information was run through the database and no record was found with that name and birthdate. Zavala Cuello then provided his name but another birthdate which was also not found in the database. Eventually, officers were able to locate Zavala Cuello's information and noted that he did not have a valid driver's license, said license was suspended by the Illinois Secretary of State and that he had a warrant through the Cook County Sheriff's Police Department. Des Plaines Dispatch confirmed with CCSPD that the warrant was valid and active when Zavala Cuello was notified of the violations and asked to step out of the vehicle, to which he complied. Zavala Cuello was taken into custody and transported to the Des Plaines Police station where he was subsequently arrested for one misdemeanor count each of Obstructing Identification and Driving on a Suspended Driver's License; one count of the Issuance of a Warrant; ticketed for Illegal Transportation or Possession of Alcohol by a Driver and the Operation of an Uninsured Motor Vehicle. Zavala Cuello was later brought to a Cook County courthouse for a detention hearing.

Both warrants were confirmed with the corresponding jurisdictions and Zepeda-Chavez was taken into custody. After being transported to the Des Plaines Police station where he was subsequently arrested for two counts of the Issuance of a Warrant.
