Des Plaines Police responded to the 1500 Block of Center Street for the report of a domestic battery. When officers arrived, they spoke with the victim who stated that she is in a relationship with the subject, Edin Mehanovic, and he had grabbed her and pulled her hair. After the incident, Mehanovic fled the area. While speaking with all parties, an unknown vehicle was seen circling the area and honking the horn several times. The officers identified the vehicle as a silver Honda Odyssey and was confirmed to be Mehanovic's car by the witnesses. An officer pulled behind the Honda and activated his overhead emergency lights curbing the vehicle near Center Street and Lincoln Avenue. Upon approach of the vehicle, the officer spoke with the driver, Mehanovic, who was

informed for the reason of the traffic stop. Mehanovic was asked to step out of the vehicle, to which he complied, and was taken into custody. After being transported to the Des Plaines Police station, Mehanovic was subsequently arrested for one misdemeanor count of Domestic Battery and was later brought to a Cook County courthouse for a detention hearing.

Des Plaines Police were on patrol southbound on Mannheim Road towards Touhy Avenue when a vehicle that was traveling northbound had sparks emitting from under its passenger side. The officer conducted a legal U-turn and identified the vehicle as a red Dodge Charger and noted black smoke coming from the rear. While behind the Dodge, the rear passenger tire dislodged from the rim when the officer activated his overhead emergency lights and curbed the vehicle. The officer requested that the driver, later identified as the above subject Romar Harayo, exit the vehicle to speak with him. Harayo complied and while conversing, the officer observed his eyes to be watery and that he was emitting the odor of alcohol from his breath. Harayo stated he was coming from a friend's house and did not admit to consuming alcohol when asked by the officer. Harayo was asked to perform Standardized Field Sobriety Tests, to which he agreed, and upon completion showed visible signs of impairment. Harayo was taken into custody and transported to the Des Plaines Police station where he was asked, and consented, to give a breath alcohol sample, the result of said test was nearly twice the legal limit. Harayo was subsequently arrested for one misdemeanor count each of Driving Under the Influence of Alcohol and DUI with a BAC Over .08; ticketed for Defective Brakes and the Operation of an Uninsured Motor Vehicle. Harayo was cited and released with his court information.

Des Plaines Police responded to a motor vehicle accident that occurred in the 3000 Block of S. Des Plaines River Road. When the officer arrived, he approached the two vehicles involved and spoke with the subject, Lusean Richardson, who denied wanting a police report and instead just wanting to exchange information with the other driver. Richardson was avoiding answering questions about the accident itself and insisted they were fine on their own. The officer then spoke with the other party who stated that they and Richardson were northbound on Des Plaines River Road when Richardson swerved from the inside lane to the outside lane and struck their driver's side. The driver asked a police report to be generated instead of exchanging information. While gathering all driver's information, the officer observed that Richardson's eyes were watery/bloodshot, he was slurring while speaking, and emitted a strong odor of alcohol. The officer suspected Richardson was intoxicated and asked him to perform Standardized Field Sobriety Tests, to which he agreed. Upon completion, Richardson showed visible signs of impairment and was taken into custody. Richardson was transported to the Des Plaines Police station where he refused all further tests and questions asked by the officer. Richardson was subsequently arrested for one misdemeanor count of Driving Under the Influence of Alcohol; ticketed for Expired Registration and Improper Lane Change. Richardson was cited and released with his court information.
