On March 6, 2024, Des Plaines Police responded to the 600 Block of Northwest Highway for the report of a theft. When the officers arrived, they spoke with the victim who owns a business in that area and stated that the subject, Travis Morales, had been let go from the company in February 2024. Since then, Morales had returned to the business, entered a company van in the parking lot and stole several vehicle maintenance items valued at approximately \$3,200.00 USC. The victim further related that he saw posts on Facebook Marketplace by Morales selling the stolen items. The officers attempted to make contact with Morales via telephone but were met with negative results and there was no known address for him at that time. The incident was turned over to the Detective Bureau for follow up.

On May 3, after being unable to locate Morales several times, Detectives obtained an original arrest warrant for him at a Cook County courthouse. On August 13, the Palatine Police Department contacted DPPD advising they had Morales in custody after conducting a traffic stop and learning of his warrant. Des Plaines Dispatch confirmed with PPD that the warrant was valid and active when DPPD traveled to the Palatine Police station and transported Morales back to Des Plaines. Once at the Des Plaines Police station, Morales was subsequently arrested for one misdemeanor count of Theft of Lost or Misplaced Property. Morales was later brought to a Cook County courthouse for a detention hearing.

Des Plaines Police responded to the Rivers Casino located in the 3000 Block of S. Des Plaines River Road for the report of a theft. When officers arrived, they met with casino security who was with the victim and the subject, Silvia Marin. The officer spoke with the victim who stated that she attempted to redeem a voucher in the self-service ATM. After inserting the voucher, no cash was dispensed so the victim walked away to seek an employee for help. During that time the victim was away, the money did dispense, and Marin is seeing approaching the machine and taking it. Video surveillance of the incident was reviewed and confirmed the above series of events. Security located Marin after being notified of the theft and stood by until DPPD arrived. The officer noted that Marin's clothing matched the same clothing worn by the subject on the surveillance video. While speaking with Marin, she initially denied the theft but then later admitted to taking the money. Marin was taken into custody, transported to the Des Plaines Police station, and subsequently arrested for one misdemeanor count of Theft of Lost or Misplaced Property. Marin was cited and released with her court information.
