Des Plaines Police responded to the 1400 Block of E. Touhy Avenue for the report of a suspicious subject where Des Plaines Dispatch related that a Hispanic male subject was in a grey Hyundai sedan with a black handgun in his lap. When the officers arrived in the area, they observed the grey Hyundai and a male subject exiting the driver's seat, later identified as subject #1 Colton Carter. Carter then appeared to be speaking to another male, later identified as Keegan Marshall. Carter walked towards the building while other officers spoke with Marshall who was then seated inside the driver's area of the Hyundai with the door open. The officers observed a fixed-blade knife in the driver's door compartment in plain view when Marshall was told not to reach around the vehicle for any reason. After being told not to, Marshall proceeded to reach into different areas of the vehicle including under the driver's seat where the officer was not able to see his hands. Marshall was asked to exit the vehicle and was taken into custody. An additional officer had approached Carter and inquired about the incident. Carter admitted that he was inside of the vehicle waiting for Marshall and while doing so, looked through Marshall's bag which he discovered contained a handgun. Carter admitted to removing the gun from the bag and placed it down in order to retrieve other items in the bag. Carter was detained and a search of the vehicle was conducted yielding a small bag with a loaded Glock 19 black handgun in it. Both Carter and Marshall were transported to the Des Plaines Police station where they were subsequently arrested for one misdemeanor count each of Unlawful Use of a Weapon. Both were issued a citation and released with their court information.

Des Plaines Police responded to the Rivers Casino located in the 3000 Block of S. Des Plaines River Road for the report of a battery that had occurred on the property. When the officers arrived, they spoke with the victim who stated that he was near a restroom entrance when the subject, later identified as Richard William, exited the restroom and bumped into the victim. After the bump, William turned to the victim and slapped him in the face with his open hand. William was described as a white male with a beard wearing a white shirt and blue pants. After the incident, William left the casino. DPPD was able to locate a phone number for William's and attempted to speak with him on that platform. William refused to speak with the officers and disconnected the phone. After further investigation, the officers learned that William was stay at a hotel in the 2400 Block of Golf Road in Rolling Meadows, IL. When the officers arrived at the hotel, William was seen outside and taken into custody without incident. William was transported to the Des Plaines Police station and subsequently arrested for one misdemeanor count of Battery. William was cited and released with his court information.

Des Plaines Police were in the 1300 Block of Rand Road when a female subject flagged the officer down for assistance. Due to a previous incident, the officer knew the subject to be Samantha Murrin however, when the officer asked for her name, she stated "Isamar". Murrin stated she was contacted by the motel staff about her vehicle, an Audi A6, that had been parked in front of her unit. Murrin provided a paper Illinois driver's license with a photo matching her but with a different name and vehicle registration in the same name. The officer requested that the driver's license information be run through the database and a photo image be viewed. The photo that was attached to the license in the database was not of Murrin, the officer deduced that Murrin was falsely using an alternative identity. While speaking with Murrin, she started sorting through her wallet and the officer noted a bank debit card not in her name. Murrin was taken into custody for the fraudulent identification cards.

Further investigation with the motel confirmed that Murrin had also used the fraudulent ID card to secure a room at the establishment. Murrin was transported to the Des Plaines Police station where the victim was contacted and related that she does not know Murrin, nor did she authorize anyone to make purchases or open bank accounts in her name. The Cook County State's Attorney's Office was contacted and approved felony charges. Murrin was subsequently arrested for seven felony counts of Identity Theft and was later brought to a Cook County courthouse for a detention hearing.

Des Plaines Police responded to a traffic accident in the 600 Block of N. Wolf Road where the victim vehicle stated that his vehicle was parked and unattended in the parking lot facing west when the subject, later identified as Jose Nolasco Diaz, was backing out of a parking space and struck his vehicle. After the accident, the victim and witnesses stated that Nolasco Diaz was attempting to leave the scene but was still there when the officers arrived. The officer spoke with Nolasco Diaz and while speaking, noted he had slurred speech, watery/bloodshot eyes, and swayed while he was standing, and emitted a strong odor of alcohol from his breath. Nolasco Diaz stated that he did not have a driver's license and admitted to consuming alcohol prior to driving. Nolasco Diaz was asked to perform Standardized Field Sobriety Tests, to which he agreed and upon completion, showed visible signs of impairment. A check of Nolasco Diaz' information through the database confirmed with the officer that he did not have a valid driver's license, said license has never been issued by the Illinois Secretary of State. Nolasco Diaz was taken into custody and transported to the Des Plaines Police station. The officer requested Nolasco Diaz provide a breath alcohol sample, yielding a result of more than twice the legal limit. Nolasco Diaz was subsequently arrested for one misdemeanor count each of Driving Under the Influence of Alcohol, DUI with a BAC Over .08, and No Valid Driver's License; ticketed for Improper Backing. Nolasco Diaz was cited and released with his court information.

Des Plaines Police were on patrol near Golf Road and Des Plaines River Road when a loud noise was heard coming from vehicle striking a curb. The officer was traveling east on Golf Road and in the 1600 Block, observed a tan colored Chevrolet SUV stopped in the middle of the roadway. There was a raised median in that area and the Chevrolet was straddling said median with all four tires off the ground. A female, later identified as the subject/Maria Sciortino, exited the driver's seat. The officer approached the female and observed her swaying and struggling to maintain her balance, she also smelled strongly of an alcoholic beverage. When asked about the accident, Sciortino stated that when she turned onto Golf Road from Des Plaines River Road, she went into the oncoming lanes of traffic. Trying to correct her mistake, she attempted to cross the median and got stuck. Sciortino admitted to consuming alcohol prior to driving when asked by the officer and agreed to perform Standardized Field Sobriety Tests. Upon completion, Sciortino showed visible signs of impairment, was taken into custody, and transported to the Des Plaines Police station. Once there, Sciortino was asked to provide a breath alcohol sample, the results of said which was over twice the legal limit. Sciortino was subsequently arrested for one misdemeanor count each of Driving Under the Influence of Alcohol and DUI with a BAC Over .08; ticketed for Not Driving on the Right Side of the Road and Improper Lane Usage – Violated Median. Sciortino was cited and released with her court information.
