### **NOTEWORTHY INCIDENTS:**

Officers responded to the 2100 block of Chestnut regarding a car crash. Upon arrival, they observed that two vehicles, a Volkswagen and a Hyundai, were involved. The officers reported that the driver of the Hyundai, Mattyann Penio, exited the vehicle, appeared unsteady on her feet, and attempted to speak but was incoherent. Penio also tried to retrieve her driver's license but seemed confused.

Suspecting alcohol or drug impairment, the officers requested that she undergo standardized field sobriety tests. Penio complied and agreed to take the Horizontal Gaze Nystagmus, Walk-and-Turn, and One-Leg Stand tests. The officers reported that Penio was unable to pass any of the three tests. She was then placed under arrest and taken into custody without incident.

After taking her into custody, officers searched her vehicle for evidence related to the DUI. They recovered Lorazepam from Penio's purse.

Penio was charged with Driving Under the Influence of Drugs, operating an uninsured motor vehicle, and failure to reduce speed to avoid a crash.

Officers responded to the area of Oakton Street and Ash Street for a traffic crash with possible injuries. Upon arrival, officers observed that Omar Maya, the driver of a Chevrolet Equinox which had backed into another vehicle causing a multivehicle crash on Oakton Street, had trouble maintaining balance and displayed signs of intoxication, such as glassy eyes, slurred speech, and a strong smell of alcohol. Maya admitted to rear-ending another vehicle, causing a three-car collision. After further investigation officer discovered that Maya did not have an Illinois driver's license, and

his driving privileges were suspended and revoked. During a search of his vehicle, opened beer cans were found within his reach. Maya denied drinking on the day of the incident, despite the signs of intoxication. Officers requested that he perform field sobriety testing to which he refused. His vehicle was towed, and he was placed in custody without incident.

Maya was charged with two counts of Aggravated Driving Under the Influence of Alcohol – with a Revoked driver's license, Driving Under the Influence of Alcohol, Driving while revoked, Illegal Transportation of Alcohol, and Failure to Reduce Speed.
